Reboletti: "Good afternoon, Mr. Speaker. How are you, Sir?"

Speaker Lang: "Well, I was fine until you rose for whatever point you're making."

"You have great counsel next to you and so with her Reboletti: representation for you, I have filed several Motions to Discharge the following House Bills: 1489, 3362, 3363, 1511, 107, 2891, and 91 from the House Executive, Revenue, Labor, and Commerce Committees. And under House Rule 58(a), any Member may move that a standing committee or a special discharged from consideration committee be legislative measures assigned to it and not reported back unfavorably. Speaker Lang: "Mr. Reboletti, before we proceed should I presume you're withdrawing your Motions relative to House Bill 1156 and 1527?"

Reboletti: "That... that's correct, Mr. Speaker."

Speaker Lang: "Those Motions are withdrawn."

Reboletti: "Those are withdrawn."

Speaker Lang: "Thank you. On the Gentleman's Motion, the Chair recognizes Mr. Kay."

Kay: "Thank you, Mr. Speaker. If you'll indulge me a moment. A few short weeks ago, Governor Quinn stood at the podium and declared that this year's budget will be the most difficult in memory and I certainly agree with him. Over the next two months, we'll be asked to make some of the most difficult choices we've had to make since arriving in this chamber. Thank you, Mr. Speaker. We will need to cut spending. I and Members on my side of this aisle believe we need to start by cutting our own salaries. I ask you to join me in voting to release House Bill 3363 from the Rules Committee so that we can debate it on the floor. This legislation will reduce General Assembly salaries by 10 percent and prohibit any cost of living adjustment for fiscal year 2014. By the way, many Member ran on this issue in 2012. Not only will this cut... not only will this cut save the state money it will also show... also show families back in our district that in this time of fiscal crisis we will lead by example and that's why they sent us here. In addition, Mr. Speaker, I would remind you that there are additional incentives that we need to move forward to this floor for debate. House Bill 107, establishing a standard making the workplace

primary cause for determining an injury. That's extremely important considering that the high cost of workers' compensation insurance for employers compared to our border states is shifting job growth in Illinois. Furthermore, I'm asking that House Bill 1489 be given your consideration likewise on this floor whereby we wish to implement a 72hour review period of the budget before a vote can be taken which is much needed with respect to the transparency to the appropriations process that we're presently engaged in. After all, our citizens need to be informed and they need to have a clear look. I'm also asking that we discharge 3362. This will take away the extra stipend Representatives and Senators receive for serving as chairmen and Minority spokesman of standing committees. Chairing committees is an aspect of the job we were elected to do and we shouldn't receive extra compensation from doing our job. We already receive generous salaries and quite frankly, being a chairman is an honor. Illinois, Mr. Speaker, financial crisis and as Members of the General Assembly we should be willing to cut our own benefits before we cut elsewhere. We were elected to lead and sometimes that means facing the pain first. This Bill will take effect at the of General Assembly to start the next avoid constitutional issues. I'd also ask, Mr. Speaker, that we consider House Bill 2889, the research and development tax credit. One of the things Illinois has going for us today is just that, the tax credit. It's been in effect for 20 and frankly most businesses would very much appreciate it if it were made permanent so they can plan

And lastly... lastly, I think it's very important that whatever we do though this discharge proceeding today we keep in mind that the only way we are going to work our way out of the problems that we have in this state is to cut spending and grow jobs. And the only way we can do it are by the provisions and Bills that I have suggested today. Thank you, Mr. Speaker."

Speaker Lang: "Representative Wheeler."

Wheeler: "Thank you, Mr. Speaker. Point of personal privilege."

Speaker Lang: "Please proceed."

"House Bill 1511 takes aim at Illinois board and commission salaries by capping them at \$20 thousand and removing the health benefits. We have nearly 340 boards and commissions in Illinois. A vast amount meet less than 100 times a year with full salary and benefits. The number one goal of this Bill is to end the political cronyism involved these commission appointments. Historically, in Governor has appointed the politically connected who are drawn to the large salaries and health benefits. This is not an appropriate motivation for people serving on these commissions. Many of these commissions serve a vital as the Workmen's function to our state such Compensation Review Board. We want to attract members who are motivated to do the work of the people and not the large salaries. With \$9 billion of unpaid bills and \$97 billion in unfunded pension liability, we need to be looking at every way we can to cut back. This Bill could potentially save the taxpayers millions of dollars while attracting the type of people who wish to work hard for the

betterment of the people of Illinois. I would also like to say that within one of our other committees Representative Jack Franks has also passed out of committee the Metra Commission in which that particular commission and salary and benefits were removed. Please discharge House Bill 1511 from Rules to the committee."

Speaker Lang: "Leader Currie."

Currie: "Thank you, Speaker and Members of the House. I certainly agree that the state faces very difficult fiscal problems. Fiscal problems with respect to our pension system. Fiscal problem with respect to a growing backlog of old bills. Fiscal problems with respect to fashioning a budget for the coming fiscal year, but I don't think the way to address these problems is by disregarding and disrespecting the committee system that by in large serves this House well. Just a few days ago, Motions from the same people who are proposing to ignore the committees, Motions were being made to send Bills back to committee, the very committees that they now want to say we should pay no attention to. The committee system is a sound system. We should consider in the Revenue Committee and the Executive Committee the kinds of proposals among those that you have just described that might be able to help us dig ourselves out of the hole. But you don't do it with a Motion to Discharge committee on the floor of the House. You do it by dent of hard work in the very committees you seek to disrespect. I urge a 'no' vote."

Speaker Lang: "Mr. Reboletti to close on your Motion, Sir."

- Reboletti: "I appreciate the Leader's comments about the process because as I watch pensions and guns they're all Floor Amendments and the committee process is disregarded in that respect, but for this we should adhere to the committee process when we can't get these Bills heard. Vote 'aye'."
