Since the 1950s, stillbirths have declined dramatically, largely due to better treatment of certain chronic conditions; however, one in every 160 pregnancies in the U.S. ends in a stillbirth each year. Stillbirths are caused by a number of known causes including birth defects, placental problems, poor fetal growth, infections, chronic health conditions of the mother, and umbilical cord accidents. Risk factors include a maternal mother with the age of over 35, maternal obesity, multiple gestation, and African-American ancestry. A recent study found that African-American women had a two-fold increased risk of stillbirth compared to Caucasian

- women. It is not known why this is the case. Women who experience a stillbirth have the option of receiving a Certificate of Stillbirth from the Department of Public Health. And it appears that the overwhelming majority of women who experience such a tragedy are not interested in certificates or are not aware one is available to them. In the last 10 years, only 75 Certificates of Stillbirth have been requested. This Resolution simply urges awareness. And I ask for its adoption. Thank you."
