I have requested a Roll Call vote. This Resolution, House JR20, is to honor a great Civil War nurse, but it's also to honor the contributions of all military nurses and all nurses in general in the state. Mary Bickerdyke was a Civil War nurse. There's a statue of her in Galesburg recognizing her contributions, what she did. And even after the war, she continued to help veterans that were still recovering. And on that monument to Mother Mary Bickerdyke, General Sherman says she outranks me. And this project's been around for a long time and this will be the final step into putting this to a reality. I ask for your favorable vote."

"Thank you, Mr. Speaker and to the Resolution. This Reboletti: Elgin-O'Hare Expressway has been on the books for IDOT since before I was born. And finally, about 55 years later, we're going to actually take the next phase in not only creating jobs, but changing the gridlock that occurs around O'Hare Airport, around the northwestern suburbs of Cook and DuPage County. And an opportunity, not only for jobs and road construction, but of vertical construction where the communities that I represent along the expansion looking at building convention centers and hotels. And all of the industrial parks, they're looking forward to new businesses and new opportunities. I know, Representative Rita, you share the same desires that all of us do in putting Illinois back to work and at the same time opening up transportation to and from O'Hare Airport. We are the transportation hub of the nation. I think this will help us maintain that. And I would urge your support."

Speaker Turner: "Representative David Harris."

Harris, D.: "Thank you, Mr. Speaker and to the Resolution. The previous speaker was certainly correct in terms of how long

it's taken to get this project underway. The current Elgin-O'Hare Expressway, it's often been said that it goes to neither Elgin nor O'Hare. So, this is a vital project; however, I'd remind the Body that this project is funded by an 87 percent increase in the Toll Highway Authority tolls. I feel that that... those... that toll increase was excessive and quite frankly, unneeded. This is one of the projects; however, that has been on the books. If they're going to use the money that the toll increase generates, then this is a proper way to use the dollars. And likewise, I stand in support of the Gentleman's Resolution."

Speaker Turner: "Representative Durkin."

Durkin: "Will the Sponsor yield?"

Speaker Turner: "The Sponsor will yield."

Durkin: "Representative, why are we doing this in the Legislature? Can't the Tollway do this through their own Resolution?"

Rita: "The way the statutes are set that the General Assembly must give the okay or the Authority the... to go forward with it...

Durkin: "Okav."

Rita: "...when they set up the initial..."

Durkin: "What is the cost for this..."

Rita: "...when they set the tollway system...

Durkin: "Okav."

Rita: "...up."

Durkin: "What is the projected cost for this expansion?"

Rita: "It's a \$3.4 billion construction project. And it's going to be expanded over... from 12 to 15 years."

- Durkin: "Okay. How... I mean, is this going to be paid through tolls or how is this going to be funded?"
- Rita: "From my understanding, about 90 percent of this... the funding has already been identified. There's a portion that some locals are going to be putting in and with the tolls is the primary."
- Durkin: "Okay. Has the tollway projected to you when this project will be finished? I mean, it's been in the pipeline for decades as my friend behind me has stated. And I live in the west suburbs. We've been hearing about it for a long time."
- Rita: "They're claiming from 12 to 15 years to be completed, but they're anxious to get this project started. This is one of the final steps into actually going out to bid and putting people to work and starting this."
- Durkin: "Well, this is a great... I'm glad we're doing this. This is a long time coming and this is going to be just a wonderful, amazing, you know, economic tool for the Chicago and DuPage County. So, I support your Resolution."
- Speaker Turner: "Representative Rita to close."
- Rita: "I've asked for a favorable vote on this. This is a... a agreed Resolution from my understanding, that everybody, the locals... it's about putting people back to work. It's about putting a construction... \$3.4 billion construction project that will last over approximately 12 years. I've asked for a favorable vote."

- Rosenthal: "Thank you, Mr. Speaker. House Resolution 106 simply urges the Department of Employment Security and the Department of Veterans' Affairs to create a veterans' job Internet website. I encourage an 'aye' vote. Thank you."
- Speaker Turner: "The Gentleman moves for the adoption of House Resolution 106. All those in favor say 'aye'; all opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Resolution is adopted. Representative Davis, for what reason do you seek recognition?"
- Davis, M.: "Mr. Speaker, I rise for a point of personal privilege."

Speaker Turner: "Please state your point, Ma'am."

Davis, M.: "A few minutes ago I offered a congratulatory Resolution to the Morgan Park High School basketball team who won the state championship, but I failed to mention the adults who are responsible for leading them successfully, academically and athletically. First, I'd like to mention Dr. Carolyn Epps, the principal who went to Roosevelt University with me, but she graduated and I was a drop out, working on her doctorate. So, I want to congratulate Carolyn Epps, the new principal at Morgan Park. We have Remy Washington, the assistant principal, Adrian Burrage, the athletic director and a math teacher of advanced math and trigonometry, Wesley Yates, the athletic director, Nick Irvin, the head basketball coach, Mr. Terry Johnson, the assistant basketball coach. It is because of these adults, they're mentoring. All of these students are above a 2.5 and their grade point averages go as high as a 4.0 or above. God bless you all again, the leaders who are leading

Speaker Turner: "Thank you, Representative. House Resolution 80, Representative Acevedo. Out of the record. House Resolution 133, Representative Dunkin. Mr. Clerk, please read the Resolution."

Clerk Bolin: "House Resolution 133. Floor Amendment #1, offered by Representative Dunkin, has been approved for consideration."

Speaker Turner: "Representative Dunkin."

"Thank you, Mr. Speaker and Members of the House here. Dunkin: House Resolution 133 simply declares its support for Choose Chicago and us connecting with the city and making sure that we encourage stakeholders in the tourism industry here to recognize the offerings all across our state and to celebrate it and to do what's right and to coordinate our Met Pier or Metropolitan Pier and Exposition Authority to act as the official sales and marketing agency for McCormick Place in Chicago. And it's governed by a board of directors and employs a staff of more than 90 industry professionals. Funding is received from both the private sector and public sources. So Choose Chicago has a relatively small budget of \$27.6 million and we simply want to encourage its... urge its stakeholders to help recognize the offerings in making it affordable, frequent and convenient train travel throughout the Midwest, so we can capture those people from St. Louis, we can capture those

people from Milwaukee, capture those people from Iowa, capture those people from Indiana, anywhere in the world. We want them to come to the State of Illinois and celebrate tourism here in our state. Thank you."

Durkin: "Will the Sponsor yield?"

Durkin: "I think it's really super what you're doing there, Representative Dunkin. That's super with a capital S, but you talked about anywhere in the world. I've got... you're on Second Reading. It's not... we're not too far down the road. We can still amend the Bill. Make it a better Bill."

Durkin: "All right. I'm going to stop while I'm ahead."

Bellock: "Thank you very much, Mr. Speaker. I, too, would like to, not on that issue, but commend Representative Dunkin for all the work that he's done for tourism in the movies in Spring... in Illinois. Some of those issues have been very controversial and recently in the papers they've talked about how it's helped the income in the State of Illinois. So thank you for all your work, Representative Durkin. We appreciate it."

Speaker Turner: "The Representative moves for the adoption of Floor Amendment #1 to House Resolution 133. Seeing no objection, the Amendment is adopted. Representative Dunkin."

It's when the policemen in their district are free and they go by a school we just ask them to stop, walk through and they'd be seen in their presence. It may stop a lot of problems. And the Resolution is adopted. House Resolution 162, Representative DeLuca. Mr. Clerk, please read the Resolution."

Clerk Bolin: "House Resolution 162 encourages all school districts in the state to establish educational programs to inform parents about the dangers of serving alcohol to minors."

Speaker Turner: "Representative DeLuca."

DeLuca: "Thank you, Mr. Speaker. Ladies and Gentlemen, House Resolution 162. Alcohol is the most commonly used and abused drug among youth in the United States and alcohol use by persons under the age of 21 is a major public health problem. Underage alcohol abuse is associated with school problems such as higher absence and poor or failing grades. The Illinois House of Representatives is committed to the education and protection of the children of Illinois. We encourage all school districts in the state to establish educational programs to inform parents about the dangers of serving alcohol to minors and the prohibition on serving alcohol to minors and a punishment for a violation of the prohibition. I ask for the adoption of the Resolution."

Speaker Turner: "The Gentleman moves for the adoption of House Resolution 162. All in favor say 'aye'; all opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Resolution is adopted. House Resolution 163, Representative Mitchell. Mr. Clerk, please read the Resolution."

Clerk Bolin: "House Resolution 163 urges the boards of directors and shareholders of Illinois corporations to

properly reflect the ethnic, racial and gender diversity of the state in their membership of their corporate boards." Speaker Turner: "Representative Mitchell."

Mitchell, C.: "Thank you, Mr. Speaker. This Resolution's in response to a great report done by the Chicago Urban League as well as research done by Chicago United. Of the 50 largest companies in Chicago, 567 individual members of their boards of which only 12 percent are racial minorities. What this Resolution is saying is that we, as a state, have tremendous purchasing power not only through what we do in terms of contracting and vendors, but also in terms of bond deals, professional services, underwriters, engineers, other service firm opportunities and that we should be working to promote those companies which understand the competitive advantage of diversity, understand how it opens new markets, understand how it creates a new and more competitive workforce and that that's a benefit to the private sector as well as to us. This Bill does not have opposition which I think is a recognition of the business community, how important diversity is. This is an opportunity to make sure that we begin to promote those companies that reflect those values that I know we all share. I urge the adoption of this Resolution."

Speaker Turner: "Representative Monique Davis."

Davis, M.: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "The Sponsor yields."

Davis, M.: "Could you tell us a little more about the diversity of your board?"

- Mitchell, C.: "I'm sorry. I'm not sure I understand the question."
- Davis, M.: "Well, you say you're going to have a board that makes sure that the corporations do exactly what?"
- Mitchell, C.: "No, Representative. What I'm saying is, once again, this is not a mandate in any way. What it's saying is year over year that we would like our corporate partners whether that's on bond deals whether that's construction, vendors, whatever it is, to report to the state how they're doing with diversity on their board of directors. And we're encouraging our agencies such as the Illinois finance authority, CMS, DCEO, the Comptroller, the Treasurer, the Governor's Office of OMB and folks doing our bond deals to seek to do business with partners whose boards are reflective of the diversity of our state. This is a Resolution. It's not an enforcement mechanism per se. It's encouraging businesses to do this and if we see we have trouble down the road, we can come back and look at doing something that has more teeth."
- Davis, M.: "So you feel that if the board has diversity, they will really understand the economic impact that fair economic distribution of jobs and bonds and contracts have upon any corporation or our state."
- Mitchell, C.: "Absolutely and I think it will also help them realize kind of the leadership opportunities and examples that it creates in African American and other minority communities as well as opportunities for women who are a bigger part of our society and a bigger part of the folks

- getting MBAs and going into C-suite level jobs. So, absolutely, I'd agree with that."
- Davis, M.: "So you're not naming just one or two ethnic groups.

 You're saying just be diverse. Is that correct?"
- Mitchell, C.: "I'm saying that we ought to... that these corporations, their boards ought to reflect the ethnic, racial and gender diversity of this State of Illinois. Yes, Ma'am."
- Davis, M.: "I commend you on such a fair Resolution. I'd like to be joined as one of the cosponsors. Thank you."
- Mitchell, C.: "Thank you."
- Speaker Turner: "Representative Mitchell to close."
- Mitchell, C.: "Thank you. I thank you for the question from Representative Davis and I would urge an 'aye' vote on this Resolution. I think it'll make us a fair and more competitive state."
- Speaker Turner: "The Gentleman moves for the adoption of House Resolution 163. All those in favor say 'aye'; all opposed say 'nay'. In the opinion of the Chair, the 'ayes have it. And the Resolution is adopted. House Resolution 165, Representative Berrios. Mr. Clerk, please the Resolution."
- Clerk Bolin: "House Resolution 165 urges the Consumer Financial Protection Bureau to adopt regulations to implement Section 1071 of the Dodd-Frank Wall Street Reform and Consumer Protection Act as expeditiously as possible."
- Speaker Turner: "Representative Berrios."
- Berrios: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. The Section 1071 of the Dodd-Frank Act was enacted into Federal Law on July 21, 2010 and requires financial

institutions to report information regarding credit applications from women-owned, minority-owned and small businesses. However, obligations do not arise under Section 1071 until the CFPB adopts regulations and then they take effect. This Resolution states that the State of Illinois recognizes the importance of data collection and reporting under Section 1071 of the Act in improving fair lending oversight and in understanding of the extent to which the credit needs of women-owned businesses, minority-owned businesses and small businesses are being met by our financial institutions. I'd also like to mention that the Illinois Bankers, the Illinois Credit Union League and the Illinois Housing Development Authority are all in support of this Resolution. Thank you."

Speaker Turner: "The Lady moves for the adoption of House Resolution 165. All in favor say 'aye'; all opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. And House Resolution 165 is adopted. Representative Brady."

Brady: "Thank you, Mr. Speaker. A point of personal privilege."

Speaker Turner: "Please state your point."

Brady: "Ladies and Gentlemen, please welcome to the Illinois
