So, I would jo... ask all of my colleagues to join me this... this Saturday, tomorrow in fact, for a parade in downtown Chicago honoring Polish Constitution Day. Thank you, Mr. Speaker."

Federal regulations require each state to establish a State Rehabilitation Council that members are appointed by the Governor unless the Governor delegates that power by Executive Order. This is an initiative of DHS and it states that the current version of Civil Administrative Code of Illinois does not accurately reflect the gubernatorial appointments of members, specifically, the representatives from the Statewide Independent Living Council and the

Mayfield: "Okay. Thank you."

Speaker Turner: "Representative Hammond... excuse me. Representative Chapa LaVia."

Chapa LaVia: "Thank you, Speaker. Would the Sponsor yield?"

Speaker Turner: "She indicates that she will."

Chapa LaVia: "Representative, is this going to cost us more money?"

Hammond: "Well, certainly, the expansion is costing us more money; however, Representative, we have no alternative at this point. We have about 500 persons that are awaiting placement in the facility."

Chapa LaVia: "Do you know exactly how much more this is going to cost? Just out of curiosity, you have a guesstimate?"

Hammond: "And I apologize, Representative. I do not know. I do
 not have that figure. I have heard it, but I could not quote
 it to you. I apologize."

Chapa LaVia: "Okay. And Representative Sullivan, when he gave you the Senate Bill he didn't give you any notes on calculations or anything?"

Hammond: "Actually, we have had phone conversations regarding the project and I do not recall that figure, I apologize."

Chapa LaVia: "Okay. Thank you very much."

Speaker Turner: "Representative Hammond to close."

Hammond: "I appreciate an 'aye' vote. Thank you."

Speaker Turner: "Welcome to your Capitol, ladies. Senate Bill 922, Representative Beiser. Mr. Clerk, please read the Bill."

Clerk Bolin: "Senate Bill 1169, a Bill for an Act concerning civil law. Third Reading of this Senate Bill."

Senate Bill 1169 removes language providing that an income withholding notice shall include the date that withholding for current support terminates which shall be the date of termination of the current support obligations set forth in the order of support. It brings Illinois law in line with federal requirements. There's no opposition. I urge an 'aye' vote. Thank you."

Clerk Bolin: "Senate Bill 1170, a Bill for an Act concerning wildlife. Third Reading of this Senate Bill."

Speaker Turner: "Representative Acevedo."

Acevedo: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Senate Bill 1170 is a Department of Natural Resources initiative. This Bill would allow violators to be charged in

Illinois for the possession of wildlife taken unlawfully in any state or country and transported to the State of Illinois. The statute of limitations for unlawful possession of wildlife or wildlife part ends two years after the possession ends. I'd be happy to answer any questions."

Speaker Turner: "On that, the Chair recognizes Representative Bost."

Bost: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "The Sponsor will yield."

Bost: "Representative, it says it creates a prohibition on the possession of wildlife or parts of wildlife. Is that correct?" Acevedo: "Yes."

Bost: "But... illegally taken. Now, are we talking that hunting out of season? What are we... what's the genesis?"

Acevedo: "Representative, just so you know, this is... we passed a version earlier, a House Bill and it's over at the Senate. Now, this is just the Senate version. Basically, what it does is, when you go into a different state and you hunt there illegally and try to bring it into Illinois, what we're trying to do is save money because Illinois is responsible for doing an investigation."

Bost: "Okay. So, this is when you're transporting. Let's say you kill a deer in Missouri and then you're bringing it through the State of Illinois or some other animal you've killed in a neighboring state and you're traveling through. This makes a violation of that. I'm trying to..."

Acevedo: "Not traveling through. Say, you're an Illinois resident and you go to another state and hunt there illegally and you try transporting it back."

Speaker Turner: "Please state your point, Sir."

Moffitt: "I wondered if we could have the Body's attention. I want to pay tribute to a firefighter."

Speaker Turner: "Members, can we please have your attention. We'd like to pay tribute. Representative Moffitt."

Moffitt: "I mentioned earlier that next week we'll have the ceremony honoring fallen firefighters, but some of you may have heard on the news of a tragedy that occurred here in Springfield yesterday. It wasn't in line of duty, but it was a firefighter. It was a Chicago firefighter who has relatives in Springfield and was killed in an accident out near Clear Lake and I-55 yesterday. He was on a motorcycle and it involved some semitrucks. It was Sean Sloe, 37, was pronounced dead at 11:45 a.m. by Sangamon's County Coroner. Mike and his brother, his brother's a Springfield firefighter, and Mike and his brother had been involved in EMS and the fire service for many years and the local president of the firefighters here said Mike and his brother had one objective and that was helping others. So, they made a career of it. And you know, when we lose one firefighter, we've all lost because they serve all of us. Speaker Turner: "Continuing on the Order of Senate Bills-Third Reading, on page 4 of the Calendar we have Senate Bill 1213, Representative Mayfield. Mr. Clerk, please read the Bill."

Clerk Bolin: "Senate Bill 1213, a Bill for an Act concerning the Department of Juvenile Justice. Third Reading of this Senate Bill."

Speaker Turner: "Representative Mayfield."

Mayfield: "Basically, this Bill is just cleanup language from...

years ago when it took over certain areas from the Department

of Corrections or just providing the same identification as

we... as they currently had under the Department of Corrections

is now going to... needs to be there for the Department of

Juvenile Justice. Let's see, there's no... there's no fiscal

technical cleanup only. I'm open to any questions."

Speaker Turner: "Seeing no debate, the question is, 'Shall Senate Bill 1213 pass?' All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On a count of 112 voting 'yes', 0 voting 'no', 0 voting 'present', Senate Bill 1213, having received the Constitutional Majority, is hereby declared passed. Senate Bill 1214, Representative Lang. Mr. Clerk, please read the Bill."

Clerk Bolin: "Senate Bill 1214, a Bill for an Act concerning transportation. Third Reading of this Senate Bill."

Speaker Turner: "Leader Lang."

Lang: "Thank you, Mr. Speaker. This is a Bill comes up... comes to us from the Illinois Tollway Authority. It would allow them to list on their website a database of all individuals or entities that owe a thousand dollars or more in unpaid fines or tolls. Today, over \$300 million in unpaid tolls and fines are owed to the Illinois Tollway Authority and they're forced to ask the Secretary of State to suspend about 5 thousand license plates a year due to unpaid tolls. This is just another tool for them to get people to pay. This would not be listed unless all of the procedures that they're required to follow under the law and the regulations have been followed including nine different letters and notices that would go to folks. I would ask your support."

Speaker Turner: "Representative Bost."

Bost: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "He indicates that he will."

Bost: "Representative, if you could... Leader, if you could, where... it is the intent that... So, you have someone who has multiple violations. It's going to step up the penalty. Is that correct?"

Lang: "No. It's simply going to be a listing on their database, on their website of toll violators who owe more than a thousand dollars. To get to a thousand dollars, you had to go through a lot of tollbooths. And so, here's three examples. I won't give you the names of the companies, but there's one company in Sandwich, Illinois that owes the Tollway Authority \$60 thousand, another one that owes \$19 thousand and another one in Streamwood that owes the state \$152 thousand. That's a heck of a lot of travel up and down the tollway system

through that I-PASS and without paying. So, they have the opportunity to have dri... have license plates suspended and remove registrations through the Secretary of State's Office, but this is about collecting the money. And this..."

Bost: "Have they... and I'm sorry to interrupt, but..."

Lang: "That's all right."

Bost: "So... so, are they... they do suspend their license or take away... obviously, if these are commercial vehicles, correct there?"

Lang: "Well, some are, but some aren't. So, in these three cases they were either commercial vehicles or at least registered to businesses..."

Bost: "Okay."

Lang: "...but there are individuals as well who have accumulated huge debts to the tollway system and this is just an additional tool to embarrass people..."

Bost: "Okay."

Lang: "...so maybe they'll pay what they owe."

Bost: "It... it's kind of like a tollway scarlet letter."

Lang: "I quess. Yes."

Bost: "Okay. I just need to find that out."

Lang: "Yeah."

Bost: "Thank you."

Speaker Turner: "Representative Fortner."

Fortner: "Thank you, Speaker. Will the Sponsor yield?"

Speaker Turner: "The Sponsor yields."

Fortner: "I know we had a vigorous debate in committee on your Bill and I just wanted to go back to some of the questions there for the benefit of the Body. When we talked about the

thousand dollar limit, it's not just based on tolls. It includes other fines and penalties that could be assessed. Isn't that correct?"

Lang: "It is, but the fines are about 20 or 50 dollars per violation, so it still would take someone a long time and a lot of violations to accumulate a thousand dollars."

Fortner: "Right. But some of those... some of the penalties, I thought, were also cumulative. That is, if there was enough time had gone by and failure to pay, they could accumulate additional fines on... on their previous failure to pay of the earlier fine. That they weren't just onetime only fines, but some of them could accumulate."

Lang: "Yes, yes, but those fines total about \$70 on... that has penalties on top of the fine, so it's still quite a few trips through that I-PASS not paying. So, perhaps it isn't a thousand, but perhaps it's two or three hundred to get to a thousand dollars."

Fortner: "Well, I would think if you could get up to 70 and throw in another \$25, you're... we're only talking about 10 to 15 trips that would bring you to a thousand."

Lang: "Would you... would you agree with me, Sir, that people ought to pay the tollway what they owe them?"

Fortner: "Absolutely..."

Lang: "All right."

Fortner: "...but I can also say that in my district office we've had a number of calls over the years where there's been difficulty identifying who the actual violator was and someone who was going through and not paying the fines. And I would not want to see the wrong people being posted on the

Web until we have exhausted not just the tollway's remedies, which I understand by this Bill they would have to do, but also they would have to... I would prefer personally, if you're going to do that, that there's at least some judicial step in there and I did not see that; and I know that was also discussed earlier."

Lang: "Sir, the tollway enforcement time line required nine separate notices to the person who's been accused of owing the money or the business that's been accused of owing the money before anything could be posted, nine separate notices."

Fortner: "Speaker, to the Bill. I understand that they have this posting of notices, but I also know of specific cases where people have responded to those notices saying I'm not the person who was violating. As it works its way through the administrative process, it would not be hard to imagine that they exhaust those nine letters. They are still contesting it, but at that point they could go ahead, by this law, and post their names. I don't think this provides sufficient security that we're really going after just the violators and not just trying to cast a wide net to make sure that we are able to get those collections. I would urge a 'no' vote."

Speaker Turner: "Representative Sandack."

Sandack: "...Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "The Sponsor will yield."

Sandack: "Leader... Good morning. ...we had a discussion at the committee. Can you just explain, as set out in the Bill, what are the administrative steps, the requirements, whether it's

internal or external or both, before the tollway lists these scofflaws on the website?"

Lang: "So, most of you were sent this document, but you could pull it up on the Illinois Tollway website and it goes on for a long time, but let me give you the highlights."

Sandack: "Thank you."

Lang: "First, if... if you've gone through the I-PASS and not paid, no one does anything for the first seven days. On the eighth day, it becomes a violation. The first notice is not sent to the person who has gone through that I-PASS lane until at least three violations have occurred over a two-year period. Then they... the recipient of that notice has 21 days to pay or contest the violation. They have an option to request a hearing at that time. They have an opportunity to contact the tollway and say, hey, it's not me. Then there's a second notice. They have 14 days to pay, but can still... while they can't request a hearing anymore, they can certainly contest it or ask for an administrative opportunity. Then there's a third notice with an additional 21 days to pay. The notice warns the driver or the owner of possible penalties. Driver's license and driver's plate registration suspension and possible referral to a collection agency. The notice also advises the violator of the right to dispute the suspension in writing. After all of that happens, then it might be referred to collection. Then there's a first collection notice. It warns of the penalties, it warns of credit bureau reporting, it warns of possible litigation and garnishment. It gives them an option for a payment plan. They can pay a settlement or ask for a hearing. Then there... and

let me... let me just say, there's second, third, fourth, fifth and sixth notice before any of this is posted online."

Sandack: "Thank you, Leader. And that certainly demonstrates a desire by the Tollway Authority to be paid before the listings occur on the website of shame we'll call it. Is there a requirement that the tollway authority, before listing and trying to embarrass people, actually sue these deadbeats?"

Lang: "Well, there's no requirement that they sue."

Sandack: "Okay. And apart from this instance, are there other instances in Illinois where we put up people's names and try and shame them into paying obligations owed to the state or the Tollway Authority in this instance?"

Lang: "Well, I think there are, but I don't have them in front of me. And so, I'm sorry about that, but I believe there are other places in State Law where people owe fees, people owe penalties to the state, maybe somewhere in the area of child support. I'm not sure where these can be listed online."

Sandack: "Thank you, Mr. Speaker... Mr. Leader. I appreciate it." Lang: "Thank you."

Sandack: "To the Bill, Mr. Speaker. I have no doubt that this is well-intended. I think we're going down a bad path, though, shaming people. I'd rather have the law say by a certain date and after certain notices the Tollway Authority will go to collection, will hire an outside attorney and will seek to get the money that's owed. But this shaming concept, I think, is a dangerous precedence... precedent. And I would urge a 'no' vote."

Speaker Turner: "Representative Reboletti."

Reboletti: "Will the Leader yield?"

Speaker Turner: "He indicates that he will."

Reboletti: "Representative, is this a... an initiative of the Illinois Toll Highway Authority?"

Lang: "Yes, Sir."

Reboletti: "My understanding, Representative, it's not their initiative. In... in our analysis..."

Lang: "I... excuse me. Let me restate that. They are neutral on the Bill. It is not their initiative. I apologize."

Reboletti: "Is this your initiative? Is this like a constituent initiative? What's the genesis of this?"

Lang: "This... this came to us from my Senator, Senator Silverstein and frankly, I didn't ask him where it came from. It just sounded like a good idea to me, Sir."

Reboletti: "If... you said that they exhaust every administrative remedy. Is that... is that correct?"

Lang: "That is absolutely true."

Reboletti: "What if the tollway did sue one of these individuals and it was pending in court. Would that still qualify as having exhausted all administrative remedies now that they're in the, we'll say, DuPage County Circuit Courthouse?"

Lang: "I don't have a real good answer to your question; however, one would think that if they've... if... one would think that they would have not... Well, I just don't have an answer to your question. Let me leave it at that."

Reboletti: "You know, they taught us in law..."

Lang: "Let me not make one up. I just don't have an answer."

Reboletti: "They taught us in law school to stop asking questions at that point, I think, when we've got you here now,

Representative. But wouldn't the Bill be better if it said you've exhausted all legal remedies first?"

Lang: "Well, I don't think so because I don't think we want the tollway to have to sue every toll violator. After all, these are folks that have the transponder in their vehicle and they have driven, God knows how many times, through the I-PASS without paying."

Reboletti: "How quickly would it take to get to a thousand dollars for simple toll violations?"

Lang: "It would take quite a while because the penalties are only...

they can only... I think the first violation is a \$20 penalty
and the second violation is a \$50 penalty and that's..."

Reboletti: "But aren't there..."

Lang: "...as far as it goes."

Reboletti: "...aren't there late fees attached to those as well?"

Lang: "I..."

Reboletti: "So, if you miss that \$20, doesn't it go up to like 75, 'cause it goes to adjudication, the person fails to appear. There's like a hearing fee, a late fee."

Lang: "Well, I don't have the whole list of how those fees accumulate, but let's assume you're correct for the sake of argument. It's still a thousand dollars owed to the State of Illinois and... and it... it's going to have to be at least several violations. The... but they don't even pursue someone until it's three violations over two years. And so, these are scofflaws. In many cases, it may start out to be minimal, but they're going to get nine notices and God knows how many phone calls from the collection agency that the Tollway Authority is empowered to hire before any of this happens."

- Reboletti: "Leader, what if an individual has entered into a payment agreement with the Toll Highway Authority or the creditor or the lawsuit and they have a \$3 thousand balance, but they can't pay it at once? Is that considered being a scofflaw under this legislation?"
- Lang: "No. If they have an agreement with the Tollway Authority, they have an agreement with the Tollway Authority and they're not considered in violation and not considered someone who would have their name posted."
- Reboletti: "Representative, where is that in the Bill?"
- Lang: "The Bill requires them to follow all of their administrative procedures and all of their administrative procedures include settlement. And if there's a settlement or a resolution, then there's a settlement and a resolution."
- Reboletti: "What about in the case, Representative, where I've had constituents call where either there's a divorce or a break up in a relationship, the person takes the vehicle, they drive up and down, they eventually don't have any notice, it's not really their fault, the other party's fault. Do we want to make those persons scofflaws as well? Because I've had to help some of those individuals deal with the tollway because, really, it's not their violation. The person took the car and they're driving up and down without paying tolls."
- Lang: "Well, Sir, I suppose there are some people who can fall through the cracks, but the fact is that they're going to get many, many phone calls. They're going to get nine notices sent to them before anything happens under the administrative rules that the Tollway Authority has created. You would suggest to me, I suppose, that perhaps the party who would

get all of these and maybe not... may be the party regis... that may be the registered owner of the vehicle, but not the person who's responsible. But the lion's share of these are large businesses that owe together over \$300 million to the State of Illinois."

Reboletti: "Thank you."

Speaker Turner: "Representative Sullivan. Leader Lang to close."

Lang: "I appreciate the debate and I understand that we don't want to embarrass people or make any mistakes, but the fact is that the Tollway Authority has a lot of money due and owing to it. This is just one additional tool. The Tollway Authority has many tools, but the thought is if they would post these names then people would want to pay up pretty darn quick to get their name off the Internet. I would suggest your 'aye' votes."

Clerk Bolin: "Senate Bill 1287, a Bill for an Act concerning civil law. Third Reading of this Senate Bill."

Adds a person convicted of a felony involving harm or threat to a minor including a felony sexual offense. Simply put, it adds three words to existing law or to... or a minor. I urge a 'yes' vote."

Speaker Turner: "Representative Durkin."

Durkin: "Will the Sponsor yield?"

Speaker Turner: "The Spon..."

Durkin: "Representative, could you explain to me a little bit about the Probate Act of 1975 and why we need to change it at this point and what are the problems with it?"

Wheeler: "Thank you for asking that excellent question.

Representative Durkin, this protects the most vulnerable of all of our population, our elderly, our disabled people and our children."

Durkin: "Well, that's a real super response, but how about answering the question."

Wheeler: "If you didn't interrupt me, I would've been glad to finish. When... when the county provides a guardian to our most vulnerable, their orders of protection allow the judge to confirm that these people are no... are not felons. That's good enough, right, Jim?"

Durkin: "Well, in the interest of time on Friday afternoon... Friday morning, I will let you go, but I'll still reserve judgment on this. But maybe you could be more responsive to the questions when they're asked of you. I know you're a freshman, but that's what we do down here. We ask a question, we ask

for a clear response and you know, I hope you that you can learn from this moment, but..."

Wheeler: "I do. Thank you."

Durkin: "...I will reserve judgment. Thank you."

Speaker Turner: "Representative Sandack."

Sandack: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "She indicates that she will."

Sandack: "Can you describe with specificity exactly what it is when someone's convicted of harming or threatening a minor?"

- Wheeler: "Excellent question. Thank you for asking. It would be either a sexual... I did ask that same question to the Cook County lawyer that came from the Public Guardians. They said sexual harm or physical harm or it could be stealing from the minor as well."
- Sandack: "What about emotional harm? What about something psychologically damaging to a minor? Do we want them as a guardian ad litem?"
- Wheeler: "Well, you're the lawyer. Is... is there an emotional... is there a felony for emotional harm?"
- Sandack: "I don't know, but should you consider that with respect to this Bill?"
- Wheeler: "The Bill actually is for... it considers it if a person is an ex-felon. So, like I said, depending on if there is a crime that would be considered a felony for emotional harm. I don't know that."
- Sandack: "To the Bill. I'm also going to reserve judgment. There were some iffy responses to some really particular questions. So, I'll listen if anyone else has questions. Thank you, Mr. Speaker."

Speaker Turner: "The Gentleman from DuPage, Representative Reboletti."

Reboletti: "Thank you, Speaker. Will the Sponsor yield?"

Speaker Turner: "The Sponsor will yield."

Reboletti: "We even have the bat phone that's ringing over here.

Representative, what if a person is a guardian and this Bill passes. Would they then lose that guardianship? Would there be some kind of action from the court or another guardian to come in?"

Wheeler: "Interestingly enough, Representative, although there have been ex-felons that have committed harm to minors there have been hearings which have been laborious and expensive and time consuming. They have yet to have ever appointed an ex-felon who was convicted of harm to a child. So..."

Reboletti: "Thank you."

Wheeler: "...the question is moot. Thank you."

Reboletti: "Mr. Speaker, I would request a verification of this vote if it were to get Constitutional Majority."

Speaker Turner: "The Gentleman has requested a verification on a vote. All Members are asked to vote their switches.

Representative Feigenholtz."
