I am concerned that we give government these types of powers without procedural safeguards to the businesses."

Franks: "I don't think that they should be in a better position than anybody else. I think that they should get theirs like everybody does. And I... to the Bill. And I appreciate what the Gentleman's trying to do, but the fact is government is not something that should be above its citizens. Government should be at the same level of its citizens. So, if its citizens are owed money, they should be able to follow the laws and there's a... going on for hundreds of years of American jurisprudence going back to English case law that it's first in time, first in right.
