Gordon-Booth: "Thank you, Mr. Speaker. Senate Bill 70 allows a video gaming applicant to be located within 100 feet of a school or place of worship. If the school or place of worship move within 100 feet of the location, after the applicant originally applied for its liquor license. This initiative is of the AMVETS Post 64 of the greater Peoria area. Post 64 first obtained its liquor license in 1960 and the Riverside Community Church moved in next door in 2000. The Riverside Community Church is not in opposition to this Bill. This Post 64, which is located in Peoria, Illinois, is not allowed to exempt from this piece... exempt from the legislation, excuse me, exempt from the statute, will end up closing its doors in less than a year. This is not the only AMVETS. When I picked this Bill up, there are many other facilities around the state that are having to deal with this issue. I ask for your 'aye' vote and I'm open for any questions at this moment."
