Durkin: "Thank you, Mr. Speaker. A brief point of personal privilege."

we have Bills that we are working on, which we've introduced, which go to treatment, it goes to education, and it goes to the source of the funds. I'm pleased to say that Dennis Reboletti did an amazing job working with our staff, Ben Rodell, and also the other colleagues of mine from DuPage County to address this issue. I know we have rules in place on how we're going to proceed in the Judiciary Committee, things that move a little bit slower. I would just ask that this is such a... an issue of such importance to Illinoisans and to families. These families are ... are losing children. And the problem with heroin is that it's easy, it's accessible, it's accessible, it's got a 100 percent addiction rate. But the fact is, if you're lucky to wake up after an overdose, you're in the minority. So I'm asking that we immediately review these Bills, bring this is... in some type of bipartisan discussion with both House Democrats and House Republicans to advance the issues that we're talking about. My point is, is that the chairman of the Judiciary Committee, Representative Nekritz, I hope that you will take this consideration to heart. We believe it's of so much importance. It's not about partisan politics that's going into the ... you know, which is unfortunately part of what we do here in Springfield. But to say this is an epidemic, I'm being modest. So, I appreciate your consideration and I hope that we can work together as collectively to do the best we can to educate the people of the State of Illinois and to get treatment to those who need it. I appreciate your consideration."

Lang: "Thank you, Mr. Speaker, Ladies and Gentleman. I appreciate the comments of the Minority Leader. I know that several on the Minority side of the aisle have worked hard and diligently to come up with some ideas. The issue of heroin is a scourge in all of Illinois but particularly in the suburbs, not only in DuPage, but the Cook County and the Lake County suburbs in particular. I had asked, before the... the Minority Party had their press conference, the Speaker to create a heroin task force and I do believe that as early as today there will be requests going out to people who want to serve on that task force. I would invite Members of the Minority Party to join this task force and let's work together to try to resolve this problem, or take a big bite out of this problem, to remedy this really terrible problem in all of our communities. Thank you, Mr. Speaker."

Speaker Turner: "Representative Reboletti."

Reboletti: "Point of personal privilege, Mr. Speaker."

Speaker Turner: "Please state your point, Sir."

Reboletti: "Mr. Speaker, I would join the Minority Leader and Majority Leader Lang, but I don't think we need a task force. I've been assigned to a task force about heroin that hasn't met yet, and I wish it would, regarding education and issues of heroin within schools. When I was a narcotics prosecutor in 2004 in Will County, we saw a huge increase where it surpassed crack cocaine as the drug of choice for all generations, for all ages, for all demographics. And now that has continued north, where we have not only 46 overdose deaths in DuPage, but all throughout the state, you'd be surprised that there are thousands of overdoses where a person lives.

And I don't think that we need a task force, which is a great idea, more than glad to serve on it as I do on so many others, but I think that we need to address some of these issues sooner than later. We have a tendency here to wait until the very end. It'll be May and then the clock will run out. Unfortunately the clock has run out on many folks that have become addicted and have overdosed and have died. It's not only a disease of the individual, Mr. Speaker and Members of this Body, it becomes a family disease. It affects all the family members because the person that they love becomes a shadow and a skeleton of themselves. They end up lying and cheating and stealing and becoming just a distant memory of the people that remember them. With that, Mr. Speaker, I would ask that we address those sooner than later, otherwise I will bring other appropriate motions at that time. Thank you."

Speaker Turner: "Thank you, Representative. Representative Cabello."

Cabello: "Thank you, Mr. Speaker. I ask for a point of personal privilege."

Speaker Turner: "Please state your point, Representative."

Cabello: "I also want to rise in support of trying to get this moved along. In our county, Winnebago, we had 124 people pass away last year alone due to a drug overdose, 124 people. That is an epidemic if you ask me. So I rise in strong support of this. I am also on a task force with Leader Reboletti and I believe our first meeting will be March 1, in Rockford. So please, let's take a look at this very quickly. Thank you."
