Speaker Lang: "On the Order of Resolutions, on the Calendar, there appears House Resolution 732, Mr. Pritchard. Please proceed, Sir."

"Thank you, Mr. Speaker. Ladies and Gentlemen of the Pritchard: House, we passed this Resolution a few weeks ago but today we have the recipient of that legislation here. And I'm also joined by the Senator from this person's district, Sue Rezin, from... that represents part of LaSalle County, and the Minority spokesperson for the Agriculture Committee, Sam McCann, as well. And what we're doing today is recognizing an individual who has spent his life promoting agriculture, working with us here in the Legislature on agricultural policy and it seemed appropriate that upon his retirement as President of the Illinois Farm Bureau that we recognize Phil Nelson. Phil is up in the chambers over here on the right side. A year or two ago, Phil was the Star Farmer for Illinois. He was also the American Farm Bureau Federation National Outstanding Young Farmer, and then he was Prairie Farmers Magazine's Master Farmer in 2001. But he's a fourth generation grain and livestock farmer from Seneca, in LaSalle County, as I mentioned, and he has served as the 14th President of the Illinois Farm Bureau and as its full-time executive officer for the past 10 years. Phil Nelson is an outstanding spokesperson for farmers and for all facets of agriculture, maintaining the highest level of integrity and honesty. His knowledge of agricultural issues is highly regarded, resulting in expanded relationship with both sides of our aisle here in the House and in the Senate, and in the policies that occur in Washington. Not only has he served as the Farm

Bureau President, he was also President of the Illinois Soybean Association, vice-president of the American Soybean Association and President of the LaSalle County Farm Bureau. Phil has been very active on the American Farm Bureau Federation board of directors, working in the area of trade advisory committee for the last four years. It's our honor to recognize him, his wife, Carmen, and their three children as they continue the tradition of family farming in Illinois. All of us can participate in recognizing Farm Bureau for what they do in our food production system with a reception that's going to be held this evening in the President Lincoln Hotel from, I believe, it's 6 to 7:30. And we'll also have a reception immediately following adjournment where we can have some cake, if you want to have some cake, in the Speaker... the Leader's office for the Republicans, here on the back side. Also, with Phil today is Rich Guebert, who is the current President of the Illinois Farm Bureau, and he will be welcoming us tonight. So, our congratulations and thank you for this recognition of Phil Nelson the 10th... the 14th President of the Farm Bureau."

in this Body, the General Assembly, and that's Miss Wyvetter Younge. If you didn't have an opportunity to serve with Miss Younge, you missed a treat. Wyvetter Younge was born in August of 1930, deceased December... December of 2008. She was a Democratic Member of the Illinois House of Representatives, representing the 114th District from 1975 until 2008. She served as Assistant Majority Leader and was a member of the Illinois Legislative Black Caucus, an attorney with a BS from Hampton Institute, a JD from St. Louis University School of Law, and an LM... LLM from Washington University School of Law. Younge was a former Assistant Circuit Attorney for the City of St. Louis. Miss Younge was married to Richard Younge, also an attorney, and they had three children: Ruth, Torque and Margaret and two stepsons, Richard Jr. and Roland Younge. Her daughter, Margaret, has said that her mother drove 90 miles, 90 miles, every day, back and forth to the General Assembly so that she could be home with her children in St. Louis that evening. She was one of the longest serving Members, current Members, of the Illinois House. Her legislative priorities included urban renewal, substance abuse treatment, services for the homeless and economic development. She was truly a public servant and dedicated to equality and community progress. Miss Younge received Best Legislator award from the UAW in 1993. She was a lawyer believing in education and the economic development, fighting hard to keep the community college in East St. Louis. She fought to make certain that the Casino Queen would be in East St. Louis. And she fought for any cause that would help her district. Miss Younge had a high school named after her in East St. Louis, and it's

still serving today to many, many kids from that area. She set the framework for Illinois Homeless Bill of Rights. She sponsored House Bill 4116 in 2004, which passed the House but did not progress to the Senate. It contained several provisions that are now law including the rights of the homeless people to access emergency medical care, the right to vote, and privacy of personal records. To respect her dedication and hard work for the people of her district, and on a larger scale, the contributions she has made for the advancement of African Americans in government, we believe she served to be honored... deserves to be honored this February as part of Black History Month. And on that note, I would in... take this opportunity to invite each and every one of you to the Governor's Mansion tonight. There will be a soiree that's being given by the Illinois Legislative Black Caucus and we would ask that you would all come. It starts are 5:30, is the start time; 6:00 is the program, and we'd hope we could see each and every one of you there. Thank you."

Sullivan: "Last year, we enhanced the Charitable Games Act with Representative Lang's legislation and in there was an unintended consequence which limited to one night per month for nongovernmental entities. So, if you have a school that did a multiple weekend two-night event, those were now disallowed under the legislation. So, this is a cleanup to go back to how we were doing it before."

Franks: "And the law that we passed with Mr. Lang... you're saying Mr. Lang's law was all screwed up. Is that what you're saying?

I'm just... I'm just trying to make sure I understand."

Sullivan: "We had a... we missed a piece of it that affected certain Catholic schools that do charitable games, like in my district, Carmel High School, and then in Representative Cloonen's district."

Franks: "So, his inferior legislation needs to be corrected. But I.m here's what I'm trying to figure out."

Sullivan: "Yes."

Franks: "Under his previous inferior legislation, it allowed for how many nights of gaming and how much would this new and improved legislation allow for?"

Sullivan: "Twelve... 12 per year."

Franks: "Okay."

Sullivan: "And it does not enhance the amount of nights. It just says how you can do it in... within a month."

Franks: "All right. So, we're changing the amount of nights, we're just making it more workable for those that need it worked."

Speaker Lang: "Welcome to Springfield. Continuing on the Order of Resolutions. House Resolution 420, Mr. Reboletti."

Reboletti: "Thank you, Mr. Speaker. I've had this Resolution before. It happened a couple of years ago. The idea of the Resolution is that... to make sure that when the Governor orders flags to be flown because of the passing of a military personnel, as we've seen very tragically recently, an IDOT worker and a tollway worker, that local and state media outlets would put the information of the Illinois Flag Honors subscription, which you can get by email. I'm encouraging all media to put that on there and ask all of us to put it on our websites so that people that want to fly the flag and follow what the Governor's putting out, can do so. I'd ask for its adoption."

Speaker Lang: "Representative Davis."

Davis, M.: "Speaker, I rise for a point of personal privilege."

Speaker Lang: "Representative, could we just hold that until we finish this Resolution?"

Davis, M.: "I'll be happy to. I'll be happy to."

Speaker Lang: "You can stay standing. We're just about ready to go to you. Those in favor of the Resolution will say 'yes'; opposed 'no'. The 'ayes' have it. And the Resolution is adopted. Now, Representative Davis."

- Davis, M.: "First of all, I'd like to say in reference to Professor Timuel Black, he's also a famous author. He's written several books and he's appeared on many television programs. And he's truly an icon and a hero on African-American history and American history in this state. So, we ought to really give him a big round of applause. Welcome, Tim, again. I'd also like to say we have in our presence one of our former Members, Representative Karen May, who is visiting the floor today and she was an environmentalist on the floor, and we welcome her back to Springfield."
- Speaker Lang: "Welcome, Representative. You trying to sell some more of your stuff from your apartment, is that why you're here? All right. House Resolution 474, Mr. Brauer."
- Brauer: "Thank you, Mr. Speaker. House Resolution 474 urges Citizens Coinage Advisory Committee to study and make a recommendation to the United State Secretary of the Treasurer on a production of a Lincoln Sesquicentennial Coin. I urge its passage."
- Speaker Lang: "Those in favor of the Resolution say 'yes'; opposed 'no'. The 'ayes' have it. And the Resolution is adopted. House Resolution 524, Representative Hatcher."
- Hatcher: "Thank you, Mr. Speaker. House Resolution 524 urges congress to pass House Resolution 875 to scientifically determine the effects of E-15 on internal combustion machines."

- Riley: "Thank you, Mr. Speaker. House Resolution 675 essentially urges the CTA to make financial and planning commitments to the Red Line Extension. The Red Line Extension has been talked about since 1967. And when the Dan Ryan 'L' was first constructed, the whole idea was for these stations to go all the way to 130th Street. And just like the old quote in the book said, what happens to a dream deferred? The dream of having the CTA Red Line go from 95th to 130th Street has been around a long time. Communities have been promised this. We don't think that the CTA has acted fast enough. It is not... no moneys for planning or construction are in the current budget. So, House Resolution 675 essentially urges the CTA, with all deliberate speed, to put some action behind the Red Line Extension."
- Speaker Lang: "Those in favor of the Resolution say 'yes'; opposed 'no'. The 'ayes' have it. And the Resolution is adopted. The Chair recognizes Mr. Reboletti."
- Reboletti: "Mr. Speaker, I have an inquiry of the Chair."
- Speaker Lang: "Always makes me nervous. Please proceed, Sir."
- Reboletti: "Speaker, since we're running all these Resolutions, are we prepared... are we prepared to adjourn sine die since we're... seem that we've finished all the House business?"
- Speaker Lang: "Unfortunately, Sir, you are not recognized for that purpose."
- Reboletti: "I said... I wasn't trying to make the Motion, Mr. Speaker. I just... feels like it's the last day of Session with all these Resolutions running."

- Speaker Lang: "Thank you. Mr. Sandack is laughing at you, Sir. House Resolution 707, Mr. Moylan. Please proceed."
- Moylan: "Thank you, Mr. Speaker. House Bill 707 encourages the City of Chicago, the Chicago Department of Aviation and the Federal Aviation Administration to revisit the current plan for a voluntary and workable Fly Quiet program. Thank you."
- Speaker Lang: "Those in favor of the Resolution say 'yes'; opposed 'no'. The 'ayes' have it. And the Resolution is adopted. House Resolution 730, Mr. Hays."
- Hays: "Thank you, Mr. Speaker. The Falun Gong is a peaceful, spiritual practice and has been persecuted by the Chinese Communist Party as documented by the United States Department of State, the U.S. Commission of International Religious Freedom, Amnesty International, Human Rights Watch and many other governmental entities. Canadian human rights attorney, David Matas and former Canadian Secretary of State for Asia-Pacific relations David Kilgour cowrote the investigative report 'Bloody Harvest: Revised Report into the Allegations of Organ Harvesting of Falun Gong Practitioners in China'. This heinous practice involves the involuntary harvesting of organs from citizens, from those who are incarcerated in prison. The Resolution calls for the United States Government and the U.S. President to investigate organ transplants in China and take all reasonable steps to bring an end to this revolting practice of harvesting organs from living Falun Gong practitioners and requests the United State Government to prohibit any doctors who perform the transplant using

organs harvested from these practitioners from gaining entry into the United States. I ask for an 'aye' vote."

Speaker Lang: "Those in favor of the Resolution say 'yes'; opposed 'no'. The 'ayes' have it. And the Resolution is adopted.

Returning to House Bills-Third Reading, there appears House Bill 4244, Mr. Hays. Mr. Hays. Please read the Bill, Mr. Clerk."

Clerk Bolin: "House Bill 4244, a Bill for an Act concerning finance. Third Reading of this House Bill."

Speaker Lang: "Mr. Hays."

Hays: "Thank you, Mr. Speaker. House Bill 4244 provides that if an independent college with benefits from grant money received pursuant to the Build Illinois program no longer qualifies as an independent college, that the balance shall be transferred to any qualifying independent college. In this specific instance, the Benedictine University was partnering with Springfield College, and Springfield College now being defunct and that campus is run by Benedictine... Benedictine University, the grant award of \$1 million would be moved from Springfield College to Benedictine to complete a construction project. I'd be happy to any... answer any questions."

Speaker Lang: "This will be a Third Reading Roll Call. The Gentleman's moved for the passage of the Bill. The Chair recognizes Mr. Franks."

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Gentleman yields."

Franks: "Representative, I'm not sure I totally understand what you're trying to do. It looks like we had a capital program

a few years ago and certain moneys were allocated but not spent. Would that be a fair portrayal?"

Hays: "That's right. This is part of the Build Illinois program. There were dollars that were earmarked for independent colleges. Independent colleges around the state received those funds. In this instance, Representative Franks, there would... there was an award to Springfield College. Springfield College is now defunct and that campus is being run by Benedictine University. There was a long-standing history of cooperation, courses from Benedictine being held on the campus of Springfield College. Benedictine now runs that campus. And so, this ... the Board of Higher Ed, which actually testified in favor of this, said there was not a conduit... that... that there was not a conduit to allow the moneys to be spent by Benedictine. This is the same campus, the same students, the same location, but they were worried that there was nothing in statute that allowed those dollars to go from being awarded to Springfield College to Benedictine. This is the same project that they had anticipated doing before. The Board of Higher Ed just thought we needed to codify it so everything was..."

Franks: "Right."

Hays: "...according to Hoyle. They did testify in favor of this."

Franks: "So, it's just another name on the door, but it's going to the same place, for the same purpose?"

Hays: "Yes, Sir."

Franks: "It's just... it's just not going to the prior institution, it's going to the subsequent institution."

Hays: "That's absolutely correct."

Franks: "Now, let me ask you this, has there been any material changes with the subsequent institution, which is Benedictine? Has there been a massive loss of students?
