Speaker Turner: "Members, beginning on page 6 of the Calendar, under the Order of House Bills on Third Reading, we have House Bill 3681, Representative Lang. Mr. Clerk, please read the Bill."

Clerk Hollman: "House Bill 3681, a Bill for an Act concerning regulation. Third Reading of this House Bill."

Speaker Turner: "Representative Lang."

Lang: "Thank you, Mr. Speaker, Ladies and Gentlemen. This Bill amends the Transmitters of Money Act. Today under the law, if a company is taking your money and sending it to somebody else electronically, they have to be licensed under the Transmitters of Money Act. They have to pay a fee, they have to pay a renewal fee, et cetera, et cetera. But there are many companies, such as Groupon and others, who don't ever really touch anybody's money. All they do is do a couple of electronic blips on a screen. They never hold anybody else's money. All they do is electronically transfer it, so there's no way for them to defraud anybody. There's no way for them to steal it. They don't have their hands on the purchaser's money, someone who is purchasing a good or service. And therefore, this is a negotiated Bill to deal with that issue, to exempt payment system operators like TechAmerica from this Act. That's all the Bill does. I don't think there are any opponents in committee. I ask for your support."

Pritchard: "Ladies and Gentlemen, this is a Bill that we passed out of the House last year that dealt with malicious damage to firms that are in the process of helping municipalities and others with nuisance animals. It allows them to get a DNR license and they have to be supervised. But what has happened is all of information, including the location of their traps, has been made public and vandals go out and remove the expensive merchandise and create a lot of problems for those that are trying to release... remediate nuisance animals. So, I would ask for your help. This gives exemption from the revealing of the location, but everything else would still be available to the public."

Bost: "Will the Sponsor yield?"

Pritchard: "Ladies and Gentlemen, I would ask that you cooperate and help us get rid of some of the nuisance animals in our municipalities and other areas. Thank you."

Speaker Turner: "The question is, 'Shall House Bill 5911 pass?' All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On a count of 102 voting 'yes', 2 voting 'no' and 0 voting 'present', House Bill 5911, having received the Constitutional Majority, is hereby declared passed. House Bill 1532, Representative DeLuca. Mr. Clerk, please read the Bill."

Clerk Hollman: "House Bill 1532, a Bill for an Act concerning civil law. Third Reading of this House Bill."

Speaker Turner: "Representative DeLuca."

DeLuca: "Thank you, Mr. Speaker and Ladies and Gentlemen. House Bill 1532 deals with the offensive use of property, which means the repeated use of the leased premises in a manner that disturbs the peace or is detrimental to the health and safety of the neighbors of the premises. This is a little different than what we've attempted in the past in regards to crime-free housing. This legislation is a result of many years of working and narrowing down crime-free housing. Now, what's

important to recognize about this Bill is it only affects the worst offenders. So, if you look at the legislation, you will see where it states that on three occasions, three or more separate occasions within a 60-day period where an arrest was made or a citation was issued for the commission of an act. So, what that says, just think about what we're talking about here. We're talking about an offender who three times within 60 days commits an act that would be described under offensive use of property. Now, either a citation or an arrest would be issued on each separate occasion. That would then allow the landlord to proceed with a termination of the lease. Now, what we've included... what we've included in this is a right to cure. Now, that's important because what that says, in the event that this offender has committed three acts within 60 days and goes before the court, they will be given one more opportunity to cure. So, for example, in committee it had come up that if you have a chronic barking dog. Would a chronic barking dog be justified as something that a citation could be issued and ultimately jeopardize the lease? Well, under this legislation it would give that tenant the opportunity to correct the problem before... before an eviction would take place. So, this legislation, is a culmination of what we worked on for many years. And I would be happy to answer any questions. And I ask for your 'yes' vote."

Speaker Turner: "On that, we have Representative Bost."

Bost: "Inquiry of the Clerk, please."

Speaker Turner: "Please state your inquiry."

Bost: "Has Amendment #3 been adopted?"

Speaker Turner: "Mr. Clerk."

Clerk Hollman: "Floor Amendment #3 was withdrawn."

Bost: "Okay. Then will the Sponsor yield, then?"

Speaker Turner: "He indicates that he will."

Bost: "It's our understanding that Floor Amendment #3 would have removed all opposition to the Bill and... and that was then tabled and... and was not adopted. Can you tell us why and what might have been going on with that?"

DeLuca: "It was last Session when we were coming up to the deadline, there were efforts made to try and remove the opposition. And what we found out... what we determined was the agreement that was then put in place, watered it down so much that it was unusable. So, we couldn't even support the Amendment that would have removed the opposition. It made it unusable."

Bost: "Okay. So, the way it is right now, three offenses in 60 days and... and is there a level of what those offenses could be?"

DeLuca: "Yes. On three or more separate occasions within a 60-day period, an act committed on the property as a felony or Class A misdemeanor, an act of disorderly conduct where the individual knowingly does any act in such an unreasonable manner as to alarm or disturb another and to provoke a breach of peace or a violation of a public order adopted under sections of the Illinois Municipal Code that allows the corporate authorities... I could continue reading, but that's generally..."

Bost: "Well, ba... basically, what you're saying is, these aren't just... just violations of the lease agreement. They're violations of... of actual law."

DeLuca: "That's correct, yes."

Bost: "And there... and there would have to be three of those in 60 days."

DeLuca: "That's correct."

Bost: "Okay. That... that's all we need to know. Thank you."

Speaker Turner: "Representative Pritchard."

Pritchard: "Thank you... thank you. Will the Sponsor yield?"

Speaker Turner: "The Sponsor will yield."

Pritchard: "Representative, I do know that you've been working some time on this and there's been a lot of varying views on it, but I understand there's still opposition to this. Could you describe what that opposition is?"

DeLuca: "The opposition to... generally would be anything, any legislation, any mechanism that would allow a landlord to evict a tenant for whatever reason, they will oppose. They will just generally oppose that concept. So, we have narrowed this down. You could even say we have watered it down from some of the crime-free housing legislation that I have worked on and introduced in the past, some successful, some unsuccessful. So, this gets to where we're just talking about creating an environment that is safe and peaceful. That... you have to be extremely disruptive to fall into this category, to actually have the police come out and issue an arrest or a citation three times in 60 days, you're doing something... you're doing something wrong."

Pritchard: "So, there was also a concern in here that we have had a problem with evictions before, where landlords try to evict because they couldn't get access to the police records or

other justification for the eviction. Does this Bill take care of that concern?"

DeLuca: "Well, it doesn't mandate it, but certainly the... the concept of crime-free housing, the concept of this legislation is cooperation. It's about the landlords and the municipalities working together and if they're working together, then the exchanging of information is not a concern... should not be a concern."

Pritchard: "Well, I know. But that's been some of the problems, that police departments wouldn't release the information and... and yet the city was coming down very heavily upon the landlord. So, I... I just want to make sure that there's going to be that kind of cooperation and help for evicting some of these problem situations."

DeLuca: "Well, whether this becomes law or not, this is... this is a continuing work..."

Pritchard: "Okay."

DeLuca: "...to try and clean up some of the issues with crime-free housing."

Pritchard: "Thank you."

Speaker Turner: "Representative Davidsmeyer."

Davidsmeyer: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "Sponsor will yield."

Davidsmeyer: "I'm just wondering how this affects the victims of crimes that are... are... living in these rentals. For instance, if... if a couple's living there and it's a domestic battery, does this affect the... the individual who is battered? Does this allow the people to evict the couple as a whole?"

DeLuca: "Yes. It prohibits landlords from filing a forcible entry and detainer action based on offensive use of property if the acts are a result of the tenant or occupant being a victim of domestic violence, dating violence, sexual assault or stalking."

Davidsmeyer: "Okay. So, it... it does protect victims, then."

DeLuca: "Yes. That's correct."

Davidsmeyer: "All right. Thank you."

Speaker Turner: "Representative Cabello."

Cabello: "Thank you, Mr. Speaker. To the Bill. I rise in strong support of this Bill. Listening to some of the questions that people are asking, this is not going to give the landlords a reason to evict people for no reason whatsoever. There's times that the police are called to the same residence three times in one day. There's times the police arrest somebody three times in one day, three separate people from one residence. Whether it's a drug house, whether it's a gang affiliated house. So, I would hope and request that we would all vote 'aye' on this. Thank you."

Speaker Turner: "Representative Riley."

Riley: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "Sponsor will yield."

Riley: "Representative DeLuca, I know you've been working on this a long time. Did the IML ever have a position on this Bill?"

DeLuca: "Well, surprisingly, I do not see that they took a position."
