Chapa LaVia: "You still look mighty fine today. Thank you very much. So last year, we passed a piece of legislation for public assistance that we are allowing... well, what happened is there were people out there that were abusing the system, taking advantage of individuals having benefits and asking to secure dollars from their benefits. And in our overzealous to pass that, to protect the consumers in the State of Illinois, what we did is we took the ability for attorneys or anybody receiving grants like... like Family Focus or Aunt Martha's to stop taking money from the state to help support our constituency to get through the paperwork to get benefits from the state. We excluded them and made it a misdemeanor. So, this is a minor correction to allow those entities to still receive dollars from us and not be fined. This does not allow private attorneys to make money off our citizens of the State of Illinois. This is only for not-for-profits. And I'll take any questions."

2640 is an Amendment to the Condominium Property Act clarifying precision... provisions related to closed board meetings ensuring that votes take... any votes taken in closed sessions have to be held at an open meeting. Adds a provision about clarifying how board members can participate by alternative means, such as telephone or video conference, and changes notice requirements. According to the Act, all board members must receive notice 48 hours prior to the meeting unless they waive the notice agreement... or notice requirement. And currently, notice needs only be mailed or delivered 48 hours prior to a meeting, so it makes some clarifications on notice. I ask for an 'aye' vote."

Speaker Lang: "Those in favor of the Bill will vote 'yes'; opposed 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Arroyo, Burke, Drury. Please take the record. On this question, there are 113 voting 'yes', 0 voting 'no'. And this Bill, having received the Constitutional Majority, is hereby declared passed. Clerk Hollman: "House Bill 2641, a Bill for an Act concerning civil law. Third Reading of this House Bill."

Speaker Lang: "Representative Cassidy."

Cassidy: "Thank you, Mr. Speaker. House Bill 2641 addresses emergency actions taken by boards allowing boards of managers of a condominium to ratify and confirm actions of members of the board taken in response to an emergency and further defines emergency to allow boards to take action to make repairs in response to... to emergency repair issues in a... in the building. I ask for an 'aye' vote."

Sandack: "Thank you. Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Of course she will."

Sandack: "Two questions, Representative. First, on the Order of Cassidy, all well and good, why weren't all of these changes in one omnibus Bill?"

Cassidy: "Because ultimately, each of these requires... they work on different sections of the Act or different Acts altogether. And for clarity, the... the proponents from the Bar Association believed that having them done separately was a better approach for clarity purposes."

Sandack: "What redundant aspects of the... of the Act are you deleting, specifically?"

Cassidy: "It remove... Yes. It removes language providing that all provisions of the declaration bylaws and other community instruments severed by the Act shall be revised by the board of directors independent of the measurement... membership to comply with the Act. So, it takes out double statements on that. Section 160 provides the same statement."

Sandack: "So it's a..."

Cassidy: "We didn't want to do anything triplicative."

Sandack: "...duplication. Nothing triplicative. Thank you."

Speaker Lang: "Those in favor of the Bill will vote 'yes'; opposed 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Cassidy, you wish to vote for your Bill? Representative Wallace. Please take the record. On this question, there are 114 voting 'yes', 0 voting 'no'. And this Bill, having received the Constitutional Majority, is hereby declared passed. Still pressing your luck, Representative? House Bill 2643, Representative Cassidy. Please read the Bill."

Cassidy: "Thank you, Mr. Speaker. We're almost there. There are two changes to the Con... Condominium Property Act in House Bill 2643. One addresses how notice is given to mortgagees or lienholders with regard to Amendments to condominium instruments. And the other addresses the possibility of omissions, errors, or inconsistencies in the instrument so that... that they can correct that with two-thirds vote."

Speaker Lang: "Representative Cassidy."

Cassidy: "Thank you. We are finally at the end of the Order of Cassidy. 2644 addresses issues related to conflicts between developers and unit owners and the ability to seek legal... legal redress. It narrows the language to only allow that redress in issues of construction defects. And I ask for an 'aye' vote, one more."

Speaker Lang: "Mr. Sandack."

Sandack: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Sandack: "Kelly, I'm going to need you to go through this one a little more specifically because there was opposition in committee. What was the impetus? What is the reason for this Bill or the necessity for your cleanup language?"

Cassidy: "So, current law voids any provision in a condominium instrument that limits or restricts the rights of the board to act in general. This provides that they may do that with regard to these construction de... defects. The other issue

that comes up, very often, in some of the condos in my condo... developments in my district, this... this 75 percent is sometimes hard to reach because of vacancies and bank-owned properties, and so it narrows it to these very limited circumstances of construction defects."

Sandack: "So, that 75 percent concept though was pretty fundamental in your... under existing law. So that's a pretty big change."

Cassidy: "This still requires that 75 percent."

Sandack: "It requires it? I thought it deleted the language requiring 75 percent."

Cassidy: "Let me double-check. We did something around this more broadly last year, lowering it. This narrows that, what we did last year, down to just construction defects."

Sandack: "Okay. But I have in my analysis it deletes the language requiring 75 percent of the affirmative vote of unit owners... owners to enforce provisions under the Act."

Cassidy: "With regard to construction defects, in particular in new developments, there aren't enough owners to address that. So a developer may still own a significant portion of the development when the construction defect becomes... becomes evident. And that... that's where we run into the problem. Either the units are bank-owned and nobody's available, or they're still owned by the developer who is the cause of the construction defects. So this is allowing these folks who are going into new developments to have opportunity for redress on these construction defects."

Sandack: "Well, I... I get it, but I don't think there's... it's limited by any new construction. I'm looking at the... the text of the... of the Bill."

Cassidy: "It's not limited to new construction, obviously, because you have renovations, you have changes made by the developers. But this... these would... these tend to be new developments or newly remodeled developments."

Sandack: "I get that, Representative. But this lets less than 75 percent, whether it's new or not, whether it's new construction or not, no longer be the threshold."

Cassidy: "Only in terms of going after a developer for construction defects. Again, keep in mind, we're talking about buildings who may be sitting on the market for many, many years where the developer, the person who is the cause of the construction defects, still owns the bulk of the building."

Sandack: "I get that. To the Bill. I hear loud and clear what the Sponsor's saying. I don't think the language says what she thinks it says. I think it's more expansive. It is not limited, in my reading, to construction, new construction, whether the unit is full or not. I think it deletes the 75 percent criterion and that's a major deviation from condominium law. I would urge a 'no' vote on this one, on this Order of Cassidy."

Speaker Lang: "Mr. Breen."

Breen: "Thank you, Mr. Speaker. Just... Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Breen: "Thank you. Representative, I'm... the operative language of your Bill is that a provision in a declaration, which would

otherwise be void and ineffective, may be enforced if it's approved by a vote of not less than 75 percent of the unit owners. So it appears that this provision that's being stricken gives unit owners more power. And so for that reason, it is actually a homeowner protection provision that is being stricken from this Act. I don't do condominium law, but that is... it appears to be a homeowner protection provision, and that was why we had opposed it in committee."

Cassidy: "It... This actually does protect the unit owners against some of the... we've had some very shotty developments in my district. Some very... slap-shot work done. You know, grab an apartment building, turn it into condos, hope for quick money, the market bursts. There's only three people living in a 20-unit building, and then the developer still owns the rest of it and they can't make him make those repairs."

Breen: "But ri... Yeah."

Cassidy: "This is the situation we seek to address. Those owners couldn't possibly reach that 75 percent threshold to get this work done to get this redress."

Breen: "But... but again, the provision that you're striking appears to give them an affirmative ability to do it. It doesn't restrict other powers, otherwise. The... the problem is, also, it's not limited to construction defects. It's any declaration in a condominium instrument, any declaration in a condominium instrument. And the operative language for your Bill is really that striking subsection (b)."

Cassidy: "I believe that Section 2 is what addresses the defects and the issue of the developer."

Breen: "And then maybe if... if the difference is... Maybe I... maybe I should just go to the Bill and maybe we've got a... we've got a fundamental difference. It..."

Cassidy: "Okay."

Breen: "The issue here is that homeowners should have the right to act apart from the board of managers, who is the other elected representatives. But if the homeowners, 75 percent of them, decide to step up and do something, they should have that ability. I think that should be maintained in current law and therefore, would respectfully urge a 'no' vote on this particular Bill in the Order of Cassidy."

Speaker Lang: "Representative Cassidy to close."

Cassidy: "Once again, with due respect to my colleagues, this addresses an issue where there aren't 75 percent of owners. The developer would be 75 percent of the owners. And... and takes care of some of the... the really horrific situations I experience in my district every day. And I do ask an 'aye' vote. This does protect the rights of the people living in the units and that's what we're attempting to... to accomplish here today."

Currie: "Thank you, Speaker. It's a simple proposition. It permits the Secretary of State to... to receive applications to be a notary public online. Doesn't require online application, but it makes that possible. I'd appreciate your 'aye' vote."

Speaker Lang: "Those in favor of the Bill will vote 'yes'; opposed 'no'. The voting is open. Have all voted who wish? Hernandez, Sosnowski. Hernandez. Please take the record.
