Durkin: "Thank you, Mr. Speaker. This Bill is a Bill we've seen in this chamber before. This Bill will allow Lyons Township High School, which is in my district, the ability to disconnect from the school treasurer's office that is a part of the Lyons Township School Treasurer Office. They're currently being billed for services that they do in-house. They no longer need these services. We have done this in the past for a number of school districts, particularly in Cook County. And I'm asking for a favorable vote."

Franks: "Representative, is there any cost to the state should this pass for... with the... with the disconnect of this jurisdiction?"

Durkin: "No."

Franks: "Okay. Why do you want to do it?"

Durkin: "Why? Because this is an outdated form of government. The township's school treasures are only... they're unique to Cook County alone."

Franks: "Okay."

Durkin: "The offices were statewide up until 1968. They were eliminated outside the state. Some school districts, it provides a valuable service for them. Doing payroll, account receivables, account... I got the list here... a lot of clerical functions that smaller schools within certain parts of Cook County don't have the capacity to undertake. But Lyons Township High School is a very sophisticated high school. They're being... currently being billed a quarter of a million dollars a year for services that they are doing themselves."

Franks: "Wow."

Durkin: "It's a... it's... this have been going on for a while. And so, I think it's the responsible thing to allow them to no longer be under the auspices of this form of government. We've done this in the past for the Oak Park, River Forest School District 200, Oak Park Elementary School 97, River Forest School Districts, Cicero School Districts, all in Cook County who can provide these services on their own without having to be... which to me is, I think, would be a challenge... it would be... it would be a problem with, you know, part of their tax base. What they have to do is they have to levy their taxes

and provide... and pay these services for things which they can do on their own."

Franks: "I think it makes sense. Should we go farther? Should we get rid of this office? Because it seems like it's a vestige of the past. It's probably not needed in today's day and age."

Durkin: "I... I will say, personally, that I agree with you. And we have to come to some type of conclusion. I would actually... I've thought about conducting some type of broader inquiry into the ethicacy of this type of government throughout Cook County. And I do... as I said earlier, for schools such as Lyons Township High School and also some very good solid high schools throughout Cook County, they can do these services on their own. But I do know that there are smaller school districts who rely upon this service. But personally, I wish I could, but this has been... they've been trying this for years. And for whatever reason, there has been no success on trying to eliminate that office. But I will give you my word today that I plan to have a broader inquiry into the ethicacy, as I stated, of the township's school treasurers in Cook County. It makes sense."

Franks: "Well, you're word is good with me."

Durkin: "Thank you."

Franks: "And I'll support your Bill. I just want to say tomorrow Lieutenant Governor is conducting the first of our hearings for the consolidation commission and this might be something that we should address. So, perhaps, you could have someone from your staff perhaps... give us a white paper on that and I can have it given to our committee tomorrow, which starts at 4:00."

Currently, this interest is locked in because there was an accounting error. I'm asking for your approval."
