Phillips: "No. It's not against anyone."

And they've also said that their stated purpose is to destroy Israel, yet this Resolution points out the fact that Israel is our ally and they are threatened by Iran. Isn't that correct?"

Phillips: "Yes, Sirree. Thank you."

Franks: "I think this is..."

Phillips: "Keep going."

- Franks: "...I think this is a Resolution that... Well, let me ask you this. How did you come up with this Resolution?"

- Franks: "I think it's important that we... that we stand with our friends in their time of need. I think that's something that this country has always done. And it's an incredible sight. So, if you haven't been, I'd encourage you to go."

Phillips: "Thank you. Yes, I will."

Speaker Riley: "The question is, 'Shall House Resolution 198 be adopted?' All in favor say 'aye'; all opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. And House Resolution 198 is hereby adopted. House Resolution 223, Representative Anthony."

"Thank you, Mr. Speaker. Ladies and Gentlemen of the Anthony: House, today we are proud to recognize Mr. John W. E. Thomas, the first black Member of the Illinois General Assembly. John Thomas was born a slave in Alabama in 1847. He learned at an early age how to read and write. And as a teenager during the Civil War he engaged in the dangerous work of teaching literacy to more than three dozen slaves, a crime under the laws of the Confederacy. A few years after the war, John Thomas moved to Chicago with his wife, Maria and their daughter to start a new life, where he opened a grocery store and he continued his passion for education by working as a teacher. Thomas was elected to the Illinois General Assembly in 1876, leaving in 1879 to study law and earn admission to the Illinois Bar before being reelected to this House for two more terms serving from 1883 to 1887. As a Member of the Illinois House, Thomas sponsored and passed Illinois's first Civil Rights Law to ban racial discrimination in public places. John Thomas was a trailblazer, a man of faith, a man of principle and a leader who... who helped make it possible for other blacks to seek and win election to the Illinois

General Assembly. He was also a Republican as were most blacks in the post-Civil War period for several generations. This fact is especially significant here in Illinois, the Land of Lincoln, the Great Emancipator. It was, after all, the Republican Party who passed three critical Amendments to the U.S. Constitution after that war was abolished... after that war that abolished slavery, bestowed citizenship to all former slaves and granted the right to vote. The Party of Lincoln was then and remains today the Party of equality and opportunity for all Americans, regardless of racial or ethnic background. Today in Washington, D.C., a black Republican the honorable Tim Scott serves his State of South Carolina in the United State Senate. And from the State of Utah a young black woman, Mia Love was elected to Congress as a Republican last year. SJR16 modifies several waiver requests to shorten the length of requests and retroactively approves three requests. The remainder of the request is unchanged. SJR16 approves and modifies school district waiver request. The waiver modifications are set up in such a way that the General Assembly must explicitly disapprove or modify a waiver request if the request is not agreeable. If the General Assembly fails to explicitly disapprove a waiver in whole or in part within 60 days of the first Session day following the release of the waiver report, being it May 2 for this report, then the waivers are granted. To the Body. Voting 'yes' means that you approve of modifications and the school district waiver applications outlined in SJR16. Voting 'no' means that you support the original school district waiver applications without any changes. And I urge an 'aye' vote."

Speaker Riley: "The Chair recognizes Representative Sandack."

Sandack: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Riley: "She indicates she will."

Sandack: "Representative, this is kind of an annual rite of passage, this waiver request or waiver report. In comparison to years prior, how many mandate waiver reports or waiver request have there been this year? Are we seeing more, the same, or less?"

- Pritchard: "Right. It waives it because they're an employee."
- Golar: "Without the waiver they would have to pay."

Pritchard: "Correct. And this Resolution comes over from the Senate and how was it voted on over there?"

Golar: "Unanimous voting, Representative."

Pritchard: "Okay. Thank you, Representative."

Golar: "Thank you."

Speaker Riley: "The Chair recognizes Representative Hammond."

Hammond: "Thank you, Mr. Speaker. To the Resolution. I would like to thank Representative Golar for bringing this important Resolution forward. Dealing particularly with tuition waivers for children of employees of school districts where they are struggling getting their children to school in another school district while they, in fact, are working and teaching in another is oftentimes very traumatic for the children.
