Zalewski: "Thank... thank you, Mr. Speaker. I move to concur in Senate Amendment #1 to House Bill 3219. This is a pilot program we did in the House relating to locking of... locking devices of pill bottles. It's simply a pilot project to provide a locking catcher... pain killer prescriptions in Illinois. A pilot project will help prevent a diversion of pain pills and save lives. We added language for the Department of Professional Regulation making it subject to appropriation and saying they can use a subcontractor for the pilot program only. This subcontractor would not be used if there's a full mandated program. And we would ask that the department not use a subcontractor for that. There's no opposition. I ask for an 'aye' vote."

Speaker Turner: "Members, can we please bring the noise level down. We have questions on the Bill. Thank you. Representative Sandack."

Sandack: "Thank you, Mr. Speaker. A few questions of the Sponsor." Speaker Turner: "The Sponsor will yield, Sir."

Sandack: "Thank you. Michael, I couldn't hear you. Making sure I understand something. All opposition that used to exist on this Bill has been taken care of, correct?"

Zalewski: "Correct, correct."

Sandack: "So, it's an agreed Bill."

Zalewski: "Correct."

Sandack: "And it's subject to appropriations."

Zalewski: "Correct."

Sandack: "Isn't that correct? Thank you."

Speaker Turner: "Seeing no further debate, the question is, 'Shall House Bill... 'Shall the House concur with Senate Amendment #1 to House Bill 3219?' All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Gordon-Booth. Mr. Clerk, please take the record. On a count of 107 voting 'yes', 0 voting 'no' and 0 voting 'present', the House concurs with Senate Amendment #1 to House Bill 3219. And all in favor... And this Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 3220, Leader Currie. Leader Currie, you may proceed."

Currie: "Thank you, Speaker, Members of the House. I move the House concur in Amendment 1... Senate Amendment 1 to House Bill 3220. You may remember, we adopted a Secure Choice program a year ago. This would provide that, with the opportunity to opt out, people who work in establishments where there is no opportunity for an employer-sponsored retirement plan would have that opportunity through an independent board working in conjunction with the State Treasurer and the State Department of Revenue. This is clarifying language. Both the Bill we passed and the Amendment that comes back from the Senate establishing that the Treasurer's in charge of the program, establishing who is responsible for writing the reports, making sure that the Department of Revenue adopts appropriate rules and regulations to govern the operation of the program. I know of no opposition. I'd be happy to answer your questions. And I'd appreciate your vote for the Concurrence Motion."

Speaker Turner: "The Chair recognizes Representative Sandack."

Sandack: "Thank you, Mr. Speaker. Will the Lady yield?"

Speaker Turner: "She indicates that she will."

Sandack: "Leader, what is... what are we concurring to? What changes occurred over in the upper chamber?"

- Currie: "Okay. Specifically, State Treasurer will be the administering agency. Department of Revenue will adopt appropriate rules. And that the Treasurer as well as the board will also establish rules to the extent that it's within their shop."
- Sandack: "Okay. So, then thank you for that. In the original Bill it was an independent board that basically administered and because of the investments and basically ran the program.

 What's the Treasurer doing now?"
- Currie: "In the original Bill that we passed the House Bill 3220, we just clarified that when it comes to reporting it's the Treasurer who is a full-time paid person will take responsibility for making sure reports are... are filed are appropriate. Because the board is an independent operation and it seems better to make sure that the people that are directly responsive to us and the electorate are given an ultimate responsibility."
- Sandack: "Thank you for answering the questions. To the Bill.

 Just to remind people, this was a pretty controversial initiative. If you voted 'no' because you thought it was a mandate and because you thought the services being provided ought to cure through the private sector. I agree with the Lady that the changes may have improved the Bill, especially because the Treasurer's involved. I would still caution not

to apply the green button on this one because frankly it'll be held against you. So, I'm going to vote 'no'."

Speaker Turner: "The question is, 'Shall the House concur with Senate Amendment #1 to House Bill 3220?' All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Franks. Mr. Clerk, please take the record. On a count of 73 voting 'yes', 34 voting 'no', and 0 voting 'present', the House concurs with Amendment #1 to House Bill 3220. And this Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 3485, Representative Will Davis. Out of the record. House Bill 3895, Representative Hammond."

Hammond: "Thank you. Mr. Speaker, I move to concur with Senate Amendment 1 to House Bill 3895. The Senate Amendment 1 basically provides that the provisions of the Act do not supersede the Juvenile Court Act and everything contained therein. And it is an initiative of the Department of Juvenile Justice."

Speaker Turner: "Seeing no debate, the question is, 'Shall the House concur with Senate Amendment #1 to House Bill 3895?' All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On a count of 108 voting 'yes', 0 voting 'no' and 0 voting 'present', the House concurs with Senate Amendment #1 to House Bill 3895. And this Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 4096, Representative Feigenholtz."

Feigenholtz: "Thank you, Mr. Speaker. House Amendments 1 and 2 are an agreement with HFS and a lot of work done with the Governor's Office so that we can begin addressing children living with mental health and ICGs. I'm happy to answer any questions."

Sandack: "Thank you. Will the Lady yield?"

Speaker Turner: "She indicates that she will."

Sandack: "Representative, I just want you to reiterate something.

You worked with the Governor's Office on this Bill?"

Feigenholtz: "Yes, Sir, I did."

Sandack: "What a novel proposition. So, we actually have an example of bipartisanship here today. I love it. Well done."

Feigenholtz: "I enjoyed that."

Sandack: "I recommend a 'yes' vote."

Feigenholtz: "Thank you."

Speaker Turner: "The question is, 'Shall the House concur with Senate Amendments 1 and 2 to House Bill 4096?' All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Brady, McDermed. Mr. Clerk, please take the record. On a count of 107 voting 'yes', 0 voting 'no' and 0 voting 'present', the House concurs with Amendments #1 and 2 to House Bill 4096. And this Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 1336, Representative Drury. Please proceed, Sir."

Drury: "Thank you, Mr. Speaker. I move to concur in Senate
Amendment #1 to House Bill 1336. House Bill 1336 is a Bill
aimed at saving our children's lives by allowing their friends

to call for emergency assistance if their lives are in danger due to alcohol consumption. This Bill came to me as a constituent request. This young woman had had too much to drink and was rendered unconscious. Scared of being arrested, her friends left her there and didn't seek any help. Luckily, another person had the courage to call 9-1-1 and got the young woman the assistance she needed just as any of us would do for any of our loved ones. This Good Samaritan's reward was a citation for underage drinking. We want to encourage people to seek medical assistance for those who need it especially our children. House Bill 1336 and Senate Amendment #1 provides that encouragement while containing necessary safeguards to make sure that the law's not abused. The person needs to first call law enforcement. They can't just be upon the scene and they have to cooperate fully. It's important to know that this Bill is supported by the Lake County Chiefs of Police, the Illinois Chiefs of Police Association, the Illinois College of Emergency Physicians, and the Illinois State Bar Association. Over 20 states have passed this good public policy law. And I think that we should pass it as well. I ask for a Concurrence in Senate Amendment #1."

Speaker Turner: "Seeing no debate, the question is, 'Shall the House concur in Senate Amendment #1 to House Bill 1336?' All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Chapa LaVia, Flowers. Mr. Clerk, please take the record. On a count of 74 voting 'yes', 34 voting 'no', and 0 voting 'present', the House concurs with Senate Amendment #1 to House Bill 1336. And this Bill,

having received the Constitutional Majority, is hereby declared passed. On page 10 of the Calendar, under the Nonconcurrences, we have Senate Bill 33. Leader Lang."

Lang: "Thank you, Mr. Speaker. I move to recede from Amendments 3 and 4. Senate Bill 33 was the Bill that added PTSD for our veterans as a condition under which you could be able to purchase medical marijuana. Amendments 3 and 4 dealt with the FOID card and I was trying, under a... a consiverant amount of fundamental fairness to say that no one should lose their FOID card for doing something that's legal. And it passed this chamber. Unfortunately, the Senate didn't see it our way. I do not want the veterans to suffer because the Senate didn't agree on the FOID card issue, so I'm making this a Motion to recede from these Amendments. And we'll get back to this issue later in the year or in the next Session. I would ask your support for receding from these Amendments."

Speaker Turner: "The Chair recognizes Representative Sandack."

Sandack: "Thank you. Will the Leader yield?"

Speaker Turner: "Please bring the noise level down, Members. Thank you. The Leader will yield."

Sandack: "Lou, which portion are we... are we concurring to anything or are we receding from what was sent over here?"

Lang: "The... the Amendments I added dealt with the FOID. So, we would go back to the original Bill as it passed the Senate, PTSD, mostly this involves veterans."

Sandack: "And the FOID portion is out?"

Lang: "Well, first we tried to put this FOID portion on the… there was in a Bill dealing with the gun issue and it was kind of an agreed Bill with a long list of items. The Senate wasn't

interested, so I tried to put it here. And they still weren't interested. And so, I don't want these vets to suffer because I wasn't able to accomplish this and that's what we're doing."

Sandack: "So, if we're... Got it. Thank you. And I... I assume you're commitment to look on the other issues on a different Bill at a different time still persists. And we can..."

Lang: "I still believe it's the right thing to do. As you know, I'm not a big fan of guns, but I believe a matter of fundamental fairness would be to allow these folks at least not to lose their FOID card that maybe they can't buy a gun under Federal Law, but they shouldn't lose their FOID card over it. And I think if there was a court case they would win. But in the meantime, I just want to go back to the original Bill that allows PTSD to be a condition."

Sandack: "Thank you for your answering the questions. Mr. Speaker, is this a voice vote or a Roll Call vote on the receding?"

Speaker Turner: "Representative, this is a Roll Call vote that will require 71 votes to pass."

Sandack: "Thank you, Sir."

Speaker Turner: "The Chair recognizes Representative Sullivan."

Sullivan: "Thank you, Mr. Speaker. Will the… will the Leader…

Leader Lang yield?"

Speaker Turner: "He indicates that he will."

Sullivan: "Leader, a couple questions. First off, the definition of 'PTSD'. Is this specific to veterans or anybody that has been diagnosed with PTSD?"

Lang: "It is not specific to veterans, but for the most part, those who'll come forward interested in doing this are veterans. These are the folks that have testified before a

committee that went before the advisory board to ask the Department of Public Health to add this as a condition. The department hasn't done that yet. And this Bill came out of the Senate virtually simultaneously with that Act. And so, I want to make sure we get this done. And... and I've heard of very little, if any, opposition to this issue."

Sullivan: "Certainly. I'm just getting clarification for the record more than anything else. This was a recommendation from the board for us to follow through and codify this aspect of... of your Bill?"

Lang: "The advisory board that heard petitions for new conditions recommended this and nine others."

Sullivan: "Okay."

Lang: "The director has yet to act. And I thought it was important, again, particularly for the veterans and particularly since this Bill came over from the Senate that we just move this along."

Sullivan: "And thank you. And... and I know that you've, and with the previous speaker on my side, you've talked about the FOID issue. I... I understand how difficult it is working with the Senate President at times on gun issues, that's one of his babies and he doesn't want this FOID issue in there, I believe at some point we'll probably have further discussions about how to, in essence, give back a right to a FOID card for someone that's taking or taking a prescription, in essence, a legal prescription in the State of Illinois. Wouldn't that be your characterization of this?"

Lang: "It's exactly right. There's no other legal pharmaceutical in Illinois that a patient could take that would require their

- FOID card to be taken from them. So, this is something we ought to do. But I can't hold up the PTSD issue over that issue."
- Sullivan: "You know... Well, thank you for your comments. To the Bill. I... I certainly support this for our veterans. Obviously, with the discussion with Leader Lang, this is for more than just veterans. There certainly would be some folks that have PTSD from different conditions or different life experiences that this would help. And I do have a commitment for working on the FOID aspect of the previous Amendments that he's receding for. So, I urge an 'aye' vote."
- Speaker Turner: "Chair recognizes Representative Barbara Wheeler."
- Wheeler, B.: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Turner: "The Sponsor indicates that he will yield."
- Wheeler, B.: "I... you know, Representative, I wish I had asked this the first time we went through this 'cause it's curious.

 How many people right now qualify for the medical cannabis card?"
- Lang: "There are about 2500 people who now have their card. Many applications are still pending. The thought is that once the dispensaries go live in a few months there will be an influx of new applicants."
- Wheeler, B.: "And any idea how many more people will be able to be qualified with PTSD?"
- Lang: "No, I don't."
- Wheeler, B.: "No numbers. It's not just veterans. It's for anyone who has been diagnosed with PTSD."

- Lang: "Yes, but please remember that a treating doctor still has to make a recommendation. So, it's not automatic. So, just like any other patient in Illinois with any other qualifying condition, your doctor has to say, I want you to have this. Your doctor has to sign a letter and your doctor has to provide all of your medical records to prove you actually have this condition."
- Wheeler, B.: "Okay. And again, is there no preliminary numbers at all as far as who in the State of Illinois has been diagnosed with PTSD?"
- Lang: "It's possible that someone testified in the Senate on that, but there was no House testimony on that issue, Representative."
- Wheeler, B.: "Okay. Thank you very much. Thank you."
- Speaker Turner: "The Clerk... The Gentleman moves that the House nonconcur with Senate Amendments #3 and 4 to Senate Bill 33. All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Drury, Kifowit, Tryon. Mr. Clerk... Mr. Clerk, please take the record. On a count of 60 voting 'yes', 41 voting 'no' and 6 voting 'present', the House nonconcurs with... with Senate Amendments #3 and 4 to Senate Bill 33. And this Bill, having received the Constitutional Majority, is hereby declared passed. Representative Brown."
- Brown: "Thank you, Mr. Speaker. The Republicans request an immediate caucus in Room 118 for one hour."
- Speaker Turner: "The Republicans will caucus in Room 118. The Democrats will caucus in Room 114. And the House will recess
