Speaker Lang: "The House will be in order. Members will be in their chairs. The House will be in order. The House will be in order. They want financial security in their pensions for which they worked and were promised. They plead for freedom from fear of gun violence that plague our various neighborhoods. They want quality education for all students with resources being fairly shared across all districts. Some even long for the right to make decisions concerning their own bodies and not be bound by what government dictates. They want Legislators to be sensitive to the earth that has been given to our care. In short, they want compromise instead of confusion and conflict. As I stated, the concerns abound us. So, I pray, Oh Lord, that You will give this Body the depth of understanding that no individual Party, no Representative, man or woman, is not and unto themselves. Rather that everyone is their brother's keeper, their sister's keeper that we're all a part of the whole. Therefore, keep them from reaching decisions based on their own personal interests or political ambitions. Instead, lead them to choose the harder right instead of the easier wrong. equality. I know this because my parents taught me about equality that all of us were equal. Two years ago I lost my parents, a month apart. And my parents were born here. They were proud to be Mexican Americans. And I stand here today saying that I am a proud Mexican American as well. They were proud of their heritage and they came here to work hard. They weren't rapists; they weren't thieves; they were not drug dealers. It took a lot to raise 10 kids and send us all to Catholic schools, but they did it. People from Mexico come here looking for a better opportunity to fulfill the American dream. They're not thieves; they're not drug dealers; and they're not rapists. My dad worked hard all his life. He fought for this country in Korea. My family fought in the Vietnam War. My family fought in the Iraqi War. Why? Because a symbol of what their flag stands for, equality. If you go on the east side of Chicago, there's a wall and it has the names of individuals who gave up their lives in Vietnam. And if you count the names, there's more Mexican names than any other nationality that gave their lives in Vietnam in the State of Illinois. You talk about equality but yet in this day and age you still can't get rid of that nasty word, that nasty word called racism. I know most of you and some of you have suffered that who are standing here today, so you know how it feels. But yet today we have, in this day and age, the audacity of a man who wants to be the President of the United States, Donald Trump, who said people who come from Mexico are rapists, drug dealers, and thieves. So, I stand here today and congratulate NBC television and the craft breweries for standing with the Mexicans... the Mexican people. And I ask

Andre attended Arizona University and was drafted by the Philadelphia 76ers in the first round of the NBA draft in 2004. He spent time with the Denver Nuggets before joining the Golden State Warriors in 2013. During the 2015 NBA finals... now this is a big deal here, folks... Andre Iguodala averaged 16.3 points, 5.8 rebounds, 4 assists, and 1.4 steals per game. And in clinching the game, he collected 25.5 assists and 5 rebounds. Andre Iguodala was named the NBA finals Most Valuable Player, the first NBA champion and NBA finals MVP right here from Springfield, Illinois. Andre and his family started the Andre Iguodala Youth Foundation to promote athletics as a conduit to educational excellence. The organization sponsors numerous events each year that make a difference for Springfield youth and their families.
