- (D) In computing service for any of the purposes of this 22 23 Article, credit shall be given for any periods prior to January 9, 1997, during which an active fireman (or fire 24 25 paramedic) who is a member of the General Assembly is on leave of absence or is otherwise authorized to be absent from 26 enable him to perform his legislative duties, 27 duty to notwithstanding any reduction in salary for such periods and 28 notwithstanding that the contributions paid by the fireman 30 were based on such reduced salary rather than the full amount of salary attached to his civil service rank. 31

If payment is made during the 6-month 13 period that begins 3 months after the effective date of this 14 amendatory Act of the 92nd General Assembly, the required 15 16 interest shall be at the rate of 2.5% per year, compounded annually; otherwise, the required interest shall be 17 calculated at the rate of 6% per year, compounded annually. 18 19 (F) In computing service for any of the purposes of this Article, no credit shall be given for any period during which 20 a fireman was not rendering active service because of his 2.1 22 discharge from the service, unless proceedings to test the 23 legality of the discharge are filed in a court of competent jurisdiction within one year from the date of discharge and a 24 25 final judgment is entered therein declaring the discharge 26 illegal. No overtime or extra service shall be 27 included in computing service of a fireman and not more than one year or 28 a proper fractional part thereof of service shall be allowed 29
