

1 AN ACT concerning education.

2 Be it enacted by the People of the State of Illinois,  
3 represented in the General Assembly:

4 Section 5. The School Code is amended by adding Sections  
5 10-20.35 and 34-18.23 as follows:

6 (105 ILCS 5/10-20.35 new)

7 Sec. 10-20.35. Sale of student information prohibited.  
8 A school district may not sell, directly or indirectly, a  
9 student's name, address, telephone number, social security  
10 number, e-mail address, or other personal identifying  
11 information to a business organization or financial  
12 institution that issues credit or debit cards.

13 (105 ILCS 5/34-18.23 new)

14 Sec. 34-18.23. Sale of student information prohibited.  
15 The school district may not sell, directly or indirectly, a  
16 student's name, address, telephone number, social security  
17 number, e-mail address, or other personal identifying  
18 information to a business organization or financial  
19 institution that issues credit or debit cards.

20 Section 10. The University of Illinois Act is amended by  
21 adding Section 30 as follows:

22 (110 ILCS 305/30 new)

23 Sec. 30. Sale of student information prohibited. The  
24 University may not sell, directly or indirectly, a student's  
25 name, address, telephone number, social security number,  
26 e-mail address, or other personal identifying information to  
27 a business organization or financial institution that issues  
28 credit or debit cards.

1           Section 15. The Southern Illinois University Management  
2 Act is amended by adding Section 15 as follows:

3           (110 ILCS 520/15 new)

4           Sec. 15. Sale of student information prohibited. The  
5 University may not sell, directly or indirectly, a student's  
6 name, address, telephone number, social security number,  
7 e-mail address, or other personal identifying information to  
8 a business organization or financial institution that issues  
9 credit or debit cards.

10          Section 20. The Chicago State University Law is amended  
11 by adding Section 5-120 as follows:

12          (110 ILCS 660/5-120 new)

13          Sec. 5-120. Sale of student information prohibited. The  
14 University may not sell, directly or indirectly, a student's  
15 name, address, telephone number, social security number,  
16 e-mail address, or other personal identifying information to  
17 a business organization or financial institution that issues  
18 credit or debit cards.

19          Section 25. The Eastern Illinois University Law is  
20 amended by adding Section 10-120 as follows:

21          (110 ILCS 665/10-120 new)

22          Sec. 10-120. Sale of student information prohibited.  
23 The University may not sell, directly or indirectly, a  
24 student's name, address, telephone number, social security  
25 number, e-mail address, or other personal identifying  
26 information to a business organization or financial  
27 institution that issues credit or debit cards.

28          Section 30. The Governors State University Law is

1 amended by adding Section 15-120 as follows:

2 (110 ILCS 670/15-120 new)

3 Sec. 15-120. Sale of student information prohibited.  
4 The University may not sell, directly or indirectly, a  
5 student's name, address, telephone number, social security  
6 number, e-mail address, or other personal identifying  
7 information to a business organization or financial  
8 institution that issues credit or debit cards.

9 Section 35. The Illinois State University Law is amended  
10 by adding Section 20-125 as follows:

11 (110 ILCS 675/20-125 new)

12 Sec. 20-125. Sale of student information prohibited.  
13 The University may not sell, directly or indirectly, a  
14 student's name, address, telephone number, social security  
15 number, e-mail address, or other personal identifying  
16 information to a business organization or financial  
17 institution that issues credit or debit cards.

18 Section 40. The Northeastern Illinois University Law is  
19 amended by adding Section 25-120 as follows:

20 (110 ILCS 680/25-120 new)

21 Sec. 25-120. Sale of student information prohibited.  
22 The University may not sell, directly or indirectly, a  
23 student's name, address, telephone number, social security  
24 number, e-mail address, or other personal identifying  
25 information to a business organization or financial  
26 institution that issues credit or debit cards.

27 Section 45. The Northern Illinois University Law is  
28 amended by adding Section 30-130 as follows:

1 (110 ILCS 685/30-130 new)  
2 Sec. 30-130. Sale of student information prohibited.  
3 The University may not sell, directly or indirectly, a  
4 student's name, address, telephone number, social security  
5 number, e-mail address, or other personal identifying  
6 information to a business organization or financial  
7 institution that issues credit or debit cards.

8 Section 50. The Western Illinois University Law is  
9 amended by adding Section 35-125 as follows:

10 (110 ILCS 690/35-125 new)  
11 Sec. 35-125. Sale of student information prohibited.  
12 The University may not sell, directly or indirectly, a  
13 student's name, address, telephone number, social security  
14 number, e-mail address, or other personal identifying  
15 information to a business organization or financial  
16 institution that issues credit or debit cards.

17 Section 55. The Public Community College Act is amended  
18 by adding Section 3-60 as follows:

19 (110 ILCS 805/3-60 new)  
20 Sec. 3-60. Sale of student information prohibited. A  
21 community college may not sell, directly or indirectly, a  
22 student's name, address, telephone number, social security  
23 number, e-mail address, or other personal identifying  
24 information to a business organization or financial  
25 institution that issues credit or debit cards.

26 Section 99. Effective date. This Act takes effect upon  
27 becoming law.
