

1 AN ACT in relation to the Metropolitan Water Reclamation
2 District.

3 Be it enacted by the People of the State of Illinois,
4 represented in the General Assembly:

5 Section 5. The Metropolitan Water Reclamation District
6 Act is amended by changing Section 4.32 as follows:

7 (70 ILCS 2605/4.32) (from Ch. 42, par. 323.32)

8 Sec. 4.32. Veteran's preference.

9 (a) A person who served on active duty in the United
10 States Army, Navy, Air Force, Marine Corps, or Coast Guard
11 for a period of more than 180 consecutive days and was
12 honorable discharged from that service is entitled to a
13 veteran's preference under this Section.

14 For the purpose of this Section, "active duty" does not
15 include training or inactive duty performed as a member of
16 the National Guard or a Reserve component of the armed
17 forces.

18 (b) The Director of Personnel shall give preference for
19 an original or promotional appointment to a person qualifying
20 for a veteran's preference under this Section whose name
21 appears on an original or promotional eligible register by
22 adding 5 points to the final grade that the person receives
23 as the result of any original or promotional examination held
24 on or after the effective date of this amendatory Act of the
25 92nd General Assembly.

26 (c) The changes made to this Section by this amendatory
27 Act of the 92nd General Assembly are not intended to affect
28 any preference granted under this Section before the
29 effective date of this amendatory Act.

12 Conflict-ends-as-prescribed-by-Presidential--proclamation--or
13 order,-who-are-new-or-may-hereafter-be-on-inactive-or-reserve
14 duty--in--such--military--or--naval--servicee,--not-including,
15 however,-persons--who--were--convicted--by--court-martial--of
16 disobedience--of-orders,-where-sueh-disobedience-eonsisted-in
17 the-refusal-to-perform-military--servicee--on--the--ground--of
18 alleged--religious--or--conscientious-objections-against-war,
19 shall-be-preferred-for-appointments-to-offices,-positions-and
20 plaees--of--employment--in--the--classified--servicee--of--the
21 District,-provided-they-are-found--to--possess--the--business
22 capaeity--necessary-for-the-proper-discharge--of--the-duties--of
23 such-office,-position,-or-place-of-employment--as--determined
24 by---examination--for--original--entrance.--The--Director--of
25 Personnel--on--certifying--from--any--existing--register--of
26 eligibles--resulting--from--the-holding--of--an-examination--for
27 original-entrance-or-any-register--of--eligibles--that--may--be
28 hereafter--created--of--persons--who--have--taken--and--successfully
29 passed--the-examinations--provided--for--in--this--Act--for--original
30 entrance--commeneed--prior--to--September-1-, --1949,--shall--plaee
31 the-name--or--names--of--such--persons--at--the-head--of--any-existing
32 eligible--register--or--list--of--eligibles--that--shall--be--created
33 under--the--provisions--of--this--Act--to--be--certified--for
34 appointment.--The-Director--of--Personnel--shall--give--preference

1 for original appointment to persons as hereinabove designated
2 whose names appear on any register of eligibles resulting
3 from an examination for original entrance held under the
4 provisions of this Act and commenced on or after September 1,
5 1949 by adding to the final grade average which they received
6 or will receive as the result of any examination held for
7 original entrance, five points. The numerical result thus
8 attained shall be applied by the Director of Personnel in
9 determining the position of such persons on any eligible list
10 which has been created as the result of any examination for
11 original entrance commenced on or after September 1, 1949 for
12 purposes of preference in certification and appointment from
13 such eligible list.

14 Every certified Civil Service employee who was called to,
15 or who volunteered for the military or naval service of the
16 United States at any time during the years specified in this
17 Act, or at any time between September 16, 1940 and July 25,
18 1947 or any time during the national emergency between June
19 25, 1950 and January 31, 1955, or any time from August 5,
20 1964 until the date determined by Congress of the United
21 States as the end of Viet Nam hostilities, or at any time
22 between August 6, 1990 and the date the Persian Gulf conflict
23 ends as prescribed by Presidential proclamation or order, and
24 who were honorably discharged therefrom or who are now or who
25 may hereafter be on inactive or reserve duty in such military
26 or naval service, not including however persons who were
27 convicted by court martial of disobedience of orders where
28 such disobedience consisted in the refusal to perform
29 military service on the ground of alleged religious or
30 conscientious objections against war, and whose names appear
31 on existing promotional eligible registers or any promotional
32 eligible register that may hereafter be created, as provided
33 for by this Act, shall be preferred for promotional
34 appointment to civil offices, positions and places of

1 employment--in--the--classified-civil-service-of-the-District
2 coming-under-the-provisions-of-this-Act.

3 The-Director--of--Personnel--shall--give--preference--for
4 promotional--appointment-to-persons-as-hereinabove-designated
5 whose-names-appear-on-existing-promotional-eligible-registers
6 or-promotional--eligible--registers--that--may--hereafter--be
7 created--by--adding--to--the--final--grade-average--which--they
8 received-or-will-receive-as-the--result--of--any--promotional
9 examination--commencing---prior---to---September---1,---1949
10 three-fourths--of--one--point--for--each-6-months-or-fraction
11 thereof--of-military-or-naval-service-not-exceeding-48-months,
12 and-by-adding-to-the-final--grade--average--which--they--will
13 receive--as--the--result--of--any--promotional-examination-held
14 commencing-on-or-after-September-1,-1949-seven-tenths--of--one
15 point--for--each--6-months-or-fraction-thereof--of-military-or
16 naval-service-not-exceeding-30-months.--The-numerical--result
17 thus--attained--shall-be-applied-by-the-Director--of--Personnel
18 in-determining-the-position-of-such-persons-on--any--eligible
19 list--which-has-been-created-or-will-be-created-as-the-result
20 of-any-promotional-examination-held-hereunder-for-purposes--of
21 preference--in--certification--and--appointment---from--such
22 eligible-list.

23 No--person-shall-receive-the-preference--for-a-promotional
24 appointment-granted-by-this-Section-after-he-has-received-one
25 promotion-from-an-eligible-list-on-which-he-was-allowed--such
26 preference--and--which--was--prepared--as--a--result--of--an
27 examination-held-on-or-after-September-1,-1949.

28 No-person-entitled-to-preference-or-credit--for--military
29 or--naval--service--hereunder--shall--be--required-to-furnish
30 evidence--or--record--of--honorable--discharge--from--the--armed
31 forces--before--any--examination-held-under-the-provisions--of
32 this-Act-but--such-preference-shall-be-given-after-the-posting
33 or-publication--of--the-eligible-list--or--register--and--before
34 any--certification--or--appointments-are-made--from--the-eligible

1 register.
