- 2 Be it enacted by the People of the State of Illinois,

- 4 Section 5. The Unemployment Insurance Act is amended by
- 5 adding Section 500.1 as follows:
- 6 (820 ILCS 405/500.1 new)
- 7 <u>Sec. 500.1. Birth and Adoption Unemployment Insurance.</u>
- 8 (a) A parent who is on a leave of absence from his or
- 9 <u>her employer or who left employment to be with his or her</u>
- 10 <u>child during the child's first year of life</u>, or during the
- 11 first year following placement of a child age 18 or less with
- 12 the individual for adoption, may not be denied compensation
- on the grounds that he or she has voluntarily left

- 16 <u>has failed to actively seek work.</u>
- (b) As used in this Section:
