RE: Fall 2020 Waiver Report | Requests to Waive School Code Mandates

As required by Section 2-3.25g of the School Code [105 ILCS 5/2-3.25g], the following report provides summaries of requests for waivers of School Code mandates being transmitted to the Illinois General Assembly for its consideration. The report concludes with a database listing all the requests received, organized by Senate and House districts, including those requests for waivers and modifications acted on by the State Superintendent of Education in accordance with Section 1A-4 of the School Code [105 ILCS 5/1A-4] and applications that have been returned to school districts or other eligible applicants.

Pursuant to Section 2-3.25g (d) of the School Code [105 ILCS 5/2-3.25g (d)]:

The report shall be reviewed by a panel of four members consisting of:

- (1) the Speaker of the House of Representatives,
- (2) the Minority Leader of the House of Representatives,
- (3) the President of the Senate, and
- (4) the Minority Leader of the Senate.

The State Board of Education may provide the panel recommendations on waiver requests.

The members of the panel shall review the report submitted by the State Board of Education and submit to the State Board of Education any notice of further consideration to any waiver request

within 14 days after the member receives the report. If three or more of the panel members submit a notice of further consideration to any waiver request contained within the report, the State Board of Education shall submit the waiver request to the General Assembly for consideration. If fewer than three panel members submit a notice of further consideration to a waiver request, the waiver may be approved, denied, or modified by the State Board. If the State Board does not act on a waiver request within 10 days, then the waiver request is approved. If the waiver request is denied by the State Board, it shall submit the waiver request to the General Assembly for consideration.

The General Assembly may disapprove any waiver request submitted to the General Assembly pursuant to this subsection (d) in whole or in part within 60 calendar days after each house of the General Assembly next convenes after the waiver request is submitted by adoption of a resolution by a record vote of the majority of members elected in each house. If the General Assembly fails to disapprove any waiver request or appealed request within such 60-day period, the waiver or modification shall be deemed granted. Any resolution adopted by the General Assembly disapproving a report of the State Board in whole or in part shall be binding on the State Board.

Memoranda detailing the following shall be submitted to the Illinois State Board of Education by each panel member to effectuate the law:

- (1) Notice of specific waiver requests noticed for further consideration by the General Assembly; and
- (2) A statement indicating that all waiver requests included in the report, except for those listed above in (1), are returned to the State Board of Education for final action.

Executive Summary

The following report outlines waivers of School Code mandates that school districts, Regional Offices of Education, or special education or area vocational centers have requested since the last report, which was transmitted in February 2020. Pursuant to Section 2-3.25g of the School Code, these requests must be sent to the General Assembly before October 1, 2020.

Section I summarizes the 39 requests received for waivers of School Code mandates pursuant to Section 2-3.25g for consideration by the General Assembly. They are presented alphabetically by topic area. The largest number of applications received, 27, are regarding non-resident tuition. Both administrative cost cap limitations and driver's education received four requests each. There are three submissions regarding physical education, and one submission related to contracts.

This document contains an additional section beyond what is required under Section 2-3.25g of the School Code. Section II is a database with a list of the modifications or waivers of State Board of Education rules and modifications of School Code mandates upon which the State Superintendent of Education has acted in accordance with Section 1A-4 of the School Code. The database also includes a list of the requests that have been returned to or withdrawn by the petitioning entities. Finally, the database includes the 39 waiver requests for the General Assembly's consideration and is organized by Senate and House districts.

Complete copies of the waiver requests for the General Assembly's consideration have been made available to legislative staff.

This report is the 51st report submitted pursuant to Section 2-3.25g of the School Code, which requires that State Board of Education staff compile and submit requests for waivers of School Code mandates to the General Assembly before March 1 and October 1 of each year.

Section I Applications Transmitted to the General Assembly

Administrative Cost Cap Limitation

Pleasant Valley CUSD 62 – Peoria (SD46/92) / Expiration 2019-2020 school year / W-100-6764 – Waiver of School Code (Section 17-1.5) requests a waiver of the fiscal year 2020 Limitation of Administrative Costs. The district's FY 2020 budgeted administrative costs exceed the FY 2019 actual administrative costs by 83 percent.

The district employed an interim superintendent for the 2018-19 school year. The interim superintendent worked two days per week, received a salary comparable to the part-time status, but did not receive health insurance or TRS. The district employed a full-time superintendent starting with the 2019-20 school year, which provided the benefit of having the lead administrator in the district daily. The full-time superintendent receives a salary comparable to the full-time status, health insurance, and TRS. The FY 2020 budgeted costs for the full-time superintendent were \$100,000 for salary and \$19,111 for benefits, for a total of \$119,111. The FY 2019 actual costs for the interim superintendent were \$50,000 for salary. Moving from an interim superintendent to a full-time superintendent resulted in additional budgeted administrative expenditures of \$69,111 in FY 2020.

The change from an interim to a full-time superintendent caused the district to exceed the statutory allowable 5 percent increase. Without these additional costs, Pleasant Valley SD 62 would have been in compliance with the FY 2020 Limitation of Administrative Costs, experiencing a decrease in administrative costs of 19 percent.

Saunemin CCSD 438 – Livingston (SD53/HD106) / Expiration 2019-2020 school year / W-100-6773 – Waiver of School Code (Section 17-1.5) requests a waiver of the fiscal year 2020 Limitation of Administrative Costs. The district's FY 2020 budgeted administrative costs exceed the FY 2019 actual administrative costs by 90 percent.

Saunemin entered into a separation agreement with its superintendent to leave the district as of June 30, 2019. The separation agreement included a clause for the district to pay the departing superintendent during FY 2020 for the remainder of the original contract. The agreement included paying for salary as well as benefits. For the 2019-20 school year, the district hired a full-time superintendent who started with the district on August 1, 2019. An interim superintendent was used in July 2019 in order to have an administrator over the district and in August 2019 to aide in the transition for the new superintendent. The district budgeted \$126,164 to pay the settlement agreement for the former superintendent and \$15,343 to pay the interim superintendent, for a total of \$141,507 additional budgeted administrative expenditures in FY 2020.

The separation agreement payments to the previous superintendent and the need for an interim superintendent for transition to the new superintendent caused the district to exceed the statutory allowable 5% increase. Without these additional costs, Saunemin CCSD 438 would have been in

compliance with the FY 2020 Limitation of Administrative Costs, experiencing a 3 percent increase.

Waltham ESD 185 – LaSalle (SD38/HD76) / Expiration 2019-2020 school year / W-100-6762 – Waiver of School Code (Section 17-1.5) requests a waiver of the fiscal year 2020 Limitation of Administrative Costs. The district's FY 2020 budgeted administrative costs exceed the FY 2019 actual administrative costs by 51 percent.

During the 2018-19 school year, the district operated two school buildings. During that time, the superintendent also served as the K-2 building principal with another individual serving as the 3-8 building principal. The combined superintendent/principal salary and benefits were divided 65 percent for superintendent duties, an area reported on the Limitation of Administrative Costs Worksheet, and 35 percent for principal duties, an area not reported on the Limitation worksheet. The district opened a new elementary building for the 2019-20 school year to house all of their students. With all district students in one building, only one principal was needed, and the combined superintendent/principal position was changed to a superintendent-only position. The change from the combined superintendent/principal position to a superintendent-only position resulted in all of the superintendent's salary and benefits being reported on the Limitation worksheet, resulting in \$55,000 additional budgeted administrative expenditures in FY 2020.

The change from a combined superintendent/principal position to a superintendent-only position caused the district to exceed the statutory allowable 5 percent increase. Without these additional costs, Waltham CCSD 185 would have been in compliance with the FY 2020 Limitation of Administrative Costs, experiencing a 1 percent increase.

Windsor CUSD 1 – Shelby (SD51/HD102) / Expiration 2019-2020 school year / W-100-6759 – Waiver of School Code (Section 17-1.5) requests a waiver of the fiscal year 2020 Limitation of Administrative Costs. The district's FY 2020 budgeted administrative costs exceed the FY 2019 actual administrative costs by 14 percent.

During the 2018-19 school year, the superintendent also served as the Jr/Sr high building principal. The combined superintendent/principal salary was divided 70 percent for superintendent duties, an area reported on the Limitation of Administrative Costs Worksheet, and 30 percent for principal duties, an area not reported on the Limitation worksheet. In order to enable additional focus on student achievement and deploy resources to provide for all students, the district separated the combined role and hired a full-time Jr/Sr high principal starting with the 2019-20 school year. This change also allowed the now full-time superintendent to concentrate on the overall district. The change from a combined superintendent/principal to a separate superintendent and principal resulted in all of the superintendent's salary being reported on the Limitation worksheet, resulting in \$39,461 additional budgeted administrative expenditures in FY 2020.

The change from a combined superintendent/principal to a separate superintendent and principal caused the district to exceed the statutory allowable 5 percent increase. Without these additional costs, Windsor CUSD 1 would have been in compliance with the FY 2020 Limitation of Administrative Costs, experiencing a decrease in administrative costs of 18 percent.

Chicago Public Schools 299 – Cook (SD1/HD1) / Expiration 2025-2026 school year / W-100-6789R – Waiver of School Code (Section 34-21.3) requests to procure food services via RFP in lieu of bids.

Driver's Education

Community High School District 128 – Lake (SD30/HD59) / Expiration 2025-2026 school year / W-100-6799R – Waiver of School Code (Section 27-24.3) requests to allow use of 9 hours of simulators in lieu of 2.25 hours of behind-the-wheel instruction.

Rock Island Milan School District – Rock Island (SD36/HD72) / Expiration 2024-2025 school year / W-100-6781 – Waiver of School Code (Section 27-24.2) requests to increase the driver's education fee to not exceed \$300.00.

Rock Island Milan School District – Rock Island (SD36/HD72) / Expiration 2024-2025 school year / W-100-6782R – Waiver of School Code (Section 27-24.3) requests to utilize 12 hours of simulation in lieu of 3 hours of behind-the-wheel instruction.

South Beloit CUSD 320 – Winnebago (SD35/HD69) / Expiration 2024-2025 school year / W-100-6779R – Waiver of School Code (Section 27-24.2) requests to increase the driver's education fee to not exceed \$300.00.

Non-resident Tuition

Annawan CUSD 226 – Henry (SD37/HD74) / Expiration 2024-2025 school year / W-100-6780R – Waiver of School Code (Section 10-20.12a) requests to allow children of staff members that reside outside district boundaries to attend district schools free of charge.

Carrier Mills-Stonefort CUSD 2 – Saline (SD59/HD118) / Expiration 2024-2025 school year / W-100-6791R – Waiver of School Code (Section 10-20.12a) requests to allow non-resident children of full-time employees that live outside district boundaries to attend district schools free of charge.

Clay City CUSD 10 – Clay (SD55/HD109) / Expiration 2024-2025 school year / W-100-6751 – Waiver of School Code (Section 10-20.12a) requests to allow children of full-time employees to attend district schools free of charge.

Donovan CUSD 3 – Iroquois (SD53/HD106) / Expiration 2024-2025 school year / W-100-6768R – Waiver of School Code (Section 10-20.12a) requests to allow non-resident children of full-time

staff to attend the district tuition free. The district would claim the children on district enrollment count in lieu of tuition charge.

East Coloma Nelson CSD 20 – Whiteside (SD36/HD71) / Expiration 2024-2025 school year / W-100-6770 – Waiver of School Code (Section 10-20.12a) requests to allow students of full-time employees that live outside the district to attend free of charge.

Hall High School District 102 – Bureau (SD38/HD76) / Expiration 2024-2025 school year / W-100-6756 – Waiver of School Code (Section 10-20.12a) requests to charge tuition in an amount not exceeding 110 percent of the per capita cost of maintaining the schools of the district for non-resident children in the immediate family of Hall High School and Spring Valley Elementary staff members. It would be at the sole discretion of the Board of Education to annually set the tuition rate and approve applications of children wanting to attend Hall High School District 502 and Spring Valley CCSD 99. Transportation will not be provided for those residing 1.5 miles or more from the school.

Hillsboro CUSD 3 – Montgomery (SD48/HD95) / Expiration 2024-2025 school year / W-100-6786R – Waiver of School Code (Section 10-20.12a) requests to allow all non-resident pupils who are children of permanent district employees to attend the district tuition free.

Knoxville CUSD 202 – Knox (SD37/HD74) – Expiration 2020-2021 school year / W-100-6807.5 – Waiver of School Code (Section 10-20.12a) requests to waive non-resident tuition fees for children of district teachers that live outside the district.

Ladd CCSD 94 — Bureau (SD38/HD76) / Expiration 2024-2025 school year / W-100-6752 — Waiver of School Code (Section 10-20.12a) requests to allow the children of full-time employees to attend the district tuition free.

Lawrence County CUSD 20 – Lawrence (SD55/HD110) / Expiration 2024-2025 school year / W-100-6758R – Waiver of School Code (Section 10-20.12a) requests to allow students of non-resident full-time employees the opportunity to attend the district without paying tuition.

Oakland CUSD 5 – Coles (SD55/HD110) / Expiration 2024-2025 school year / W-100-6788 – Waiver of School Code (Section 10-20.12a) requests to allow children of full-time staff that live outside district boundaries to attend the district free of charge.

Oregon CUSD 220 – Ogle (SD45/HD90) / Expiration 2024-2025 school year / W-100-6761 – Waiver of School Code (Section 10-20.12a) requests to waive non-resident tuition costs for full-time employees to allow students of full-time certified and non-certified employees the opportunity to attend district schools without paying the non-resident tuition costs.

Pawnee CUSD 11 – Sangamon (SD50/HD99) / Expiration 2024-2025 school year / W-100-6772 – Waiver of School Code (Section 10-20.12a) requests to charge less than 110 percent of the per capita tuition charge for children of staff of the district that live outside of district boundaries.

Paxton-Buckley-Loda CUSD 10 – Ford (SD53/HD106) – Expiration 2020-2021 school year / W-100-6802 – Waiver of School Code (Section 10-20.12a) requests to allow children of certified staff that live outside the district boundaries to attend the district free of charge.

Pekin CHSD 303 - Tazewell (SD49/HD91) / Expiration 2024-2025 school year / W-100-6775 – Waiver of School Code (Section 10-20.12a) requests to allow students of full-time employees that live outside of district boundaries to attend free of charge.

Pleasant Hill SD 69 – Peoria (SD46/HD92) / Expiration 2024-2025 school year / W-100-6771 – Waiver of School Code (Section 10-20.12a) requests to allow students of staff and teachers that live outside the district boundaries to attend free of charge.

Prophetstown-Lyndon-Tampico CUSD 3 — Whiteside (SD36/HD71) / Expiration 2024-2025 school year / W-100-6792 — Waiver of School Code (Section 10-20.12a) requests to allow non-resident students whose parents are full-time employees of the district, to attend district schools free of charge. Applicable registration fees will apply.

Raccoon School District 1 – Marion (SD54/HD107) / Expiration 2025-2026 school year / W-100-6798R – Waiver of School Code (Section 10-20.12a) requests to allow non-resident children of school district employees to attend Raccoon Grade School free of charge.

Rankin SD 98 – Tazewell (SD46/HD91) / Expiration 2025-2026 school year / W-100-6793R – Waiver of School Code (Section 10-20.12a) requests to allow children of full-time teachers, administrators, and full-time (12 month) support staff not residing within district boundaries to attend Rankin SD 98 tuition free.

Selmaville CCSD 10 – Marion (SD54/HD107) / Expiration 2024-2025 school year / W-100-6795R – Waiver of School Code (Section 10-20.12a) requests to allow non-resident children of full-time employees to attend the district free of charge.

Shelbyville CUSD 4 – Shelby (SD51/HD102) / Expiration 2024-2025 school year / W-100-6787 – Waiver of School Code (Section 10-20.12a) requests to allow children of certified staff that live outside of district boundaries to attend the district free of charge.

South Pekin GSD 137 – Tazewell (SD49/HD91) / Expiration 2024-2025 school year / W-100-6783R – Waiver of School Code (Section 10-20.12a) requests to allow children of full-time teachers, administrators, and full-time support staff that live outside district boundaries to attend the district free of charge.

Spring Lake CCSD 606 – Tazewell (SD49/HD91) / Expiration 2024-2025 school year / W-100-6774R – Waiver of School Code (Section 10-20.12a) requests to set the tuition for non-resident pupils at a lower than per capita cost rate identified in the most recent audit.

Vienna High School District 13-3 – Johnson (SD59/HD118) / Expiration 2024-2025 school year / W-100-6807R – Waiver of School Code (Section 10-20.12a) requests to charge less than 110 percent of the per capita tuition charge for non-resident children of full-time and part-time employees of Vienna High School District 13-3 and also charge less than 110 percent of the per capita tuition charge for non-resident students of part-time and full-time employees that work at the District's feeder districts (Buncombe Elementary School District 43, Cypress Elementary School District 64, New Simpson Hill School District 32 and Vienna Public School District 55

Washington Grade School District 52 – Tazewell (SD44/HD88) / Expiration 2024-2025 school year / W-100-6785 – Waiver of School Code (Section 10-20.12a) requests to allow children of full-time employees that live outside the district boundaries to attend the district free of charge.

Wauconda CUSD 118 – Lake (SD31/HD62) / Expiration 2020-2021 school year / W-100-6796 – Waiver of School Code (Section 10-20.12a) requests to allow children of non-resident staff to attend the district free of charge. This waiver would assist staff who do not live within the district who have day care issues associated with area school districts implementing different educational programming during the 2020-21 school year in response to the Covid-19 pandemic. This may provide staff the option they need in order to return to work.

Woodlawn CUSD 5 – Livingston (SD53/HD106) / Expiration 2024-2025 school year / W-100-6776 – Waiver of School Code (Section 10-20.12a) requests to allow students of full-time employees that live outside district boundaries to attend free of charge.

Physical Education

Fenton CHSD 100 – DuPage (SD39/HD77) / Expiration 2024-2025 school year / W-100-6769 – Waiver of School Code (Section 27-6) requests to allow students in grades 10, 11, and 12 to substitute one semester of Driver's Education for one semester of physical education.

Manteno CUSD 5 – Kankakee (SD17/HD34) / Expiration 2024-2025 school year / W-100-6753 – Waiver of School Code (Section 27-6) requests to waive the physical education requirement for show choir students in grades 11 and 12 beginning in January 2021.

Oswego CUS D308 – Kendall (SD49/HD97) / Expiration 2024-2025 school year / W-100-6790 – Waiver of School Code (Section 27-6) requests to allow students in grades 9-12 who are active participants in Show Choir to be exempt from the state mandated physical education requirement. Students eligible for this waiver have a minimum of three rigorous practice sessions per week (total of 7.5-10 hours) and this would allow them to schedule a study hall. The waiver would only be applicable in the spring semester.

Section II Waiver and Modification Database

Requests received during this waiver cycle are presented numerically by Senate and House district and then alphabetically by school district or eligible applicant. The "action" to be taken for each request is noted; that is, request for waivers upon which the General Assembly must act are noted as "Transmitted to GA"; modifications already acted upon by the State Superintendent of Education in accordance with Section 1A-4 of the School Code are noted as "ISBE Approved" or "ISBE Denied"; and requests that were returned for one or more of the following reasons are noted as one of the following: "Returned," "Ineligible," "NWN" (no waiver needed), or "Withdrawn."
