Pursuant to Public Act 87-552, please find below the report for the Illinois Liquor Control Commission. If you have any questions on the information provided in the Sections below, please contact Monica Pullett, ILCC Human Resources Specialist, at 217-843-1298.

Section 1

The mission of the Illinois Liquor Control Commission regarding Public Act 87-552 is to be flexible in the assignment of work schedules for ILCC employees to an extent that does not impede the Commission from performing its statutory responsibilities in a professional and expedient manner.

Section 2

Monica Pullett, Human Resources Specialist of the Illinois Liquor Control Commission, is responsible for implementing the Department's plan for flexible work schedules.

Section 3

The Commission currently has over 600 different work schedules that offer a variety of start and end times. In addition, the Commission offers four-day and nine-day work schedules. We currently do not have any employees on a flexible work schedule (adjusting their start or end times). We do have 11 employees, who work an alternate work schedule (four-day or nine-day work schedule). The Commission currently does not have any employees in a part-time status. Please note that employees are on flexible work schedules and alternative work schedules for a variety of reasons.

Section 4

At this time the Commission does not expect to expand on current programs.

## Section 5

The Commission can open a nursing mothers' suite. This suite will be private and locked at all time. Based on Hybrid model learning with schools, staff can request ability to work remotely from home periodically.
