The First Stop Business Information Center (First Stop) completed its 27th year providing small businesses and business startups with comprehensive information on business licenses, permits and government regulations, while also linking them to available programs and resources to help them succeed.

As Illinois' entrepreneurs and small businesses struggled with challenges and hardships caused by the global coronavirus pandemic, the First Stop Business Information Center, with assistance from department staff volunteers, took on the new responsibility of providing Illinois' COVID-19 business assistance helpline. As a result, First Stop requests for assistance increased nearly 1,800 percent in 2020.





Business Specialists:

At the core of First Stop's services is the professional staff that handles the thousands of inquiries that come in via the toll-free business helpline, email, standard mail and walk-ins. When a business encounters difficulty with the state regulatory process, the business specialist facilitates communication between small

businesses and State agencies. First Stop staff provides expert guidance in linking pre-business ventures and existing business owners to federal, state, and local government resources. Business specialists help dispel the common perception that government is inaccessible to small businesses. Services for Underserved Communities:

Striving to ensure equitable assistance and opportunities for success for Illinois' underserved communities, First Stop has provided a bilingual business specialist for our Spanish-speaking entrepreneurs for the past seventeen years. First Stop continues to provide its most popular publications, such as the <u>Starting Your Business in Illinois</u> handbook in Spanish and links clients to <u>DCEO's Office of Minority Economic Empowerment (OMEE)</u> for additional resources and targeted services

Oracle Service Cloud Self-service Tool:

To better serve its clients, First Stop uses Oracle Service Cloud to house its comprehensive database of more than 630 business related questions and answers known as the KnowledgeBase System (KBS). This system allows entrepreneurs and small business owners to access the same business permit, license, certification and business assistance program information as our call center on a self-serve basis and can be found on the First Stop website.

Training Opportunities:
