RE: Law Enforcement Camera Grant Act

Pursuant to the "Reporting" sections of the **Law Enforcement Officer-Worn Body Camera Act (50 ILCS 706/10-25)** and the **Law Enforcement Camera Grant Act (50 ILCS 707/15, 20)**, the Athens Police Department report the following:

- 1) The Athens Police Department received three (3) in-car cameras in 2019.
- 2) All three of these cameras were installed in Athens Police Department patrol vehicles.
- 3) Supervisors review each report an officer submits, and reviews video evidence as needed from each individual case.
- 4) The cameras were used to review evidence relating to citizens complaints on two occurrences, both which exonerated the officer of any wrongdoing.
