## **Review of Existing Data Reporting Mandates Pursuant to House Resolution 0014**

#### **House Resolution 0014**

The Illinois State Board of Education (ISBE) is urged to submit a report to the General Assembly by December 31, 2021, with information on the reviewed areas and recommendations on how to streamline the school data reporting and collecting systems of the State of Illinois.

#### Context

ISBE supports more than 200 software applications that were created in response to state and federal requirements for data collection and reporting. ISBE is proactive in efforts to avoid duplicative data collection in order to lessen the burden on each Local Education Agency (LEA). LEA-facing ISBE software applications utilize a single sign-on, centralized security portal. The ISBE Web Application Security (IWAS) system maintains a user profile to prevent unnecessary or repetitive input of information.

The Student Information System (SIS) captures demographic, enrollment, program indicators, and assessment data for all students. SIS has absorbed multiple outdated systems which has resulted in a more efficient and centralized reporting structure for LEAs.

Our review included the following data collection systems, which are the significant public school student and teacher data collections:

- 1. Bilingual Education Program Delivery Report (PDR) Collection
- 2. Employment Information System (EIS) including Unfilled Positions Survey
- 3. Entity Profile System (EPS)
- 4. Non-Certified Staff Salary Study
- 5. Reduction In Force (RIF) Survey
- 6. Student Health (Dental, Eye, Immunizations and Physical Fitness)
- 7. Student Information System (SIS)
- 8. Teacher Salary Study
- 9. Title I Comparability
- 10. US Census SDRP
- 11. Year End Collection (YEC)

#### **Analysis**

Overall, we found nine redundancies (see Table 1). In those instances, multiple data collection is necessary to link data across data collection systems. For example:

- Illinois Educator Identification Number (IEIN) and Teacher Position are entered in EIS and SIS in order to link students and teachers.
- District Superintendent Name and District Superintendent email are entered in EIS and EPS for consumers of our data to find contact information for both an entity and an individual.
- o ISBE's Entity Profile System (EPS) is another illustrative example. The EPS application

is the sole source for data about all entities that do business with ISBE. When notified of a new entity, ISBE creates a new entity record in EPS that stores key information that includes entity name, address, and contact phone number. This new entity is also given a unique Entity ID. As that entity utilizes any number of our agency applications, the Entity ID will be used to uniquely identify them as the ones providing the data. In addition, information like entity name and address may also appear within the application. While the Entity ID may need to be provided or passed from our web security module known as IWAS, the additional information is derived from it and presented as informational only (not requiring entry). This could be perceived as duplicative data but in reality, the data is inferred through the linking of the key field value known as the Entity ID.

#### Recommendations

ISBE continues to be consistent and vigilant in eliminating redundant or duplicative data collections by merging applications/systems and providing users with a centralized location to input data. Because ISBE has more than 200 data collection systems, ISBE would need to
