Pursuant to the requirements of Section 25 of the Personal Information Protection Act, Lutheran Social Services of Illinois submits this report of a breach of written material. Lutheran Social Services of Illinois is a private organization under contract with DCFS to provide child welfare services, and has signed business associate agreements with the Department.

On February 5, 2019, a Lutheran Social Services of Illinois worker inadvertently sent an email regarding a specialty consultation referral containing the personal information of one individual who, with their family, is DCFS involved to employees on a distribution list of another state agency, who are not entitled to view the information. The parties who received this email in error through the incorrect distribution list were asked to delete this information and to disregard the email. The email contained the name, mental health, and medical information of the DCFS involved client. The total number of individuals involved in this breach is three.
