


- Troy mentioned resident occupancy dates for DOM (Sep-Oct 2023) and LTC (Early 2024) VUC can confirm.
- Recognition Survey input:
 - Jennifer Hoard leads the State Home Per-Diem Program for Pod #3 (national VA region). She shared that:
 - o IVHQ can only ask for Recognition for beds ready to be fully operational.
 - o Beds not certified for occupancy by local and state officials cannot be requested for.
 - Will send out notes related to the process of kicking off the Request for Recognition.
 - o John Broderick will oversee Per-Diem after Recognition.
- Prep for surveys:

- Jennifer suggested being prepared by conducting internal 'mock reviews' and all internal-tostate inspections because the FED Recognition surveys are PASS-FAIL.
- USDVA is busy and re-surveys could take time to schedule.
- The usual survey scheduling lead times are roughly 6-8 weeks.
- The typical surveys take 2-3 days on site.
- Phased occupancy:
 - o (DOM only) Recognition or (DOM + Partial LTC) Recognition are both possibilities.
 - * **BUT*** VUC needs to be sure of clear lines of separation for construction and occupied areas, operational separations etc. That is an area of real concern.
 - Ramu and Josh shared images to help Jennifer understand the request for phased Recognition Surveys. Jennifer will consider. Image snipper shared below.
 - o Kitchen does not receive per-diem for its operation in itself, will not be slated for a Recognition Survey.
- Pass-Fail and date to receive per-dem
 - The date to receive per-diem is set to the date of last successful survey pass. Failed surveys cannot be used to retroactively ask for per-diem.
- State Home grant input
 - Demetrius Bussey is Grant Coordinator for Illinois working with Liz Yo. Encouraged a first payment application asap.
 - Suggested that there should be no major deviations from accepted and funded scope.
 - Chris I am sure you kept notes of Demetrius input. Will trust that you would add those on your own.
