MEMORANDUM TO THE HONORABLE MEMBERS OF THE 103rd GENERAL ASSEMBLY

SUBJECT: Public Act 102-0721 Illinois Business Preference Report – FY23

The Illinois Department of Transportation (IDOT) has prepared an annual report identifying Illinois businesses procured by the agency for construction services on Illinois-based projects in accordance with Public Act 102-0721, which went into effect on January 1, 2023.

The legislation requires the report to be submitted by September 1 of each year; therefore, a copy of the first report is enclosed for your use.

Typically, IDOT administers seven scheduled bid lettings per year with approximately 70% of the advertised projects involving Federal-aid funding. All non-Federal aid projects advertised by IDOT after January 1, 2023 included a bid preference for Illinois businesses in accordance with Public Act 102-0721.

Please note that the shortened time period between the effective date of January 1, 2023 and the report submittal date of September 1 did not allow a full year of data collection, however, all future annual reports will include data covering the full fiscal year.

The Department continues to work to expand competition in the industry through advertisements that promote awareness of State contracting opportunities to Illinois businesses to grow their revenue, which in turn, spurs economic growth and job creation throughout Illinois.
