50 ILCS 706/10/25 (Law Enforcement Officer-Worn Body Camera Reporting)

Each law enforcement agency receiving a grant for officer-worn body cameras under Section 10 of this Act must provide an annual report to the Board, the Governor, and the General Assembly on or before May 1 of the year following the receipt of the grant and by each May 1 thereafter during the period of the grant. The report shall include:

- (a)(1): a brief overview of the makeup of the agency, including the number of officers utilizing officer-worn body cameras; **(39 sworn personnel)***
- (a)(2): the number of officer-worn body cameras utilized by the law enforcement agency; **(39)***
- (a)(3): any technical issues with the equipment and how those issues were remedied; **(We had a downloading / charging strip go bad – lost 10 days of video at the end of the year – ordering new equipment)***
- (a)(4): a brief description of the review process used by supervisors within the law enforcement agency; **(During use of force, citizen complaint review/investigations, and for officer training and evaluation purposes)***
- (a)(6): any other information relevant to the administration of the program - **Nothing***
