Dear ILESTB Board Members:

I am providing you with the attached annual report for an in-car video camera grant our agency received in 2018. Our agency received funding for one camera which was installed in Squad 21.

As Deputy Chief Kevin Keegan has relayed to you in the past, every month a sergeant must complete an evaluation of each officer assigned to their respective shift. As part of the evaluation process, the sergeant must review at a minimum three in-car videos from the officer's assigned squad car. Upon completion of the evaluation, it is reviewed by the officer, signed, and forwarded to command staff for further review. Any areas of concern are properly addressed with training, a conversation for record or discipline. The in-squad camera proves to be a valuable tool for our agency. Please let us know if you require more information than what is attached.

I also want to take this opportunity to update you on two items,

- (i) Deputy Chief Keegan has retired from the Frankfort Police Department. If you need to reach out to us, please contact me at the below email address or at 815-469-9435.
- (ii) The Frankfort Police Department will be replacing all in-car dashcams that will work in tandem with our Body Worn Cameras, beginning May 1, 2024. Therefore, we will no longer be providing an update on this camera. How would you like us to handle the disposition of the camera?

On behalf of the Frankfort Police Department, I want to thank the board members of the ILESTB for their continued support of our agency, and the approval of this grant. This camera has served our community well for the last six years.
