This report is issued pursuant to the provisions of Section 20-15(a) of the Data Governance and Organization to Support Equity and Racial Justice Act (“the Act”) (20 ILCS 65/20-1). The Act requires the Illinois State Board of Education (ISBE) to report statistical data on the racial, ethnic, age, sex, disability status, sexual orientation, gender identity, and primary or preferred language demographics of program participants for each major program the ISBE administers.

Introduction

In the Data Governance and Organization to Support Equity and Racial Justice Act Report that was first submitted in March, ISBE identified the following “major programs” and corresponding participant populations for analysis:

For each major program identified in the ISBE March 2024 report, this report will provide statistical data where available for each of the demographic dispositions enumerated in the Act: race, age, sex, disability status, sexual orientation, gender identity and primary or preferred language.

ISBE assessed currently catalogued demographic data for each of the aforementioned programs. The agency made an initial assessment and determined that the following demographic categories have been defined and standardized across all “major programs” identified in this report:

- Race/ethnicity
- Age
- Disability status
- Gender (includes gender identity)
- Primary or preferred language

As of the date of this report, ISBE was unable to begin reporting the following data: Sex and Sexual Orientation. As of June 30, 2023, per 20 ILCS 65/20-15(a-5), “In relation to major program participants, the Board shall not be required to collect personally identifiable information and report statistical data on the categories of sex, sexual orientation, and gender identity unless required for federal reporting.”

ISBE will, to the extent that such methods are deemed feasible and safe, make reports available on its [Submitted Mandated Reports webpage](#) of statistical data on sex, sexual orientation, and gender identity demographics collected through anonymous surveys or other methods as age and developmentally appropriate. At this time, no such methods have been identified.

Change Management Efforts and Potential Challenges

The agency will continue to consult with LGBTQ+ advocates, educators, families, and students from across the state to discuss potential ways to ensure that data for the exempted demographic categories are collected with the safety and privacy of all students in mind. Currently, the statewide climate survey is not a viable method due to its use in the state’s accountability system.

Methodology

The information contained in this report is based solely on the data reported by program participants and collected by programming personnel for the various major programs. The data provided by program participants has not been audited for completeness and quality; therefore, no baseline for comparison has been established.

For this report, program participants are defined as all students enrolled on October 1, 2022, in each program. The program participants count is the number of distinct individuals who have been identified as program participants regardless of demographic category.

Participant information and demographics were collected using the Student Information System and the IEP-Student Tracking and Reporting System. Participants were included in the distinct head count if they were enrolled on October 1, 2022, and if their information was entered into the system by release date of the Report Card Snapshot. The data used for this report is similar to the data used for the Illinois Report Card. Although data for October 1, 2022, was pulled on June 11, 2024, the data was partially frozen in time on March 28, 2023. Following this date, there have been periodic updates related to the Illinois Report Card. The final snapshot was taken on September 28, 2023. Participant counts are unique head counts, according to Fall Enrollment business rules.

Race and Ethnicity

The Act provides that ISBE “shall use the same racial and ethnic classifications for each program” (20 ILCS 65/20-15(a)). The enumerated classifications are:

- (1) American Indian and Alaska Native alone.
- (2) Asian alone.
- (3) Black or African American alone.
- (4) Hispanic or Latino of any race.
- (5) Native Hawaiian and Other Pacific Islander alone.
- (6) White alone.
- (7) Middle Eastern or North African.
- (8) Some other race alone.
- (9) Two or more races.

The Act also allows for ISBE to “further define the racial and ethnic categories[.]” *Id.*

The agency defines the category “(8) Some other race alone” as “Unknown.” In addition to the aforementioned racial categories, the agency also uses the category “Hispanic.”

The Act further states that

If a program administered by the Board or the Department is subject to federal reporting requirements that include the collection and public reporting of statistical data on the racial and ethnic demographics of program participants, the Department may maintain the same racial and ethnic classifications used under the federal requirements if such classifications differ from the classifications listed in subsection (a).

(20 ILCS 65/20-15(b)).
