Departmental Report to the Honorable Members of the Illinois General Assembly Concerning the Death or Serious Life-Threatening Injury of a Child

This report is being submitted by the Department of Children and Family Services pursuant to the Abused and Neglected Child Reporting Act, 325 ILCS 5/4.2 (ACT).

The Act directs the Department to notify the President of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives, and the members of the Senate and the House of Representatives on the occurrences of death or serious life-threatening injury of a child whose care, custody and/or guardianship has been transferred to the Department OR in the case of a child abuse or neglect report made to the State Central Register (SCR) involving the death of a child.

The following allegations are included in this report: 1 – Death, 2 – Head Injuries, 4 – Internal Injuries, 5 – Burns, 7 – Wounds, 9 – Bone Fractures, 16 – Torture, 51 – Death by Neglect, 52 – Head Injuries by Neglect, 55 – Burns by Neglect, 57 – Wounds by Neglect, 59 – Bone Fractures by Neglect, 79 – Medical Neglect, 81 – Failure to Thrive and 83 – Malnutrition. Of those, only allegations resulting in a twenty (20) or fifty (50) years retention period were included. This report also includes all reports made to SCR/DCFS Hotline involving the death of a child, categorized as 1 – Death or 51 – Death by Neglect.
