#### **SENATE RESOLUTION NO. 8**

WHEREAS, Many Illinois citizens are experiencing high rates of illnesses such as heart disease, stroke, diabetes, and cancer; these conditions are often linked to excessive sugar consumption; and

WHEREAS, It is predicted that by the year 2020, diabetes will increase in Illinois by an estimated 25%; and

WHEREAS, Sugary drinks are a main source of empty, dangerous calories; a diet high in sugar contributes to weight gain, which increases the risk for developing type 2 diabetes; and

WHEREAS, The American Heart Association promotes going sugarless for one day a week in order to promote a healthier lifestyle; and

WHEREAS, Sugarless does not mean sugar-free; it means no sugary drinks such as soda and artificial fruit juice, and a reduction in the consumption of sugary desserts and snacks; and

WHEREAS, The American Heart Association created "Sugarless Wednesdays" in order to inform and educate communities on healthy alternatives, the health risks associated with excessive consumption of sugary drinks, and the benefits of one sugarless day per week; and

WHEREAS, The American Heart Association asks Illinois to join them by participating in "Sugarless Wednesdays", and to take the pledge to "Do My Best to Go Sugarless"; and

WHEREAS, The American Heart Association urges people to tell friends, family, and loved ones about "Sugarless Wednesdays" and the benefits that going sugarless one day a week can have; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate each Wednesday in the month of February of 2017 as a "Sugarless Wednesday" in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the American Heart Association in appreciation of its work to promote a healthier Illinois.

Senator McGuire offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### **SENATE RESOLUTION NO. 18**

WHEREAS, An omphalocele is a birth defect that occurs early in pregnancy in which the abdominal wall does not close properly and some or most of the abdominal organs protrude into the umbilical cord; and

WHEREAS, It is estimated that a small omphalocele occurs in about one out of every 5,000 pregnancies and a large or giant omphalocele occurs in about one out of every 10,000 pregnancies; and

WHEREAS, An omphalocele may be isolated or may be associated with other defects or chromosomal abnormalities; and

WHEREAS, Despite the challenges a baby born with an omphalocele may face, many babies who are born with an omphalocele survive and go on to live happy, healthy lives; and

WHEREAS, Mothers of Omphaloceles (MOO) is a group of over 2,000 parents from around the world that was created to provide hope and information to families with babies diagnosed with an omphalocele; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize Mothers of Omphaloceles for their courageous efforts to

advocate for their children and raise awareness that an omphalocele is a treatable condition; and be it further

RESOLVED, That we recognize International Omphalocele Awareness Day celebrated annually on January 31 as part of Birth Defects Prevention Month; and be it further

RESOLVED, That we declare January 31, 2017 as Omphalocele Awareness Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Mothers of Omphaloceles as an expression of our respect and esteem.

Senator McCarter offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### SENATE JOINT RESOLUTION NO. 1

WHEREAS, The first President of the United States, George Washington, stated in his Farewell Address: "The basis of our political systems is the right of the people to make and to alter their Constitutions of Government."; and

WHEREAS, 25% of Congress has been in office for more than 16 years; by the end of 2016, 9 members will have been in office for more than 40 years; and

WHEREAS, Term limits would reverse this trend by ensuring that open-seat races are held on a regular basis; the best and brightest minds in our states, who are currently blocked from serving in Congress by tenured politicians, would finally have the opportunity to move upward and make their case to the American people; and

WHEREAS, Term limits also address the top-down power structure in Washington by allowing for less senior members to hold leadership roles; this means Congress will not only get an infusion of new talent but that all of its members will be empowered to make a difference; and

WHEREAS, Article V of the United States Constitution requires the United States Congress to call a convention for proposing amendments upon application of two-thirds of the legislatures of the several states for the purpose of proposing amendments to the United States Constitution; and

WHEREAS, The State of Illinois sees the need for a convention to propose amendments to set a limit on the number of terms that a person may be elected as a Member of the United States House of Representatives and to set a limit on the number of terms that a person may be elected as a Member of the United States Senate, or for a substantially similar purpose, and desires that the convention should be so limited; and

WHEREAS, The State of Illinois desires that the delegates to the convention shall be comprised equally from individuals currently elected to State and local office, or be selected by election in each Congressional district for the purpose of serving as delegates, though all individuals elected or appointed to federal office, now or in the past, be prohibited from serving as delegates to the Convention, and intends to retain the ability to restrict or expand the power of its delegates within the limits expressed above; and

WHEREAS, The State of Illinois intends that this be a continuing application, considered together with applications from other States to Congress, to call a convention to set a limit on the number of terms that a person may be elected to the House of Representatives of the Congress of the United States and the Senate of the United States; and this application shall be aggregated with same for the purpose of attaining the two-thirds of states necessary to require Congress to call a limited convention on this subject but shall not be aggregated with any other applications on any other subject; and

WHEREAS, This application constitutes a continuing application in accordance with Article V of the Constitution of the United States of America until the legislatures of at least two-thirds of the several states have made applications on the same subject; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we, the legislature of the State of Illinois, hereby make application to the Congress, under the provisions of Article V of the Constitution of the United States, for the calling of a convention for proposing amendments; and be it further

RESOLVED, That this application shall be deemed an application for a convention to address each and any of the subjects listed in this resolution; for purposes of determining whether two-thirds of the states have applied for a convention addressing any subject, this application is to be aggregated with the applications of any other state legislatures limited to one or more of the subjects listed in this resolution; and be it further

RESOLVED, That this resolution constitutes a continuing application and remains in effect until rescission by any sitting session of the legislature of this State; this application does not constitute a recognition that any particular activity or activities currently undertaken by the federal government is or are authorized by the Constitution; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President and Secretary of the United States Senate, the Speaker and Clerk of the House of Representatives of the United States Congress, and the Archivist of the United States; to the members of the United States Senate and House of Representatives from this State; and to the presiding officers of each of the legislative chambers in the several States, requesting their cooperation.

Senator Haine offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### SENATE JOINT RESOLUTION NO. 2

WHEREAS, The members of the Illinois General Assembly are proud to honor those who have given their lives to the defense of our nation; and

WHEREAS, Lance Cpl. Richard Charles "Ricky" Bennett was born on August 1, 1947 in Detroit, Michigan; his parents were Edwin and June Bennett; he and his family moved to Wood River when he was in grade school; after graduating from East Alton-Wood River High School, he enlisted in the United States Marine Corps; he passed away on August 10, 1967 from injuries suffered by enemy explosion fragments while on water detail in Thua Thien; and

WHEREAS, Lance Cpl. Chris A. Totora was born on October 7, 1948 at Alton Memorial Hospital in Alton; his parents were Anthony and Rosemary Totora; he was raised in Wood River and attended East Alton-Wood River High School, where he was active in football and wrestling and graduated in 1966; he joined the United States Marine Corps in August of 1966 and underwent Basic Training at Camp Pendleton in California; he passed away on October 25, 1967 in Danang from injuries sustained after an explosion while on patrol in the Quang Nam Province; and

WHEREAS, PFC Jim Stassi also attended East Alton-Wood River Community High School and enlisted in the Marines following his graduation in 1965; he was killed on June 27, 1967 in South Vietnam from injuries suffered by an enemy landmine; he was 19 years old; and

WHEREAS, It is fitting and proper to pay tribute to these courageous men and their great sacrifice in the name of liberty; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we

designate the portion of Illinois Route 143 from the Phoebe Goldberg Overpass to Sixth Street as the "Lance Cpl. Chris Totora Memorial Highway"; and be it further

RESOLVED, That we designate the portion of Illinois Route 143 from Sixth Street to East Edwardsville Road as the "USMC Lance Cpl. Richard Bennett Memorial Highway"; and be it further

RESOLVED, That we designate the portion of Illinois Route 143 from East Edwardsville Road to the I-255 overpass as the "PFC Jim Stassi Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of these names; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Secretary of the Illinois Department of Transportation and the families of Lance Cpl. Richard Bennett, Lance Cpl. Chris Totora, and PFC Jim Stassi.

WHEREAS, Officer Snyder was a freelance graphic designer before becoming a police officer; he also served on the board of directors at Riverbend Family Ministries; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate McAdams/River Road as it passes through the Village of Godfrey as the "Officer Blake Snyder Memorial Road"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name "Officer Blake Snyder Memorial Road"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Officer Snyder and Godfrey Mayor Michael J. McCormick.

WHEREAS, Upon his retirement, Thomas Boyle served as a Law Enforcement Professional for the Criminal Investigations Department of the Department of Defense, where he trained police in Kosovo, Iraq, and Afghanistan; and

WHEREAS, Thomas Boyle was awarded the Defense Medal of Freedom and the Civilian Commander's award for the investigation and prosecution of eight terrorist bomb makers in Iraq; and

WHEREAS, Thomas Boyle was killed in a firefight on June 18, 2012 while serving in Afghanistan; and

WHEREAS, Thomas Boyle was survived by his wife of 35 years, Pauline, and his son, Ryan; therefore, be it
