Senator Hutchinson offered the following Senate Resolution, which was referred to the Committee on Assignments:

**SENATE RESOLUTION NO. 117**

WHEREAS, The future of our nation's productivity and competitiveness in the global marketplace depends on the success of all men and women; and

WHEREAS, Women have been discriminated against in education, the workplace, and society as a whole; and

WHEREAS, Women continue to earn no more than 80 cents on the dollar compared to men; and

WHEREAS, The wage gap is even greater for most women of color; African American Women earn 63 cents on the dollar and Latina Women earn 54 cents on the dollar; and

WHEREAS, The pay gap has been shown to start as soon as one year after college; this inequality affects not only women, but their families and society as a whole; and

WHEREAS, The pay gap between women and men has long-term effects on women's economic security; such a gap affects women's Social Security earnings, their ability to save for retirement, and their children's education; and

WHEREAS, Pay equity is closely linked to the eradication of poverty and is essential to having a highly-motivated workforce; and

WHEREAS, Equal Pay Day was originated by the National Committee on Pay Equity in 1996 as a public awareness event to illustrate the gap between men's and women's wages; the day, observed in April, symbolizes how far into the year a woman must work, on average, to earn as much as a man earned the previous year, with Tuesday being the day in which women's wages catch up to men's wages from the previous week; because women earn less on average than men, they must work longer for the same amount of pay; this wage gap is even greater for most women of color; and

WHEREAS, Equal pay is a priority for all women and for our society at large; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRETH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate April 4, 2017 as Pay Equity Day in the State of Illinois in order to raise awareness about this endemic inequity.

Senator Castro offered the following Senate Resolution, which was referred to the Committee on Assignments:

**SENATE RESOLUTION NO. 118**

WHEREAS, Since the late 1990s, the installation and use of indoor and outdoor artificial turf fields with crumb rubber infill has grown exponentially across the United States and particularly in Illinois; and

WHEREAS, The costs to install artificial turf fields with crumb rubber range from \$500,000 to well over one million dollars with a useful life of six to 12 years depending on usage and maintenance; maintenance costs which include disinfecting are around \$100,000 annually; and

WHEREAS, The installation of artificial turf fields with crumb rubber infill is largely paid for by taxpayer dollars; a typical artificial turf field uses between 20,000 to 40,000 ground up car and truck tires for its crumb rubber infill; the crumb rubber industry came out of an effort to figure out how to dispose of millions of used tires that were considered too toxic to dump into landfills; and

WHEREAS, On October 8, 2014, NBC News aired a national report, "How Safe is the Artificial Turf Your Child Plays On?" that brought the issue of crumb rubber into the national consciousness; Amy Griffin, the former United States women's national team goalkeeper coach at the University of Washington, compiled a list that now contains the names of over 230 athletes, most of whom are soccer players, particularly goalies, that have been stricken with cancer due to repeated contact with crumb rubber; since that NBC report, there have been many other reports across the United States and Europe about the safety of crumb rubber, particularly for young children; and

WHEREAS, Today, children as young as 18-months are playing sports, particularly soccer, on crumb rubber artificial turf fields; more and more children are playing sports on these fields with the presumption that the fields are safe; children can be exposed to highly toxic crumb rubber substances through inhalation, skin absorption, and accidental ingestion; and

WHEREAS, The scientific name for crumb rubber is styrene-butadiene rubber (SBR), and according to OSHA, chronic exposure to both styrene and butadiene can harm the central nervous system of children; the EPA has classified butadiene as a known human carcinogen; and

WHEREAS, In June of 2015, Environment and Human Health, Inc., an organization of physicians and public health professionals, conducted a study of 14 samples of crumb rubber at Yale University and found that 96 chemicals were found in crumb rubber infill; of the 96 chemicals that were found, 20% were carcinogenic, about 50% had not been tested for toxicity, and many had incomplete toxicity testing completed; another 40% were found to be skin and eye irritants and also causes of breathing problems; and

WHEREAS, New York and Connecticut-based studies found that crumb rubber infill "off-gassed" toxic chemicals; and

WHEREAS, Tire rubber is composed of 30% to 40% of "carbon black" which is suspected to being a cancer causing agent; no studies regarding long-term exposure to carbon black on indoor or outdoor fields have been conducted; tires may also contain "carbon nanotubes" which some scientists believe may act similar to asbestos when inhaled into the lungs and cause cancer; and

WHEREAS, The crumb rubber industry and recycling industries tout crumb rubber as 100% safe, often referring to studies that have already been completed and statements made by the EPA and Consumer Product Safety Commission (CPSC) in 2008; however, in 2013 CPSC Chairman Elliot Kay said his 2008 CPSC statement "does not reflect my view on the state of play. Safe to play on means something to parents that I don't think we intended to convey"; and

WHEREAS, On January 28, 2016, due to the lack of reliable studies on the safety of crumb rubber, the CDC, EPA, and CPSC initiated a multi-agency plan to study the long-term effects of crumb rubber exposure on human health; and

WHEREAS, The use of crumb rubber is unregulated and lacks safety oversight by any governmental agency; furthermore, crumb rubber was excluded from classifications as a "children's product" and thus exempt from laws on chemicals "of high concern for children" found in children's products; and

WHEREAS, When applying crumb rubber to turf fields, workers are advised to wear respirators in order to protect them from inhaling crumb rubber dust; and

WHEREAS, There are no requirements to inform field users about the chemical content, associated risk, or precautionary guidelines regarding crumb rubber dust; parents are often told by the turf field owner that these fields are safe based on unreliable static air quality testing; and

WHEREAS, Citing the safety of its students, the Los Angeles Unified School District, the Los Angeles Parks and Recreation Department, the New York City Department of Parks and Recreation, the Chicago Public Schools, as well as other communities across the country have moved away from using crumb rubber infill in favor of a non-petroleum based alternative infill for their turf fields like sand or cork; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the State of Illinois is urged to monitor and, where feasible, actively participate in all crumb rubber federal testing; and be it further

RESOLVED, That the State of Illinois is urged to create a watchlist of fields and playgrounds for indoors and outdoors that contain crumb rubber and publish them on the Illinois EPA website until the 2016 multi-agency federal testing concludes that crumb rubber is definitively safe for use as infill for artificial turf fields; and be it further

RESOLVED, That any indoor or outdoor facility using artificial turf with crumb rubber infill used by children between the ages of 18-months to 12 years is urged to provide proper notification to parents regarding the 2016 multi-agency study of crum rubber and the possible chemical exposure to their children due to playing on crumb rubber infill.

Senator Koehler offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### **SENATE RESOLUTION NO. 128**

WHEREAS, On September 17, 2008, the Electronic Products Recycling and Reuse Act, Public Act 95-0959, was enacted, setting forth procedures for the recycling and reuse of covered electronic devices in Illinois; and

WHEREAS, The Electronic Products Recycling and Reuse Act banned the disposal of covered electronic devices in landfills and incinerators beginning January 1, 2012; and

WHEREAS, To provide adequate collection of discarded electronic devices and comply with the disposal ban, more than 500 collection sites statewide are currently registered with the Illinois Environmental Protection Agency (IEPA) to accept electronic wastes; and

WHEREAS, Local governments statewide have contracted with electronic waste processors and recyclers for collection, reuse, and recycling of discarded electronics, providing a vital service to their residents; and

WHEREAS, A significant component of the discarded electronic waste stream collected to date has been, and continues to be, cathode ray tube (CRT) devices, including televisions and computer monitors; and

WHEREAS, CRT glass contains lead at a sufficiently high concentration to meet the definition of hazardous waste, necessitating handling the glass in a manner that protects human health and the environment; and

WHEREAS, The principal recycling market for CRT glass was historically the production of new CRTs; and

WHEREAS, Demand for new CRTs historically provided an economic incentive to recycle CRT glass for use in the manufacturing of new CRTs, and recyclers received revenue for the CRT glass provided to CRT manufacturers; and

WHEREAS, New CRTs have essentially ceased to be purchased in the United States, and there are no CRT manufacturing facilities located in the United States; and

WHEREAS, All CRT glass used in the manufacturing of new CRTs is now exported to India to the single remaining CRT manufacturing facility in the world; and

WHEREAS, There exist limited additional available outlets for the legitimate recycling of CRT glass in the United States; and

WHEREAS, The quantity of CRT glass collected far exceeds current demand and available markets for the glass; and

WHEREAS, CRT glass processing and recycling now carries a substantial cost, a significant change since the Electronic Products Recycling and Reuse Act was enacted in 2008; and

WHEREAS, The increased cost to process CRT glass has caused a number of electronic waste collection programs operated by local governments in Illinois to bear the cost increases or to be discontinued to avoid accumulation of CRTs; and

WHEREAS, Stockpiles of abandoned CRT glass have been discovered at several former electronic waste processing facilities across the United States, due to the lack of markets for CRT glass and the high cost associated with existing markets; and

WHEREAS, Kuusakoski Recycling and Peoria Disposal Company (PDC), both Illinois-based businesses, developed and permitted a CRT glass solution, the KleanKover Recycling Solution, whereby CRT glass is treated to reduce the leachable lead levels in the glass (the principal environmental concern associated with CRTs) below stringent federal thresholds and placed as Alternative Daily Cover (ADC) in a permitted landfill; and

WHEREAS, Kuusakoski Recycling and PDC have successfully operated the KleanKover Recycling Solution since November of 2013; and

WHEREAS, Given the lack of viable recycling markets, the IEPA has determined that treated CRT glass used as ADC can be counted towards manufacturer recycling goals under the Electronic Products Recycling and Reuse Act, as documented in IEPA correspondence to Kuusakoski Recycling on November 26, 2013; and

WHEREAS, Sustainable Electronics Recycling International (SERI), administrators of the R2 Standard (a voluntary certification standard for electronic waste recyclers) has prohibited its certified recyclers from using the KleanKover Recycling Solution or any other use of CRT glass as ADC; and

WHEREAS, At least 11 government jurisdictions in Illinois, representing over 4.3 million people and with some of the most effective e-waste recycling programs in the U.S., have petitioned SERI to reconsider its position on CRT glass management, citing the need for additional CRT glass management options in the U.S.; and

WHEREAS, Basel Action Network (BAN), administrators of the eStewards Standard (a separate voluntary certification standard for electronic waste recyclers) has defined any use of treated CRT glass within a disposal facility, including use as ADC, as a "last resort" option, effectively prohibiting use of the KleanKover Recycling Solution; and

WHEREAS, BAN has expressed interest in considering retrievable storage of CRT glass in permitted, monitored, and contained designated disposal sites as a preferred CRT glass management method; and

WHEREAS, In response to BAN's interest, PDC has proposed to develop a designated storage cell at its Indian Creek Landfill to provide storage and future retrieval of CRT glass, should markets develop to utilize the leaded glass; and

WHEREAS, The Indian Creek Landfill is fully permitted to develop the retrievable storage cell and accept treated CRT glass for placement in the cell, as confirmed by IEPA in a letter to PDC dated January 26, 2015; and

WHEREAS, PDC has established a perpetual care fund for the Indian Creek Landfill, consisting of a trust fund held by a third-party and available to Tazewell County (the host jurisdiction for the landfill), which provides funding to monitor and maintain the landfill into perpetuity, an even greater level of financial and environmental protection than is required under state and federal regulations; and

WHEREAS, PDC hosted a tour at the Indian Creek Landfill on October 23, 2014 for approximately 35 attendees of the annual conference of the Illinois Counties Solid Waste Management Association (ILCSWMA) to show attendees how CRT glass is currently managed, present the plan for retrievable storage, and answer questions; and

WHEREAS, ILCSWMA conference attendees were subsequently polled to determine their support for allowing treated CRT glass to be placed in a landfill regardless of whether it is used as ADC or placed in a dedicated cell for retrievable storage, and attendees voiced nearly unanimous support of this option with only 2 of the approximately 60 participants dissenting; and

WHEREAS, Kuusakoski Recycling and PDC formally petitioned BAN on November 18, 2014 to modify its standard and allow, as an additional preferred CRT glass management option, the placement of treated CRT glass in a retrievable storage cell within a permitted disposal site which has a perpetual care fund established; and

WHEREAS, At least 10 government jurisdictions in Illinois representing nearly 4 million people have sent letters to BAN in support of Kuusakoski Recycling and PDC's petition and urging BAN'S approval in order to maintain their vital electronic waste collection and recycling programs for their residents; and

WHEREAS, The option of retrievable storage of treated CRT glass in a dedicated cell at a permitted disposal site will provide needed environmentally protective, cost effective, and immediately available capacity for CRT glass, resulting in relief for residents, local governments, and recyclers across Illinois and the United States to manage this problematic material and reduce the potential for future discoveries of stockpiled material that would pose a significant environmental threat; therefore, be it

WHEREAS, On January 27, 2017, President Donald J. Trump signed an executive order, "Protecting the nation from foreign terrorist entry into the United States", purportedly to protect Americans from terrorist attacks by foreign nationals admitted to this country; and

WHEREAS, The President's order barred citizens of seven Muslim-majority nations - Iran, Iraq, Libya, Somalia, Sudan, Syria, and Yemen - from entering the United States for 90 days; it suspended all refugee admissions to the country for 120 days, and indefinitely barred Syrian refugees from entering the United States; and

WHEREAS, The President's cruel, unnecessary, and bigoted executive order produced chaos in the United States immigration system in the hours and days immediately following its execution; and

WHEREAS, The order caused widespread confusion in the air and on the ground at U.S. and international airports; it resulted in travelers being detained for hours and questioned by U.S. authorities without legal representation, in some instances separating small children from their parents, and in one case, delaying an urgent medical appointment of a four-month old girl with a heart condition; it prompted vetted refugees and legal residents en route to the United States to be blocked and turned back; it triggered mass protests at airports throughout the country, including in Chicago, and it spurred legal action against the President; and

WHEREAS, President Trump's malicious and arbitrary order bears a striking resemblance to another episode when, during one of the darkest times in human history, America closed its doors to frightened refugees in search of sanctuary, ultimately resulting in the murder of many of them; in 1939, the German ocean liner, the SS St. Louis, set out for the United States by way of Cuba from Hamburg, Germany, with 900 Jewish refugees seeking asylum from Nazi persecution; the passengers were denied entry to the United States, Cuba, and Canada because of strict immigration quotas and were forced to return to Europe; more than half of the Voyage of the SS St. Louis passengers who returned to Europe were killed by Nazis in the Holocaust; and

WHEREAS, History has shown that executive decisions about immigration, refugee resettlement, and religious bans can have tragic life-or-death consequences that may go unrecognized for too long; and

WHEREAS, The United States, and Illinois in particular, have always welcomed, supported, and protected people of all races, ethnicities, religions, and nationalities, so much so that the very self-definition of our country, as expressed both in our founding documents and in our public consciousness, relies upon an open embrace of immigrants and refugees; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRETH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn President Donald J. Trump's executive order barring refugees from the United States and call on him to uphold and protect the values of all of the people of this great nation, which was founded by immigrants on principles that include religious freedom and the notion that all people are welcome and created equal; and be it further

WHEREAS, The Ninety-second Congress of the United States of America, at its Second Session, in both houses, by a constitutional majority of two-thirds, adopted the following proposition to amend the Constitution of the United States of America:

"JOINT RESOLUTION

RESOLVED BY THE HOUSE OF REPRESENTATIVES AND SENATE OF THE UNITED STATES OF AMERICA IN CONGRESS ASSEMBLED (TWO-THIRDS OF EACH HOUSE CONCURRING THEREIN), That the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as a part of the Constitution when ratified by the

legislatures of three-fourths of the several States within seven years from the date of its submission by the Congress:

"ARTICLE \_\_\_\_\_

Section 1. Equality of rights under law shall not be denied or abridged by the United States or any State on account of sex.

Section 2. The Congress shall have the power to enforce by appropriate legislation the provisions of this article.

Section 3. This Amendment shall take effect two years after the date of ratification.""; and

WHEREAS, A Joint Resolution is a resolution adopted by both houses of the General Assembly and does not require the signature of the Governor; a Joint Resolution is sufficient for Illinois' ratification of an amendment to the United States Constitution; and

WHEREAS, The United States Congress has recently adopted the 27th Amendment to the Constitution of the United States, the so-called Madison Amendment, relating to Compensation of Members of Congress; this amendment was proposed 203 years earlier by our First Congress and only recently ratified by three-fourths of the States; the United States Archivist certified the 27th Amendment on May 18, 1992; and

WHEREAS, The founders of our nation, James Madison included, did not favor further restrictions to Article V of the Constitution of the United States, the amending procedure; the United States Constitution is harder to amend than any other constitution in history; and

WHEREAS, The restricting time limit for the Equal Rights Amendment ratification is in the resolving clause and is not a part of the amendment proposed by Congress and already ratified by 35 states; and

WHEREAS, Having passed a time extension for the Equal Rights Amendment on October 20, 1978, Congress has demonstrated that a time limit in a resolving clause can be disregarded if it is not a part of the proposed amendment; and

WHEREAS, The United States Supreme Court in Coleman v. Miller, 307 U.S. 433, at 456 (1939), recognized that Congress is in a unique position to judge the tenor of the nation, to be aware of the political, social, and economic factors affecting the nation, and to be aware of the importance to the nation of the proposed amendment; and

WHEREAS, If an amendment to the Constitution of the United States has been proposed by two-thirds of both houses of Congress and ratified by three-fourths of the state legislatures, it is for Congress under the principles of Coleman v. Miller to determine the validity of the state ratifications occurring after a time limit in the resolving clause, but not in the amendment itself; and

WHEREAS, Constitutional equality for women and men continues to be timely in the United States and worldwide, and a number of other nations have achieved constitutional equality for their women and men; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the proposed amendment to the Constitution of the United States of America set forth in this resolution is ratified; and be it further

RESOLVED, That a certified copy of this resolution be forwarded to the Archivist of the United States, the Administrator of General Services of the United States, the President pro tempore of the Senate and the Speaker of the House of Representatives of the Congress of the United States, and each member of the Illinois congressional delegation.

ARTICLE V  
THE EXECUTIVE

SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. They shall be elected at the general election in 1978 and every four years thereafter. A person may not be elected to any Executive Branch office, or any combination of Executive Branch offices, for more than two terms. Service before the second Monday in January of 2019 shall not be considered in the calculation of a person's service.

Today I veto Senate Bill 261 from the 99th General Assembly, which amends the Illinois Rehabilitation of Persons with Disabilities Act to remove the state's ability to place any limit on the number of weekly hours a provider of home care services may work.

Each physically disabled resident in the taxpayer-funded Home Service Program is provided a service plan that includes a certain number of hours for in-home care. This care is provided by individual providers and is based on the personal circumstances and level of need of each person in the program. The total number of hours in a resident's service plan varies, with some high-need individuals requiring as much as 80, 90, or even more than 100 hours of care each week.

In response to a recent ruling by the United States Department of Labor that requires payment of time-and-a-half for each hour worked over 40 hours, the Illinois Department of Human Services (IDHS) has attempted to reasonably address the overtime being worked by individual providers—taking into account both the safety of participants in the program and the need to manage the significant increase in costs resulting from this ruling.

IDHS' proposed policy to address overtime is not yet in force, but rather proceeding through the normal process overseen by the Joint Committee on Administrative Rules (JCAR)—the legislative body tasked with reviewing rules issued by state agencies. Notably, the proposed policy incorporates many of the concerns and suggestions provided by stakeholders across the home services community. Specifically, the policy: (i) permits overtime in the appropriate circumstances, (ii) safeguards individual providers from being unnecessarily overworked, (iii) ensures that residents with extensive service plans will have more than one person who understands their needs and who is capable of caring for them, and (iv) allows the state to put reasonable limits on the amount of overtime individuals providers may work.

Despite addressing many of the concerns raised by stakeholders, and doing so through the legislatively-sanctioned JCAR process, Senate Bill 261 prohibits the state from placing any limit whatsoever on the number of weekly hours worked by individual providers. This legislation will result in many individual providers working unlimited hours on insufficient rest, will place many customers at risk of receiving inadequate care from a single, exhausted individual provider, and will drive up costs that will result in cuts to this program or others.

As stewards of the Home Services Program, the state must protect the safety of our residents, as well as the long-term sustainability of the program. The state has a responsibility to contain rising costs so that future participants will also have access to the services of this critical program. Therefore, pursuant to Section 9(b) of Article IV of the Illinois Constitution of 1970, I hereby return Senate Bill 261, entitled "AN ACT concerning employment", with the foregoing objections, vetoed in its entirety.
