WHEREAS, The month of April is designated nationally and internationally as Autism Awareness Month; and

WHEREAS, Autism Spectrum Disorders (ASDs) affect a growing number of Illinois residents and their families; and

WHEREAS, According to the Centers for Disease Control and Prevention, the prevalence of ASDs has increased from one in 150 children as of 2002, to one in 68 children today; based on these figures, more than 40,000 school-age children in Illinois have an ASD; and

WHEREAS, In 2003, to improve the State’s response to autism, Illinois passed Public Act 93-395, which created The Autism Program of Illinois (TAP); and

WHEREAS, TAP brings together universities and nonprofit organizations from across Illinois to implement a system of care for those with ASD; and

WHEREAS, Over the past 14 years, TAP has developed into the largest statewide autism resource and service network in the nation; and

WHEREAS, TAP currently operates centers or other programs in partnership with the University of Illinois Chicago, Illinois State University, Southern Illinois University, Easter Seals Metropolitan Chicago-Rockford Service Center, Easter Seals Central Illinois, RCADD - Chicago, Trinity Services, Kreider Services, the CTF Illinois, Little Friends Inc., Have Dreams, and the Hope Institute for Children and Families; and

WHEREAS, TAP has provided direct services to more than 8,500 Illinois families and trained more than 88,000 family members, educators, health care providers, day care providers, and first responders; and

WHEREAS, The TAP service model has been validated by researchers at Baylor University with many major national organizations seeking partnership with TAP; and

WHEREAS, Despite TAP's many accomplishments, there remain unmet needs, and much work needs to be done in Illinois; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate April 2, 2017 as World Autism Awareness Day in the State of Illinois; and be it further

RESOLVED, That we congratulate the members of TAP and its many partners on the occasion of its 14th anniversary, and pledge our continuing support to Illinois families impacted by autism; and be it further

RESOLVED, That a suitable copy of this resolution be presented to The Autism Program of Illinois.

**SENATE JOINT RESOLUTION  
CONSTITUTIONAL AMENDMENT NO. 11**

SC0011

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 6 of Article IV and Section 2 of Article V of the Illinois Constitution as follows:

ARTICLE IV  
THE LEGISLATURE

SECTION 6. ORGANIZATION

(a) A majority of the members elected to each house constitutes a quorum.

(b) On the first day of the January session of the General Assembly in odd-numbered years, the Secretary of State shall convene the House of Representatives to elect from its membership a Speaker of the House of Representatives as presiding officer, and the Governor shall convene the Senate to elect from its membership a President of the Senate as presiding officer. A person may not serve more than a total of 10 years in the office of Speaker of the House of Representatives or President of the Senate; provided that service before the second Wednesday in January of 2019 shall not be considered in the calculation of a person's service.

(c) For purposes of powers of appointment conferred by this Constitution, the Minority Leader of either house is a member of the numerically strongest political party other than the party to which the Speaker or the President belongs, as the case may be.

(d) Each house shall determine the rules of its proceedings, judge the elections, returns and qualifications of its members and choose its officers. No member shall be expelled by either house, except by a vote of two-thirds of the members elected to that house. A member may be expelled only once for the same offense. Each house may punish by imprisonment any person, not a member, guilty of disrespect to the house by disorderly or contemptuous behavior in its presence. Imprisonment shall not extend beyond twenty-four hours at one time unless the person persists in disorderly or contemptuous behavior. (Source: Illinois Constitution.)

ARTICLE V  
THE EXECUTIVE

SECTION 2. TERMS

[March 7, 2017]

(a) These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. They shall be elected at the general election in 1978 and every four years thereafter.

(b) A person may not serve more than 2 terms within the office of the Governor.
