SENATE RESOLUTION NO. 277

WHEREAS, African American teens have the lowest employment rate compared to other ethnic and racial groups; and

WHEREAS, According to the Bureau of Labor Statistics, as of July 2016, unemployment rates were as follows: Caucasians 9.9%, African Americans 20.6%, Asians 10%, and Hispanics 11.3%; these percentages showed little or no change from the previous July; and

WHEREAS, African American males ages 16 to 19, particularly those living in urban areas such as Chicago, face the most uncertainty in employment; and

WHEREAS, Disparities in employment outcomes for young African American men and women are longstanding; these labor market disparities have many causes, including discrimination, lower access to high-quality education, and the dearth of jobs in neighborhoods with high percentages of African American residents; and

WHEREAS, Reports note that students who do not work while in school face greater chances of dropping out of high school as well as having increased incidences of teenaged childbearing and juvenile delinquency and arrests; and

WHEREAS, The same report also states that higher rates of youth unemployment lead to increased tax burdens for other workers as governments forego income tax revenue, Social Security, and Medicare taxes and have to pay out more in welfare and unemployment insurance costs; it is estimated that high youth unemployment costs various governments \$25 billion a year; and

WHEREAS, The investment to hire youth is lower than hiring seasoned individuals; companies have the opportunity to train eager newcomers who are technologically savvy and possess unique skill sets that could benefit any company; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge solutions be sought in the form of investment and economic development in order to increase the employment rate of African American youth, and we urge the business community to work to identify and assist young African American adults to find employment opportunities.

WHEREAS, The State of Illinois is proud of the sister-state relationship it has enjoyed with the Republic of China (Taiwan) since 1992, marked by strong bilateral trade, educational and cultural exchange, and tourism; and

WHEREAS, Taiwan shares the same values of freedom, democracy, human rights, the rule of law, peace, and prosperity with the United States and the State of Illinois; and

WHEREAS, The United States ranks as Taiwan's second largest trading partner; Taiwan is the ninth largest trading partner of the United States; bilateral trade reached \$66.6 billion in 2015; and

WHEREAS, Taiwan and the State of Illinois have enjoyed a long and mutually beneficial relationship with the prospect of future growth; Taiwan was Illinois' sixth largest export market in Asia in 2015, with \$633.8 million worth of Illinois goods exported to Taiwan; and

WHEREAS, Negotiations for a Bilateral Investment Agreement (BIA) between Taiwan and the United States are an important step toward further strengthening bilateral trade and paving the way for entering into a Free Trade Agreement between our countries, thereby increasing Illinois' exports to Taiwan and creating bilateral investment and technical collaboration through tariff reduction and other trade facilitation measures; and

WHEREAS, Taiwan has undertaken a policy of "steadfast diplomacy" in its international relations; Taiwan is capable of and willing to fulfill its responsibilities and to collaborate with the world to deal with the challenges of humanitarian aids, disease control, and so forth; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we reaffirm our commitment to the strengthening and deepening of the sister-state relationship between Taiwan and the State of Illinois; and be it further

RESOLVED, That we endorse Taiwan's efforts to secure the signing of Bilateral Investment Agreement (BIA) and Free Trade Agreement (FTA) with the United States; and be it further

RESOLVED, That we continue to support Taiwan's appropriate participation in international organizations which impact the health, safety, and well-being of its people, and support its aspiration to make more contributions in international societies; and be it further

RESOLVED, That suitable copies of this resolution be delivered to all members of the Illinois Congressional Delegation and the Taipei Economic and Cultural Office in Chicago.
