Senator Morrison offered the following Senate Resolution, which was referred to the Committee on Assignments:

## SENATE RESOLUTION NO. 400

WHEREAS, The 1909 White House Conference on Dependent Children stated that every child deserves a stable and lasting family life and should not be deprived of it except for urgent and compelling reasons; and

WHEREAS, Once the decision is made to remove children from their homes, the Department of Children and Family Services has a responsibility and duty to provide them with substitute living arrangements that ensure that they are safe from additional harm and provide stability; and

WHEREAS, When children are removed from their homes and then experience placement disruption, it can lead them to experience profound distress, a sense of loss, and feelings of not belonging - all of which can lead to distrust and fear of forming secure and healthy relationships; and

WHEREAS, Children experiencing instability also have a high rate of additional placement disruption, have greater difficulty finding permanent homes, and experience poorer adult outcomes; and

WHEREAS, Evidence links multiple placements with behavioral and mental health problems, educational difficulties, and juvenile delinquency; and

WHEREAS, Children need continuity, consistency, and predictability from their caregivers; and

WHEREAS, In 2014, 20.7% of children entering substitute care had at least three different placements in their first year; and

WHEREAS, Youth who experience minimized placement changes are more likely to experience fewer school changes, less trauma and distress, less mental health and behavioral problems, increased probabilities for academic achievement, and experiencing a lasting positive relationship with an adult; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Department of Children and Family Services to develop a plan, in collaboration with the private agencies that serve the majority of youth in care, to create a review system for any child in its care when he or she enters his or her third placement; and be it further

RESOLVED, That the Department of Children and Family Services shall submit a report no later than December 31, 2017 with its recommendations to the General Assembly on how this system should be developed and implemented.

Senator Biss offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 404

WHEREAS, It is in the interest of the State of Illinois to keep communities safe and to encourage crimes to be reported; and

WHEREAS, Through information gathered from law enforcement participation in programs like "Secure Communities", 62% of people targeted have committed no crime or a minor infraction with no serious threat to public safety or national security; and

WHEREAS, The Department of Homeland Security has been arresting victims of and witnesses to crimes; and

WHEREAS, There has been a drop in the reporting of violent crimes in the wake of United States Immigration and Customs Enforcement (ICE) targeting the victims and witnesses of crimes due to their immigration status; and

WHEREAS, The use of State resources for the purpose of enforcing federal immigration law is voluntary; and

WHEREAS, Restrictions on spending State resources to enforce immigration law does not hinder the prosecution of those who break the law, whatever their immigration status; and

WHEREAS, The Department of Homeland Security issues detainers without probable cause and does not allow for channels for individuals to challenge the detainers; and

WHEREAS, The Department of Homeland Security has issued detainers against U.S. citizens and long-term permanent residents; and

WHEREAS, These procedures violate the Fourth and Fifth Amendments of the United States Constitution; and

WHEREAS, The federal government will not indemnify the State for costs and liabilities incurred as a result of enforcing federal immigration law; and

WHEREAS, Illinois is currently suffering through a budget crisis; and

WHEREAS, Undocumented immigrants contribute \$758 million dollars in taxes to the State of Illinois; and

WHEREAS, Six percent of Illinois family households include at least one undocumented immigrant; and

WHEREAS, 126,000 families with native born children have at least one undocumented parent; and

WHEREAS, The fear of deportation of family members leads children to fear attending school; and

WHEREAS, It is in the interest of the State of Illinois that children remain in school and receive the best education possible; and

WHEREAS, A policy that will encourage children to remain in school and residents to report criminal activity without fear of deportation is beneficial for the health and welfare of the State of Illinois and its residents; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the State of Illinois to cease expending State resources on enforcement of federal immigration law.

Senator Harmon offered the following Senate Resolution, which was referred to the Committee on Assignments:

## SENATE RESOLUTION NO. 408

WHEREAS, In 2014, medical literature first described the rare condition of PURA syndrome, and identified the PURA gene on the fifth chromosome as the source of the syndrome; and

WHEREAS, PURA syndrome is a very rare condition; it causes a variety of neurological symptoms from birth, including difficulty breathing, maintaining body temperature, severe sleepiness, feeding difficulties, and very low muscle tone; and

WHEREAS, There are approximately 100 confirmed cases of PURA syndrome globally, though it is expected that many more people will be diagnosed in the coming years due to the increased use of 'gene sequencing' technology; PURA syndrome patients range in age from seven months to 29 years; and

WHEREAS, Nearly all PURA syndrome patients are non-verbal and have various motor difficulties, including challenges with walking independently; and

WHEREAS, Early intervention is key to aiding children with PURA syndrome; occupational therapy can assist with spinal development, independence, sensory processing, self-care, and motor functioning; and

WHEREAS, The PURA Syndrome Foundation is a global organization that provides support, education, and community for PURA families, helping to fund research for families coping with the effects of PURA syndrome to enhance the quality of life for patients and their families; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 28, 2017 as PURA Syndrome Day; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the PURA Syndrome Foundation Team Chicago in recognition and appreciation of the organization's important work.

Senator T. Cullerton offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 412

WHEREAS, On November 18, 1967, Jim Mixon joined with the Junior Women's Club and the Wood Dale Club to establish the Wood Dale Park District; and

WHEREAS, In 1968, the first property, Mohawk Manor, was purchased from Addison Township; and

WHEREAS, In 1976, the Park District joined the Northeast DuPage Recreation Association; and

WHEREAS, Throughout the years, the Wood Dale Park District has added a pool, a senior citizens club, a nature center, nature trails, playgrounds, a police ranger program, a golf club, a water park, a gazebo, a recreation complex, and most recently, a dog park; and

WHEREAS, In 2007, TopGolf Wood Dale opened up in support of the Salt Creek Golf Club; it was awarded the 2008 Best Administration of Facilities Award in Illinois Park and Recreation Magazine; and

WHEREAS, The Wood Dale Park District adopted a new mission statement in 2014, "Serving the community with quality recreational experiences that provide a fun and healthy lifestyle"; in 2016, it adopted a new tag line, "Active Places. Friendly Faces"; and

WHEREAS, In 2016, Salt Creek Golf Course was awarded the "Best of the Best" designation for public golf courses by the Daily Herald Newspapers; and

WHEREAS, The Wood Dale Park District will celebrate its 50th anniversary in 2017; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare November 18, 2017 as Wood Dale Park District Day; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Wood Dale Park District.

Senator Steans offered the following Senate Resolution, which was referred to the Committee on Assignments:

## SENATE RESOLUTION NO. 414

WHEREAS, Epilepsy is a medical condition that produces seizures affecting a variety of mental and physical functions; and

WHEREAS, 65 million people around the world have epilepsy; and

WHEREAS, Nearly three million people in the United States have epilepsy; one in 26 people in the United States will develop epilepsy at some point in their lifetime; there are 150,000 new cases of epilepsy in the United States every year; and

WHEREAS, Over 200,000 people in the State of Illinois have epilepsy; and

WHEREAS, Epilepsy is the fourth most common neurological disorder in the United States after migraines, stroke, and Alzheimer's disease; the prevalence of epilepsy is greater than autism spectrum disorder, cerebral palsy, multiple sclerosis, and Parkinson's disease combined; and

WHEREAS, One-third of people with epilepsy live with uncontrollable seizures because no available treatment works for them; and

WHEREAS, 50,000 people die from epilepsy-related causes in the United States every year; and

WHEREAS, The Epilepsy Foundation affiliates in Illinois offer counseling, advocacy, and educational services to people with epilepsy, their families, and the communities in which they live; and

WHEREAS, The Epilepsy Foundation affiliates of Illinois lead the fight to stop seizures, find a cure, and overcome challenges created by epilepsy; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the date of May 17, 2017 as Illinois Epilepsy Advocacy Day in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Epilepsy Foundation of Chicago, the Epilepsy Foundation of North Central Illinois, and the Epilepsy Foundation of Southern Illinois.

Senator Barickman offered the following Senate Resolution, which was referred to the Committee on Assignments:

## **SENATE RESOLUTION NO. 427**

WHEREAS, Many students in all levels of public schools benefit from the opportunity to participate in activities involving nature and the environment; and

WHEREAS, Activities which better our communities and the areas in which we live are an integral part of the education of our young people; and

WHEREAS, It is always a special benefit when communities can directly gain from the efforts of public school programs; and

WHEREAS, Recently students from Pontiac Township High School's Science and Life Skills classes, TriPoint High School's National Honor Society and Science classes, Prairie Central's Grade School and Life Skills classes, Prairie Central High School Life Skills class, and Heartland Community College Science classes have collaborated on The Bluebird Project which will benefit all of their communities; and

WHEREAS, These students have rallied their communities and have helped to install hundreds of bluebird houses throughout the area with the goal of attracting the eastern bluebird back to its native habitat; and

WHEREAS, A community event, the second annual Bluebird Festival, is to be held in honor of this native bird and will feature decorations of artwork created by primary school students; and

WHEREAS, The students and teachers should be recognized for their efforts and their team spirit toward this notable project; and

WHEREAS, With this project being a collaboration of students, schools, and communities the teamwork and cooperation demonstrated is noteworthy, exciting, and significant in multiple forms; and

WHEREAS, The growth of our area, the beauty of our environment, the strength of our communities, and the character of our youth are all enhanced by the efforts and spirit of these students; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 4, 2017 as "Bluebird Project Day" in the State of Illinois; and be it further

RESOLVED, That we urge other schools in the State of Illinois to follow these schools in doing similar efforts to strengthen and unify communities, beautify the environment, and build camaraderie across the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Pontiac Township High School, TriPoint High School, Prairie Central Grade School, Prairie Central High School, and Heartland Community College.

#### SENATE JOINT RESOLUTION NO. 31

WHEREAS, It is with great humility that the Illinois General Assembly has the opportunity to pay respect and tribute to great individuals who have given their lives in service to their communities; and
