WHEREAS, The BAPS Swaminarayan Sanstha is a spiritual, volunteer-driven organization dedicated to improving society through individual growth by fostering the Hindu ideals of faith, unity, and selfless service; and

WHEREAS, The BAPS Shri Swaminarayan Mandir in Bartlett was inaugurated by His Holiness Pramukh Swami Maharaj in 2004; the Mandir has served as a center for spirituality, harmony, and service for its members and the surrounding community within Illinois; and

WHEREAS, Over the past 13 years, The BAPS Shri Swaminarayan Mandir has been, for thousands of visitors from all across the United States of America, a center for learning and experiencing Indian culture, heritage, architecture, and Hindu religion and customs; and

WHEREAS, His Holiness Pramukh Swami Maharaj appointed His Holiness Mahant Swami Maharaj as his spiritual successor and the sixth Guru of the BAPS Shri Swaminarayan Santha; and

WHEREAS, His Holiness Mahant Swami Maharaj will arrive in the United States of America for the first time as the leader and guru of the BAPS Swaminarayan Sanstha; on Sunday July 9, 2017, he will celebrate the auspicious occasion of Guru Purnima at the BAPS Shri Swaminarayan Mandir in Bartlett; and

WHEREAS, For millions of Hindus from around the world, Guru Purnima marks a day when they honor and express gratitude for their spiritual and academic teachers, as both pay a critical role in providing true knowledge; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare July 9, 2017 as "His Holiness Mahant Swami Maharaj Day" in honoring and welcoming His Holiness Mahant Swami Maharaj to the great State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to His Holiness Mahant Swami Maharaj as a symbol of our respect and esteem.

Senator Connelly offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 45

WHEREAS, Taxpayers in the State of Illinois are faced with high taxation; the weight of property taxes, and the process by which they are applied is one of the most burdensome concerns facing Illinois homeowners, and thus there needs to be an investigation into ways by which Illinois government can bring about necessary relief to homeowners across the State; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the Fair and Equitable Assessment of Property Task Force, whose purpose is the following:

- (1) conduct a comprehensive review of State laws relating to Assessment of Real Property including the appeal of assessments at the local and State level;
- (2) conduct a comprehensive review of all Statewide Assessment systems or Computer Assisted Mass Appraisal systems (CAMA) and their impact on equity;
- (3) identify opportunities to consolidate, streamline, eliminate, or create new assessment jurisdictions;

(4) conduct a comprehensive review of current exemptions available, the impact of these exemptions, and the administration or application of these exemptions;

(5) analyze the impact of TIFs on assessed values and local property taxes;

(6) analyze preferential assessments including farm valuation, open space, and developer relief;

(7) discuss the use of technology in the data collection, online review, CAMA analysis, and electronic appeal filing and make recommendations for improved accountability and efficiency;

(8) analyze assessment systems and legislation in the United States and countries worldwide; and

(9) prepare a final report to the Governor and the General Assembly making specific recommendations on the improvement of fair and equitable assessments through technology advancements, legislative procedural review, consolidation, streamlining, and/or creation of new jurisdictions with the goal to improve fair and equitable assessments throughout the State; and be it further

RESOLVED, That the Task Force shall consist of the following members:

(1) the Governor, or his or her designee, who shall serve as Chair;

(2) the Secretary of the Illinois Department of Revenue, or his or her designee;

(3) four members of the House of Representatives, one each appointed by the President of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives, and the Minority Leader of the House of Representatives; and

(4) four members appointed by the Governor, or his or her designee, who are residents of the State of Illinois and represent public and private organizations with an interest in strengthening the fair and equitable appraisal for real estate for property tax purposes throughout the State, including, but not limited to, representatives of units of local government and assessment jurisdictions; and be it further

RESOLVED, That the Task Force members shall serve without compensation; if a vacancy occurs, a replacement will be appointed by the Chair of the Task Force; and be it further

RESOLVED, That the purpose of the Task Force shall be to study issues of assessment equity and fairness, and make recommendations that will ensure accountable and efficient delivery of uniform and transparent property valuations for property tax purposes; and be it further

RESOLVED, That the Illinois Department of Revenue shall provide staffing and administrative support to the Task Force as needed, including providing an ethics officer, an Open Meeting Act officer, and a Freedom of Information Act officer; and be it further

RESOLVED, That the Task Force shall hold at least four meetings throughout the State, but otherwise shall meet at the call of the Chair; and be it further

RESOLVED, That in addition to whatever policies or procedures it may adopt, all operations of the Task Force will be subject to the provision of the Illinois Freedom of Information Act (5 ILCS 140/1 et seq.) and the Illinois Open Meeting Act (5 ILCS 120/1 et seq.); and be it further

RESOLVED, That if any provision of this resolution is found invalid by a court, the remaining provisions shall remain in full force and effect; and be it further

RESOLVED, That the Task Force shall submit its final report to the Governor and General Assembly by December 31, 2017; and be it further

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 53

WHEREAS, The members of the Illinois General Assembly recognize that foster youth are some of the State's most precious, valuable, and vulnerable citizens; and

WHEREAS, The mission of the Foster Care Alumni of America (FCAA) is to connect the alumni community and to transform policy and practice, ensuring opportunity for people in and from foster care; it seeks to serve and act on behalf of the rights, needs, and well-being of current and former foster youth; and

WHEREAS, FCAA-IL is one of 23 state chapters that the FCAA has around the country with members dedicated to its mission; and

WHEREAS, The Illinois Department of Children and Family Services (DCFS) protects children who are abused or neglected and tries to help their families safely care for them and provide for their well-being; they provide appropriate, permanent families as quickly as possible for those children who cannot safely return home; they support early intervention and child abuse prevention activities, and they work in partnerships with communities to fulfill this mission; and

WHEREAS, The services that DCFS provide include a Statewide Youth Advisory Board whose mission is to advocate and educate all youth in its care; the Statewide Youth Advisory Board is committed to youth empowerment, development, leadership, and achievement across the State of Illinois; and

WHEREAS, FCAA-IL, working together with DCFS and their Statewide Youth Advisory Board, are proud to host the second Annual Illinois Foster Youth and Alumni Legislative Shadow Day on May 10, 2017; and

WHEREAS, The purpose of this day is to connect current and former foster children with a state legislator to educate them on the legislative process; the legislators spend their day mentoring them and helping reshape the impression of who youth in foster care and alumni are; this process connects legislators to the youth that they impact directly and indirectly; and

WHEREAS, The actions of founding FCAA-IL members April Curtis, Jeremy Harvey, and James McIntyre, DCFS Director George Sheldon, and current and former DCFS Statewide Youth Advisory

Board members represent shining examples of those in our communities doing positive things for foster children, past and present, and are responsible for the creation of the Annual Illinois Foster Youth and Alumni Legislative Shadow Day; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we recognize May 10, 2017 as the second Annual Illinois Foster Youth and Alumni Legislative Shadow Day and the dedication, hard work, and significant contributions to the well-being of current and former foster children; and be it further

RESOLVED, That suitable copies of this resolution be presented to all participants in recognition of their efforts.

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 54

WHEREAS, Forty-six years ago, with the passage of the National Cancer Act of 1971, leaders of the United States came together to establish cancer research and patient care as public health priorities; and

WHEREAS, In 2017, an estimated 600,920 Americans, or more than 1,640 people a day, are expected to die of cancer; and

WHEREAS, Cancer is the second most common cause of death in the United States, exceeded only by heart disease; and

WHEREAS, In the United States, cancer accounts for nearly one in every four deaths; and

WHEREAS, The risk of being diagnosed with cancer increases with age, with 91% of new cases occurring at age 45 or later; and

WHEREAS, In the United States, men have slightly less than a one in two lifetime risk of developing cancer; and

WHEREAS, In the United States, women have slightly more than a one in three lifetime risk of developing cancer; and

WHEREAS, A total of 64,720 new cases of cancer among Illinois residents were reported in 2017; and

WHEREAS, In 2017, the American Cancer Society reported an estimated 20,040 cancer deaths in Illinois; and

WHEREAS, Cancer touches everyone, either through a direct, personal diagnosis or indirectly through the diagnosis of a family member or friend; and

WHEREAS, According to the Sanger Institute, the Cancer Gene Census has identified more than 600 cancer-related genes, and the list of those genes will continue growing as researchers continue identifying genomic changes associated with different types of cancer; and

WHEREAS, Other external factors affect cancer risks, including, but not limited to, nutrition, physical activity, safe neighborhoods, healthy foods, access to education, and differences in occupational hazards, environmental exposure to pollution and other toxins; and

WHEREAS, According to the American Association for Cancer Research, advances in chemotherapy, surgery, radiation, and palliative care have led to important improvements in patient care and, as a result, increases in survival rates associated with many cancers, including acute lymphoblastic leukemia, Hodgkin's disease, aggressive lymphomas, and testicular cancer; and

WHEREAS, Advances in cancer care, including early detection and high-quality treatment programs, and access to health care coverage are necessary to provide cancer patients with an efficient and effective continuum of care; and

WHEREAS, Public policy can influence and support efficient cancer care by mitigating some of the economic and public health burdens on State agencies, including the Department of Public Health, the Department of Healthcare and Family Services, and the Department of Human Services; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that an urgent and significant need exists to discuss and evaluate public policies affecting cancer research, treatment, education, and prevention efforts; and be it further

RESOLVED, That the Illinois Senate and the Illinois House of Representatives, by this resolution, express their support for the establishment of a joint legislative cancer caucus, to be formally known as the Illinois Legislative Cancer Caucus; and be it further

RESOLVED, That the Illinois Legislative Cancer Caucus shall act as a forum for legislators and affiliate members to learn about important public health issues related to cancer and to evaluate legislative proposals concerning those issues; and be it further

RESOLVED, That the members and affiliate members of the Illinois Legislative Cancer Caucus shall work to increase awareness and promote policies to prevent, treat, and educate the public about cancer, with the ultimate goal of identifying solutions to unmet needs; and be it further

RESOLVED, That the Illinois Legislative Cancer Caucus shall work to strengthen community support programs, to meet the diverse needs of Illinois citizens, and to support programs that make treatment options available to the medically indigent; and be it further

RESOLVED, That the organizing members of the Illinois General Assembly respectfully request recognition within the Illinois General Assembly as the official caucus for issues related to cancer prevention, treatment, and education efforts; and be it further

RESOLVED, That a suitable copy of this resolution be distributed to the members of the General Assembly, the Governor, the Director of Public Health, the Director of Healthcare and Family Services, and the Secretary of Human Services.

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 59

WHEREAS, In May of 2017, the world witnessed a coordinated global cyberattack known as WannaCry; it was one of the largest cyberattacks ever, impacting over 150 countries and infecting more than 250,000 computers and devices; and

WHEREAS, WannaCry is a type of malicious software (malware) classified as ransomware; it encrypts essential files on a Windows device and requires that you pay a ransom to unlock those files; and

WHEREAS, Although WannaCry was focused on organizations and businesses; it was unique in that it was not targeted at any one industry or region, and it used malware that can move through a corporate network from a single entry point; and

WHEREAS, For organizations that have older equipment or legacy software, such as hospitals, manufacturing plants, and power plants, deploying a patch to fix a malware vulnerability can be complicated and disruptive; power plants (coal, nuclear, and renewables) provide virtually all of the power needs for almost 13 million Illinoisans; and

WHEREAS, Cyberattacks are an increasing concern for the Illinois power grid as a widespread outage could cause catastrophic damage to the economy of Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the International Cybersecurity Task Force is created within the Illinois Commerce Commission; and be it further

RESOLVED, That the Task Force shall review the Joint Analysis Report from the U.S. Department of Homeland Security and the Federal Bureau of Investigation dated December 29, 2016 and entitled "Grizzly Steppe - Russian Malicious Cyber Activity" and develop strategies to either implement or reject the recommendations made in the report; and be it further

RESOLVED, That the Task Force shall make recommendations to Midcontinent Independent System Operator and PJM Interconnection LLP relative to insulation of Illinois businesses and consumers from cyberattacks; and be it further

RESOLVED, That the Task Force shall consist of the following members:

(1) two members from businesses that supply electricity that serve 20,000 or more customers, appointed by the Minority Leader of the House of Representatives;

(2) two members from businesses that supply natural gas that serve 20,000 or more customers, appointed by the Minority Leader of the Senate;

(3) one member from a water supplier that serves 20,000 or more customers, appointed by the Speaker of the House of Representatives;

(4) one member from the nuclear power industry, appointed by the Speaker of the House of Representatives;

(5) one member from the wind power industry, appointed by the President of the Senate;

(6) one member from the solar power industry, appointed by the President of the Senate;

(7) one member from the an Illinois-based organization that represents businesses,

appointed by the Minority Leader of the House of Representatives;

(8) one member from an Illinois-based organization that represents hospitals, appointed by the Minority Leader of the Senate;

(9) one member of a civil liberties organization, appointed by the Speaker of the House of Representatives;

(10) two members of telecommunication businesses that serve 20,000 or more customers, appointed by the Governor;

(11) two members of the Illinois Commerce Commission, appointed by the Governor;

(12) the Mayor of Chicago, or his or her designee;

(13) the Mayor of Aurora, or his or her designee;

(14) the Mayor of Springfield, or his or her designee;

(15) a mayor from the Quad Cities area, or his or her designee, appointed by the President of the Senate;

(19) two members of the majority party of the Senate, appointed by the President; and

(20) two members of the minority party of the Senate, appointed by the Minority Leader; and be it further
