PRESENTATION OF RESOLUTIONS

SENATE RESOLUTION NO. 130

Offered by Senator Link and all Senators:
Mourns the death of the Reverend Dr. W. Gehl Devore of Zion.

By unanimous consent, the foregoing resolution was referred to the Resolutions Consent Calendar.

Senator T. Cullerton offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 127

WHEREAS, The State of Illinois exempts State taxation of retirement income; and

WHEREAS, Retirees living on a fixed income have limited ability to rejoin the workforce, face high health care costs, and have little ability to save money; and

WHEREAS, Retirees could not have anticipated in their lifetime of planning that their retirement income would suddenly be taxed by the State, forcing them to cut already strained household budgets; and

WHEREAS, Retirees do pay many other taxes, such as federal income taxes, property taxes, and sales taxes; and

WHEREAS, The exclusion of taxing retirement income encourages residents to remain living in Illinois throughout their retirement and encourages newly retired Americans to relocate to the State; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we state our belief that the Illinois Income Tax Act should not be amended to permit taxing retirement income; and be it further

RESOLVED, That suitable copies of this resolution be delivered to all Illinois constitutional officers, the Speaker and Minority Leader of the Illinois House of Representatives, and the President and Minority Leader of the Illinois Senate.

Senator Crowe offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 128

WHEREAS, According to the 2015 National Health Interview Survey, among women aged 40 to 64, those who are uninsured have the lowest prevalence of mammography use in the past two years at only 31 percent compared to 68 percent for women with health insurance; and

WHEREAS, The five-year survival for breast cancer is much higher when diagnosed at an early stage, and improvements in early detection, screening, and treatment have resulted in a 39 percent reduction in breast cancer deaths; and

WHEREAS, The costs of treating advanced stage breast cancer are significantly higher than for early stage disease; average costs allowed per patient in the two years following a breast cancer diagnosis can reach up to \$182,655 for stage 4 breast cancer, which is 2.5 times the cost of treating stage 0 breast cancer; and

WHEREAS, The American Cancer Society reports that breast cancer stage at diagnosis is more advanced in racial and ethnic minorities, lower income, and uninsured women, and the mortality rate for African American women with breast cancer is higher than in white women; and

WHEREAS, The Illinois Breast and Cervical Cancer Program within the Illinois Department of Public Health receives funding from the Centers for Disease Control and Prevention's (CDC) National Breast and

Cervical Cancer Early Detection Program (NBCCEDP), a program that provides low-income uninsured and underinsured women access to breast and cervical cancer screening and early detection services, along with patient navigation, case management, and educational information; and

WHEREAS, The CDC defines health equity as when every person has the opportunity to "attain his or her full health potential"; and

WHEREAS, The Illinois Breast and Cervical Cancer Program is meeting an unmet need in providing recommended breast cancer screening services to low-income uninsured and underinsured women, whose mammography uptake has been significantly lower compared to those who are insured; and

WHEREAS, Between 2012-2017, the Illinois Breast and Cervical Cancer Program has served 62,167 women; and

WHEREAS, From 2012-2017, the Illinois Breast and Cervical Cancer Program screened 51,795 women for breast cancer with mammography and diagnosed 7,030 breast cancers; and

WHEREAS, Despite its proven success, the program remains woefully underfunded; decreased investment at the federal and state level has left low-income, uninsured and underinsured women without access to services; this lack of funding has resulted in less than one in ten eligible women currently receiving screenings through NBCCEDP; and

WHEREAS, The Illinois Breast and Cervical Cancer Program raises awareness about the importance of breast cancer screening and provides low-income, uninsured and underinsured women access to critical cancer control and prevention services that they may otherwise not have access to; and

WHEREAS, Access to these potentially lifesaving screening and early detection services provided by the Illinois Breast and Cervical Cancer Program should be available to all eligible women, consistent with American Cancer Society recommendations; and

WHEREAS, Increased investment for the Illinois Breast and Cervical Cancer Program will help Illinois reduce breast cancer incidence and mortality, save costs through increasing access to screening, diagnostic and treatment services, and reduce expensive treatment for late-stage diagnosis; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that Illinois Breast and Cervical Cancer Program eligibility and funding should be broadened to further reduce barriers to breast screening, detection and treatment for underserved women to improve conditions for women to achieve optimal health, regardless of their race, ethnicity, or economic status.

Senator Bertino-Tarrant offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 129

WHEREAS, February is nationally recognized as Career and Technical Education Month; and

WHEREAS, Career and Technical Education (CTE) programs in Illinois provide instruction for careers in high-wage, high-skill, and in-demand occupations in fields such as, business and finance, healthcare, information technology, advanced manufacturing, and human services; and

WHEREAS, CTE programs continue to strengthen the academic knowledge and technical skills of students, provide smooth pathways to and through postsecondary education and employment, assist in meeting the Illinois Learning Standards, and close achievement gaps; and

WHEREAS, CTE programs are instrumental in supporting local communities, ensuring student success, and promoting continuous improvement; and

WHEREAS, Approximately 414,000 students are enrolled in CTE across the State of Illinois; and

WHEREAS, CTE prepares students for tomorrow's careers and drives economic growth by matching employability skills with workforce demand; and

WHEREAS, CTE provides relevant academic and technical coursework leading to college credits and industry-recognized credentials for secondary and postsecondary learners; and

WHEREAS, All students benefit from career-connected learning, opportunities to develop and discover practical skills and strengths, and career exploration; and

WHEREAS, February 23, 2019 marks the 102nd anniversary of the signing of the Smith-Hughes Vocational Education Act of 1917, which was the first major Federal investment in Career and Technical Education and laid the foundation for the bipartisan, bicameral support for Career and Technical Education that continues today; and

WHEREAS, The Strengthening Career and Technical Education for 21st Act, known as Perkins V, will take full effect on July 1, 2019; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate February 2019 as Career and Technical Education Month to celebrate Career and Technical Education across the State of Illinois; and be it further

RESOLVED, that suitable copies of this resolution be presented to the Illinois State Board of Education and the Illinois Community College Board.

SENATE RESOLUTION NO. 131

WHEREAS, The vending and convenience services industry employs over 150,000 Americans and generates an economic output of over \$25 billion; and

WHEREAS, The vending machine industry has expanded in recent decades to include a wide array of convenience services and refreshments; and

WHEREAS, The vending machine industry uses cutting-edge technology to deliver innovative options to consumers; and

WHEREAS, Through the Randolph-Sheppard Vending Program, the vending industry has provided crucial business opportunities for blind people across the nation; and

WHEREAS, Illinois is proud of the dozens of small business owners in the State of Illinois who own vending companies; and

WHEREAS, The National Automatic Merchandising Association has declared March 7th as National Vending Day; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 7, 2019 as Vending Day in the State of Illinois, and we call this observance to the attention of all of our citizens.

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to those individuals who have given their lives in service to their communities; and

WHEREAS, Commander Paul R. Bauer faithfully served the Chicago Police Department (CPD) for over 31 years until his tragic on-duty death on February 13, 2018; and

WHEREAS, Commander Bauer joined the CPD in July 1986; through 1994, he served in the 3rd (Grand Crossing) and 1st (Central) Districts, as well as with the elite mounted unit; in 1994, he was promoted to sergeant and assigned to the 22nd District (Morgan Park) until 1998; from 1998 through 2005, he served on specialized enforcement teams before returning to the mounted unit; in 2005, he was promoted to lieutenant and served in the 12th District (Near West) until 2008, when he once again returned to the mounted unit as its commanding officer; in 2015, he was promoted to captain and served as executive officer of the 18th District; he was promoted to commander of the 18th District in July 2016; and

WHEREAS, Commander Bauer's most recent assignment was Commander of the 18th District (Near North); and

WHEREAS, Commander Bauer oversaw public safety plans at large scale events and for dignitary protection; he made community outreach a priority, attending countless public meetings and hosting a monthly Coffee with the Commander meeting in his district; and

WHEREAS, During his career, Commander Bauer earned 67 awards and honorable mentions, including two for crime reduction; and

WHEREAS, Commander Bauer graduated from Saint Ignatius College Preparatory; he earned his Bachelor of Science from Northern Illinois University and his Master of Public Administration from the Illinois Institute of Technology; he is survived by his wife, Erin, and his 13 year old daughter, Grace; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate the James R. Thompson Center plaza, which is defined by the open space to the east and south of the building proper, bounded by the sidewalks of Randolph and Clark street, as the "Commander Paul R. Bauer Plaza"; and be it further

RESOLVED, That the Department of Central Management Services is requested to erect, at suitable locations consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of the "Commander Paul R. Bauer Plaza"; and be it further
