WHEREAS, Northwestern University is home to world-leading faculty and innovators dedicated to bringing breakthrough discoveries from laboratories to clinics; and

WHEREAS, The Chemistry of Life Processes Institute at Northwestern University is dedicated to advancing human health and offering new hope to millions of people around the world living with disease; and

WHEREAS, The Chemistry of Life Processes Institute hastens the development of new ways to prevent, diagnose, and treat diseases like cancer, Parkinson's, Alzheimer's, addiction, heart disease, and other disorders that transform science and life; and

WHEREAS, The Chemistry of Life Processes Institute has accelerated 75 new drug candidates, medical devices, and diagnostic technologies in the development pipeline resulting in 26 new companies that have received \$1.5 billion in external investments; and

WHEREAS, The Chemistry of Life Processes Institute at Northwestern University is hosting a Biotech Summit by the Lake on March 27, 2019 to encourage investment in breakthrough science at Illinois-based and national biotech and pharmaceutical public companies led by Northwestern University graduates; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support the critical research of the Chemistry of Life Processes Institute at Northwestern University and the important contributions to human health of leading biotechnology and pharmaceutical companies based in Illinois and across the nation; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Chemistry of Life Processes Institute at Northwestern University as a symbol of our respect and esteem.

#### SENATE RESOLUTION NO. 224

WHEREAS, The members of the Illinois Senate support Northwestern Pritzker School of Law, John Marshall Law School, Northern Illinois University College of Law, University of Chicago Law School, Southern Illinois University School of Law, Chicago-Kent College of Law, DePaul University College of Law, Loyola University Chicago School of Law, and University of Illinois College of Law and their pledge to improve the well-being and mental health of their campuses and to better address mental health issues among lawyers, starting with law students; and

WHEREAS, Improving wellness and advancing legal education are synchronized interests; addressing these issues within the State's communities will result in happier and healthier individuals and better students and contributing members of the legal profession; and

WHEREAS, The legal profession has a lengthy history of substance abuse and often penalizes individuals seeking help; poor student or practitioner health is not a necessary byproduct of a rigorous legal education and needs to be treated as the scourge of the profession that it is; students left behind are not due to a failure of personal strength but are testaments to the collective failure to uplift one another and raise the standards of the legal trade; and

WHEREAS, Law school administrations are joining efforts to facilitate well-being and recognize mental health issues, to listen to the concerns of the students and be responsive to their well-being and mental health struggles, and to build a school atmosphere where well-being and mental health is recognized as an immediate issue which deserves attention and resolution; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the need to end the stigma surrounding mental health, stand in support of the efforts by the law schools of our State to provide better access to care, and urge them to continue in their efforts to address this issue; and be it further

RESOLVED, That suitable copies of this resolution be presented to Richard C. Minott, President of Northwestern Pritzker School of Law, Hannah G. Johnson, President of John Marshall Law School, Victor Zamora, President of Northern Illinois University College of Law, Mihai F. #### **SENATE RESOLUTION NO. 225**

WHEREAS, The Going Home Coalition believes that integrated living in the general community is the best practice for people with disabilities; and

WHEREAS, Persons with disabilities have been historically isolated and segregated from their home communities, often in institutional settings, and Illinois currently institutionalizes more people with developmental disabilities than 48 other states; and

WHEREAS, The U.S. Supreme Court decreed in Olmstead v. LC. on June 22, 1999, that the unjustified institutionalization of people with disabilities is illegal discrimination; and

WHEREAS, Olmstead Plaintiffs Lois Curtis and Elaine Wilson won the right to live safe, meaningful, and connected lives in their communities as a result of this decision; and

WHEREAS, The Olmstead decision was affirmed in Illinois by the U.S. District Court in Ligas v. Harnos on June 15, 2011, giving plaintiff Stanley Ligas the right to live an integrated life in the way he imagined it; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare June 22, 2019 and 2020 as "Illinois Community Living Day" in the State of Illinois, and we urge the citizens of Illinois to celebrate with both service and awareness; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Going Home Coalition as a symbol of our respect and esteem.

WHEREAS, Team Nora presents a newly-found awareness for childhood cancers; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare July 10, 2019 Team Nora Day in the State of Illinois to raise awareness of childhood cancers and the pressing need for continued research and innovative treatment; and be it further
