SENATE RESOLUTION NO. 1067

Offered by Senator Fowler and all Senators:
Mourns the death of Corporal William Lee Brown of Benton.

SENATE RESOLUTION NO. 1070

Offered by Senator Van Pelt and all Senators:
Mourns the death of Nellie Margaret Bixby Anderson.

Senator Villanueva offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 1068

WHEREAS, The future of our nation's productivity and competitiveness in the global marketplace depends on the success of all men and women; and

WHEREAS, Women have been discriminated against in education, the workplace, and society as a whole; and

WHEREAS, Nationally, women continue to earn no more than 82 cents on the dollar compared to men; in Illinois, women earn 78 cents on the dollar compared to men; and

WHEREAS, The wage gap is even greater for most women of color; African American women earn 62 cents on the dollar and Latina women earn 54 cents on the dollar; and

WHEREAS, The pay gap has been shown to start as soon as one year after college; this inequality affects not only women, but their families and society as a whole; and

WHEREAS, The pay gap between women and men has long-term effects on women's economic security; such a gap affects women's Social Security earnings, their ability to save for retirement, and their children's education; and

WHEREAS, Pay equity is closely linked to the eradication of poverty and is essential to having a highly-motivated workforce; and

WHEREAS, Equal Pay Day was originated by the National Committee on Pay Equity in 1996 as a public awareness event to illustrate the gap between men's and women's wages; the day symbolizes how far into the year a woman must work, on average, to earn as much as a man earned the previous year, with Tuesday being the day in which women's wages catch up to men's wages from the previous week; because women earn less on average than men, they must work longer for the same amount of pay; this wage gap is even greater for most women of color; and

WHEREAS, Equal pay is a priority for all women and for our society at large; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 31, 2020 as Pay Equity Day in the State of Illinois in order to raise awareness about this endemic inequity.

Senator Bush offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 1069

WHEREAS, Financial literacy is an important life skill that can greatly benefit all Illinois residents; and

WHEREAS, The need for learning good personal financial habits has never been greater, as nearly two-thirds of American adults cannot pass a basic financial literacy test; one in four adults do not pay their bills on time, and 48% of millennials report living paycheck to paycheck; and

WHEREAS, Problems, such as existing debt and bad credit history, and the majority (80%) of roadblocks for potential homeowners can be solved with better financial literacy education; and

WHEREAS, It is imperative that we teach children good personal financial habits so they are more likely to show positive financial behaviors and skills later in life, such as paying off credit cards each month, saving for retirement, and refraining from making compulsive purchases; and

WHEREAS, Children should be taught financial literacy skills at a young age, and all schools in Illinois should have access to high quality, standards-based curriculum to teach these important life skills; and

WHEREAS, Revised Social Studies Standards, which included economics and financial literacy standards for the first time, were adopted in 2015 by the Illinois State Board of Education and approved by the Joint Committee on Administrative Rules in 2016; and

WHEREAS, It is the goal of the State Treasurer's Office to provide programs, services, and curriculum to teachers and school districts that satisfy these new standards and provide financial education to children throughout the State; and

WHEREAS, The State Treasurer's Office has partnered with the Illinois Council on Economic Education, which is commonly referred to as Econ Illinois, to develop an interdisciplinary, standards-based curriculum for teaching financial literacy in first through eighth grades, called Money Minded Illinois; and

WHEREAS, Econ Illinois is a nonprofit that has specialized in financial education for over 65 years and impacts 130,000 students through their programming; and

WHEREAS, This new curriculum is free to any Illinois teacher or school district and has distinct units for each grade level that use informative and engaging activities to teach students about a variety of financial topics; and

WHEREAS, The State Treasurer's Office, alongside Econ Illinois, hopes to help Illinoisans avoid pitfalls and problems that come with a lack of financial literacy and to help promote good personal financial habits through our standards-based curriculum; and

WHEREAS, Teaching financial literacy skills will allow Illinois residents to save for the future, pay down already accrued debt, prevent future debt, and enjoy a better quality of life, while creating informed communities and an improved economy in Illinois; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 2020 as Financial Literacy Month in the State of Illinois in order to raise awareness of free financial literacy programs, such as Money Minded Illinois, which will help to ensure that every child throughout the State has access to high quality financial education; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the State Treasurer's Office, the Illinois State Board of Education, and the Illinois Council on Economic Education.

Senator Stadelman offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 1071

WHEREAS, The School Breakfast Program has served our nation admirably since it was permanently established in 1975; and

WHEREAS, The School Breakfast Program is dedicated to the health and well-being of our nation's children; and

WHEREAS, The School Breakfast Program joins and has been joined through the years by many other excellent child nutrition programs; and

WHEREAS, The State of Illinois is dedicated to expanding access to and enhancing current School Breakfast Programs throughout the State to ensure that our children are provided with the means to succeed; and

WHEREAS, Research shows that school-age children who experience hunger have higher levels of absenteeism, make more visits to the school nurse, and have more challenges than children receiving a well-balanced diet; and

WHEREAS, Frequent studies have shown that meals provided at school not only contribute to the nutritional needs of students but also significantly increase and enhance their ability to learn; and

WHEREAS, Parents, teachers, and school food professionals are responsible for providing the children of Illinois with the basic resources needed to grow, learn, and discover their own potential in order to live happy, fulfilling lives; and

WHEREAS, Breakfast After the Bell programs, which make breakfast part of the school day, are desirable and effective ways of ensuring more students realize the benefits of breakfast; and

WHEREAS, Offering breakfast as part of the school day improves children's diets, builds healthy, lifelong eating habits, and allows students to begin their days focused and ready to learn; the benefits of these models are maximized when eligible schools offer free meals to all students at no cost; and

WHEREAS, The Community Eligibility Provision offers high-need Illinois schools the opportunity to serve breakfast to all students at no cost; this provision has the added benefits to schools of reducing administrative costs, eliminating the collection of paper applications, streamlining meal service operations, and increasing the reimbursements schools receive from federal child nutrition programs; and

WHEREAS, More than 74 million school breakfast are served yearly to students at more than 3,400 schools in Illinois; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we do hereby proclaim March 2-6, 2020 as School Breakfast Week in Illinois; and be it further

RESOLVED, That we strongly encourage all citizens to recognize the efforts made by schools, their school food service professionals, and school administrators to ensure the health, safety, and success of our children.

Senator Glowiak Hilton offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 63

WHEREAS, The fifth generation of wireless (5G) is expected to be available throughout the country in 2020; and

WHEREAS, 5G taps into millimeter waves at the top of the radio spectrum that have not previously been used for telecommunication to allow for the faster transfer of data; and

WHEREAS, New antennas and other 5G equipment will need to be installed to increase capacity; and

WHEREAS, New technology frequently invokes concerns about health impacts; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the 5G Task Force is created to identify any major health risks associated with the proliferation of 5G infrastructure in the State of Illinois; and be it further

RESOLVED, That the Task Force shall be comprised of the following members, who shall serve without compensation:

- (1) One member from the Department of Public Health, appointed by the Director of Public Health;
- (2) One member from the Department of Innovation and Technology, appointed by the Director of the Department of Innovation and Technology;
- (3) One member who is considered an expert in the field of radiology, appointed by the Governor; and
- (4) One member who is considered an expert in the field of electrical engineering and is employed as a professor of the subject, appointed by the Governor; and be it further

RESOLVED, That the Department of Public Health shall provide administrative support to the Task Force; and be it further

RESOLVED, That the Task Force shall submit a final report to the General Assembly by January 1, 2021 and, upon the filing of its report, is dissolved.
