SENATE RESOLUTION NO. 1074

WHEREAS, Congress passed the 19th Amendment to the Constitution of the United States, guided by the shared ideals of freedom, sovereignty, democracy, civil liberties, and individual rights; and

WHEREAS, From 1919 to 1920, the Sixty-Sixth Congress debated, and state legislatures considered, an amendment to the Constitution to provide suffrage for women; and

WHEREAS, On May 21, 1919, the U.S. House of Representatives approved a proposed amendment, followed by the Senate a few weeks later on June 4, 1919; and

WHEREAS, The introduction, passage, and ultimate ratification of the 19th Amendment were the culmination of decades of work and struggle by advocates for the rights of women across the United States and worldwide; and

WHEREAS, The ratification of the 19th Amendment ensured women could more fully participate in our democracy and fundamentally changed the role of women in the civic life of our nation; and

WHEREAS, August 18, 2020 marks the centennial of the ratification of the 19th Amendment by three-fourths of the states, providing the support necessary under Article V of the Constitution of the United States; and

WHEREAS, August 26, 2020 marks the centennial of the 19th Amendment becoming a part of the Constitution of the United States, providing for women’s suffrage; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare August 26, 2020 as "Women’s Suffrage Day" in the State of Illinois.

Senator Bertino-Tarrant offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 1078

WHEREAS, Approximately half of Illinois high school graduates enrolling as full-time freshmen in Illinois public community colleges require remedial education; and

WHEREAS, Illinois employers report that recent high school and postsecondary institutional graduates often lack the critical skills necessary to succeed in high-demand and growing occupational areas, and that they are unable to find qualified workers to meet their industry's needs; and

WHEREAS, Student readiness for postsecondary education and careers cannot be reduced to a single metric but must instead be understood as a multifaceted set of knowledge, skills, and abilities that allow students to successfully meet the challenges of postsecondary education and career in order to live healthy, productive lives; and

WHEREAS, Enabling high school students to engage in career and postsecondary education development activities and incentivizing achievement in career-oriented education, particularly in high-demand industry sectors, promotes postsecondary and career readiness and facilitates better-informed postsecondary education decisions; and

WHEREAS, Aligning support from State agencies, school districts, postsecondary education providers, employers, and other public and private organizations will lead to the development and implementation of a robust and coordinated postsecondary education and career readiness system in Illinois; and

WHEREAS, The Illinois Postsecondary and Workforce Readiness Act establishes a voluntary system for school districts to award college and career pathway endorsements on high school diplomas; the endorsement demonstrates students' readiness for college and careers, completion of instruction and professional learning experiences in a selected career interest area, and incentivizes career exploration and development, particularly in high-demand career fields; and

WHEREAS, The Illinois Postsecondary and Workforce Readiness Act takes a student-centered and competency-based approach to create four strategies to help students prepare for postsecondary and career opportunities, which include offering a Postsecondary and Career Expectations framework (PaCE), piloting competency-based high school graduation requirements, supporting students to avoid remediation in college through targeted math instruction during their senior year, and creating a new system for school districts to award college and career pathways endorsements on high school diplomas; and

WHEREAS, The Postsecondary and Career Expectations framework outlines what students should know and actions they should take from middle school through 12th grade to select the right postsecondary option, prepare for careers, and access financial aid opportunities; and

WHEREAS, Illinois enacted the Postsecondary and Workforce Readiness Act to deploy a number of strategies to prepare more students for meaningful career opportunities by supporting postsecondary and career planning, promoting and incentivizing competency-based learning programs, reducing remedial education rates, increasing alignment between K-12 and postsecondary education systems, and implementing college and career pathway systems; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage high schools across the State to participate in the Postsecondary and Workforce Readiness Program to help address key barriers to the successful transition of Illinois high school students into college and careers.

Senator Martinez offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 65

[March 12, 2020]

WHEREAS, The executive board of the World Health Organization designated the year 2020 as "Year of the Nurse and Midwife" in conjunction with the 200th birthday of Florence Nightingale; and

WHEREAS, The World Health Organization is urging world leaders to make investments in nursing and to pave the way for a brighter future for health around the world; and

WHEREAS, Nurses and nurse midwives have a critical role in health promotion, disease prevention, and the delivery of care in all settings; and

WHEREAS, Illinois has 185,992 registered nurses living and working in the State, of which 13,746 are also licensed as advanced practice registered nurses, and 24,763 licensed practical nurses, making nursing the largest licensed health care profession; and

WHEREAS, There are over 525 active certified nurse-midwives (CNMs) licensed through the Illinois State Board of Nursing; and

WHEREAS, There are 129 schools of nursing in Illinois; and

WHEREAS, The care provided by nurses in Illinois is the primary component to a successful health care delivery system; and

WHEREAS, Since 2015, nurse researchers in Illinois have been awarded funding from the National Institute of Nursing Research in excess of \$27 million, to provide the evidence-based findings to improve health for individuals, families, and communities; and

WHEREAS, CNMs are primary care providers throughout a woman's life span, promoting the health and well-being of newborns and women, and care for families and communities during a time of an obstetric workforce shortage in the country; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we declare 2020 as the "Year of the Nurse and Midwife" in the State of Illinois; and be it further

RESOLVED, That we recognize the vital role of nurses and nurse midwives in promoting and providing health care to the residents of Illinois and the importance of investment in nursing education and research to develop a sufficient and effective workforce.
