Senator McClure offered the following Senate Resolution, which was referred to the Committee on Assignments:

**SENATE RESOLUTION NO. 1084**

WHEREAS, The Apollo 13 mission was manned by 38-year-old Command Module Pilot John Swigert, 36-year-old Lunar Module Pilot Fred Haise, and 42-year-old Mission Commander James Lovell; and

WHEREAS, The Apollo 13 spacecraft Odyssey was successfully launched from the Kennedy Space Center on April 11, 1970 and was intended to be the third Apollo mission to land men on the moon; and

WHEREAS, The Odyssey successfully docked with the Lunar Module Aquarius on April 11, 1970; and

WHEREAS, When the spacecraft was 200,000 miles from Earth on April 13, 1970, a cryogenic oxygen tank stir was conducted; unbeknownst to the crew, this caused a fire in one of the spacecraft's oxygen tanks due to faulty wiring; and

WHEREAS, Moments after the cryogenic oxygen tank stir was conducted, the crew heard a large bang that was accompanied by fluctuations in electrical power and firing of attitude control thrusters; this prompted Commander James Lovell to state to the NASA command center "Houston, we've had a problem"; and

WHEREAS, This accident damaged key components of the spacecraft, including the power and oxygen supply, rendering it unable to complete its planned landing on the moon; instead, it placed the lives of the crew in jeopardy and necessitated emergency procedures in order to safely return the astronauts to Earth; and

WHEREAS, Following the accident, it was determined by mission control and Flight Director Eugene Kranz that the mission would abort by looping the spacecraft around the moon and using the Lunar Module Aquarius as a lifeboat; and

WHEREAS, In order to expedite the return to Earth, a burn of the Lunar Module Descent Propulsion System lasting four minutes and twenty-three seconds was conducted by the crew using the sun and moon as navigational aids; and

WHEREAS, The Lunar Module carried enough oxygen to support the crew during their return journey but could not sufficiently process the carbon dioxide produced by the three astronauts, requiring engineers on the ground to devise a way to adapt filters from the Command Module to work on the Lunar Module; and

WHEREAS, During the return flight from the moon, the crew members lost 31 pounds between them, endured temperatures as low as 38 degrees Fahrenheit, and were rationed to .2 liters of water per day, per person; and

WHEREAS, The crew successfully powered up the command module from full shutdown, jettisoned the Lunar Module Aquarius, and splashed down safely in the Pacific Ocean on April 17, 1970, despite concerns about possible damage to the spacecraft's heat shield; and

WHEREAS, All members of the Apollo 13 crew were awarded the Presidential Medal of Freedom by then-President Richard Nixon, with the mission being deemed a "successful failure" by the public, highlighting the resolve and ingenuity of NASA and its astronauts to confront and overcome a crisis; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 11, 2020 Apollo 13 Day in the State of Illinois to commemorate the 50 year anniversary of the mission launch and safe return of all three crew members to Earth.

Senator Castro offered the following Senate Resolution, which was referred to the Committee on Assignments:

**SENATE RESOLUTION NO. 1158**

WHEREAS, There have been growing concerns that an increasing number of workers in the State of Illinois are being misclassified by their employers, but limited data currently exists to support or abate these concerns; and

WHEREAS, Employee misclassification creates a host of issues that deny workers in Illinois basic labor standards, including, but not limited to, wage and hour protections, discrimination protections, health and safety standards, workers' compensation, retirement security, and unemployment insurance; and

WHEREAS, The misclassification of workers also enables unscrupulous employers and hiring entities to gain an unfair advantage over other employers that obey the law and permits such employers to shift the cost of providing benefits, such as a safe workplace, retirement security, and unemployment insurance, to governmental bodies and, ultimately, the taxpayers; and

WHEREAS, The harms caused by misclassification are only exacerbated in times of economic downturn, such as the current state of the global economy in the wake of the COVID-19 pandemic; and

WHEREAS, The spread of COVID-19 has resulted in unprecedented job loss and an increase in unemployment insurance claims in the State; and

WHEREAS, The Department of Employment Security previously adopted the practice of verifying employment classification when processing claims for unemployment insurance benefits; and

WHEREAS, Through this process, the Department of Employment Security has the capability of identifying employee misclassification, however, only where workers voluntarily seek regular unemployment benefits from the Department; and

WHEREAS, Federal unemployment insurance programs, such as Pandemic Unemployment Assistance, have recently expanded eligibility to workers who were previously ineligible to receive unemployment insurance benefits, including individuals who are self-employed, independent contractors, and sole proprietors; and

WHEREAS, Workers who are self-employed, independent contractors, and sole proprietors, and their hiring entities have not traditionally been required to contribute to federal or state unemployment insurance programs; and

WHEREAS, The Department of Employment Security is presently receiving and processing claims for unemployment benefits under both the State and federal programs, gaining access to information and data from a larger sample of the workforce in the State, including those thought to be non-employees; and

WHEREAS, Absent the Pandemic Unemployment Insurance program providing assistance to workers who are self-employed, independent contractors, or sole proprietors, it is difficult to collect data about this type of employment and earnings; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Department of Employment Security is urged to collect data, where practicable, regarding incidents of employer misclassification, including, but not limited to, job titles, employment industry, wages, hours, and dollar amount of unemployment benefits paid from the state unemployment fund; "Employer misclassification" in this paragraph shall mean a case in which a worker is classified by his or her employer as an independent contractor and paid 1099 wages but is later deemed by IDES to qualify as an employee, based upon the legal standard applicable to State of Illinois unemployment law; and be it further

RESOLVED, That the Department of Employment Security is urged to collect data, where practicable, regarding applicants who are found by the Department to qualify for Pandemic Unemployment Assistance as self-employed, independent contractors, and sole proprietors, including, but not limited to, job titles, employment industry, hours, and wages or earnings; and be it further

RESOLVED, That such data, to the greatest extent permitted under the law, should be presented in a meaningful and workable electronic format that excludes private and personally identifying information of Unemployment Insurance applicants to be shared with the members of the Senate of the One Hundred First General Assembly of the State of Illinois on or before the last day of the 101st General Assembly; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor JB Pritzker and Thomas Chan, Acting Director of the Department of Employment Security.

Senator Brady offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### **SENATE JOINT RESOLUTION NO. 66**

WHEREAS, Senate Joint Resolution Constitutional Amendment No. 1 proposes to amend the Revenue Article of the Illinois Constitution by removing language that requires a uniform rate for personal income tax imposed by the State, and by authorizing the General Assembly to set by law the rate or rates for personal income tax imposed by the State; and

WHEREAS, Senate Joint Resolution Constitutional Amendment No. 1 was adopted by a three-fifths majority of the Senate on May 1, 2019, and by a three-fifths majority of the House of Representatives on May 27, 2019, meeting the requirements of subsection (a) of Section 2 of Article XIV of the Illinois Constitution to be placed on the ballot at the next general election; and

WHEREAS, The proposal to amend the Illinois Constitution authorized by Senate Joint Resolution Constitutional Amendment No. 1 is scheduled to appear on the general election ballot for November 3, 2020; and

WHEREAS, Subsection (a) of Section 2 of Article XIV of the Illinois Constitution specifically authorizes proposed constitutional amendments adopted by the General Assembly under Section 2 of Article XIV of the Illinois Constitution to be removed from the ballot when "withdrawn by a majority of the members elected to each house"; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the proposal to amend the Illinois Constitution authorized by Senate Joint Resolution Constitutional Amendment No. 1 is hereby withdrawn from the general election ballot for November 3, 2020; and be it further

RESOLVED, That the Governor, the Secretary of State, the Illinois State Board of Elections, and all Illinois election authorities shall be provided with copies of this resolution.

CONSTITUTIONAL AMENDMENT NO. 23**

SC0023

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend the Illinois Constitution in Article I by adding Section 25 as follows:

ARTICLE I  
BILL OF RIGHTS

SECTION 25. WORKERS' RIGHTS

No law shall be passed on or after the effective date of this Constitutional Amendment that prohibits the ability of workers to join together and collectively bargain over wages, hours, and terms and conditions of employment through a representative of their own choosing, including any law that prohibits the right of private sector employers and employees to enter into and administer union-security agreements. The General Assembly by law may establish reasonable amendments to existing law and establish reasonable exemptions relating to these rights.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.
