Senator Villivalam offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 57

WHEREAS, Education Support Professionals (ESPs) are the backbone of Pre-K through 12 public education and also work in higher education institutions; more than half a million Education Support Professional members across the country take care of our children every day; they ensure all students have the tools they need to succeed in our schools, classrooms, and higher education institutions; ESPs are comprised of nine career families working in clerical services, custodial and maintenance services, food services, health and student services, security services, skilled trades, technical services, and transportation services and as paraeducators; ESPs are not treated, respected, nor valued the same as teachers; and

WHEREAS, ESPs interact daily with students, parents, and staff; responsibilities include, but are not limited to, processing and maintaining vital, confidential data and student records; and

WHEREAS, ESPs keep schools open, operational, safe, accessible, and clean for students, staff, and the community at all times; they are responsible for ensuring proper indoor air quality and for complying with ROE state regulations and federal OSHA standards for safety operations in the school buildings; and

WHEREAS, ESPs ensure that students have access to safe and nutritious meals and ensure that school districts are complying with the federal free and reduced meal guidelines; and

WHEREAS, ESPs perform a wide variety of health assistance that improves and protects student health and welfare; their responsibilities include, but are not limited to, traditional tasks of providing first aid, monitoring immunizations, conducting health screenings, and assisting sick and injured children; ESPs also provide education that encourages students to maintain good health independently; and

WHEREAS, ESPs perform professional responsibilities that contribute directly to student achievement by providing direct services to students and their families, including academic, social emotional, behavioral, English as a second language, special education, and medical and life skills support for general education to ensure all students receive fair and equitable educational opportunities; and

WHEREAS, ESPs have a clear understanding of not only security techniques but also the unique nature of the school population with whom they work; on a broader level, they are active in designing and implementing security policies and crisis response plans; and

WHEREAS, ESPs maintain and improve the physical quality of school buildings, offices, and facilities; they work behind the scenes to repair, maintain, and operate machinery that is essential to the smooth functioning of the school; and

WHEREAS, ESPs lead the effort to maintain high standards of technology and communication in our schools; they install, repair, and upgrade computers and networks that enable the timely communication of essential information between parents, school district employees, and students; and

WHEREAS, ESPs transport students to and from school safely, and an ESP is the first people to greet each student in the morning and last to say goodbye as they return home; ESPs operate and maintain all of a school system's vehicles; in addition to driving, often in bad weather or heavy traffic, they are responsible for first aid and emergency evacuation procedures, student conduct and discipline, and the safe transportation of students with special needs; all employees in a district's transportation department stay up-to-date on new safety requirements, regulations, and policies; and

WHEREAS, The starting salaries of ESPs begin at \$10.00 per hour for the 2020-2021 school year in the state of Illinois according to the ISBE Non-certified Salary Study; ESPs also often do not qualify for health benefits or use most or all of their wages to pay for health benefits; some ESPs earn at or near poverty level and qualify for government assistance; many ESPs must work more than one job to provide for their families; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that Education Support Professionals in public schools should be treated with the same respect, recognition, value, and standards as teachers and should no longer be second class citizens within the ranks of public education; these professionals provide invaluable services to school communities; and be it further

RESOLVED, That we urge the General Assembly to seek solutions via study and legislation that include, but are not limited to, legislated salary parity, quality professional development and training, and mandated access to health benefits for all education support professionals.

Senator Crowe offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 58

WHEREAS, The Sexual Assault Survivors Emergency Treatment Act is primarily focused on sexual assault survivors generally, and child sexual abuse has distinct circumstances and responses; and

WHEREAS, Child sexual abuse has various adverse effects on the psychological, physical, behavioral, and interpersonal well-being of the victim; and

WHEREAS, Child victims of sexual and physical abuse are at a higher risk of suffering from depression, low self-esteem, post traumatic stress disorder, psychotic syndromes, suicide or attempted suicide, anti-social personality disorders, drug and alcohol abuse, and increased risk of re-victimization; and

WHEREAS, Child victims of sexual abuse deserve to have an acute specialized medical response/exam that is developmentally appropriate, trauma-informed, evidenced-based, and provided by a medical specialist with pediatric expertise; and

WHEREAS, The research conducted on child sexual assault indicates that in cases of child sexual abuse when the investigation is conducted carefully and conscientiously then answers to questions of safety begin to emerge; and

WHEREAS, The research conducted on child sexual assault cases indicates one in 10 children are affected; 73% of child victims do not tell anyone about the abuse for at least a year, 45% of victims do not tell anyone for at least 5 years, and some children never disclose; 90% of child sexual abuse victims know their abuser; and

WHEREAS, The State has a responsibility to protect these youth from mistreatment, further traumatization, and exploitation; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Child Sexual and Physical Abuse Task Force is created to investigate, assess, and make recommendations on the Sexual Assault Survivors Emergency Treatment ACT and its implementation to ensure that child development and children's unique medical needs are addressed in the medical response to child sexual abuse within this Act; in addition to the goals stated above, The Task Force shall:

- (1) Evaluate current training, mentoring, and certification programming for pediatric sexual abuse medical exam providers to ensure all align with national accreditation standards;
- (2) Conduct a comprehensive review, evaluation, and streamlining of the complaint process for practitioners and providers;
- (3)Prepare a peer review of all processes relating to the implementation, accreditation, and programmatic structure of the Sexual Assault Survivors Emergency Treatment Act;
- (4) Conduct a comprehensive review of pediatric evidence available to ensure that the implementation of the Sexual Assault Survivors Emergency Treatment Act is appropriate for pediatric populations; and
- (5) Conduct a comprehensive review of the examination process for becoming a Sexual Assault Nurse Examiner Pediatrics in Illinois to ensure that this accreditation is efficient, effective, and appropriate; and be it further

RESOLVED, That the Task Force shall consist of the following members:

- (1) The President of the Senate or his or her designee, who shall serve as Chairperson;
- (2) The Minority Leader of the Senate or his or her designee;
- (3) The Director of the Department of Children and Family Services or the (DCFS) Director of Legislative Affairs;
- (4) The Director of the Department of Public Health or the (DPH) Director of Legislative Affairs;
 - (5) The Director of the Illinois State Police or the (ISP) Director of Government Relations;
 - (6) The Attorney General or the (AG) Chief of Legislative Affairs;
 - (7) The Director of the Guardianship and Advocacy Commission or his or her designee; and
- (8) The following members appointed by the Director of the Department of Children and Family Services:
 - (a) One member representing a coalition of Children's Advocacy Centers in Illinois;
- (b) Five members representing Children Advocacy Centers; appointees must be geographically diverse: four members representing each CAC region and one representing a county with a population less than 100,000 people;
- (c) Five members representing Certified Pediatric Sexual Assault Nurse Examiners SANE-Ps; appointees must be geographically diverse: four members, each representing only one CAC region and one representing a county with a population less than 100,000 people;
- (d) Five Pediatrician Board Certified/Eligible in Child Abuse and Neglect; appointees must be geographically Diverse: four members representing only one CAC region and one representing a county with a population less than 100,000 people;
 - (e) Five general pediatricians with expertise in child sexual abuse;
 - (f) One member representing a statewide association of pediatricians;
 - (g) One member representing a statewide association of hospitals;
 - (h) One member representing a statewide association of physicians;
- (i) One member representing children's justice prosecutor with experience prosecuting sexual and physical abuse of minors;
- (j) One member who serves as a law enforcement officer (juvenile division or Child Death Review Team) with experience investigating sexual and physical abuse of minors; and
- (k) One pediatrician who is board certified in child abuse pediatrics at an independent free-standing children's hospital located in Chicago and serves as an assistant professor of pediatrics (child abuse) at a medical school located in Chicago; and be it further

RESOLVED, That members of the Task Force shall be appointed within 30 days after the adoption of this resolution and shall serve without compensation; and be it further

RESOLVED, That the Illinois State Police shall provide administrative support to the Task Force; and be it further

RESOLVED, That the Task Force shall hold at least four meetings, and the first meeting must be held within 30 days after appointments are finalized or at the call of the Chairperson; and be it further

RESOLVED, That the Task Force must report its findings and recommendations to the Governor and the General Assembly no later than April, 30, 2021, and upon the filing of its report is dissolved; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the Senate, the Minority Leader of the Senate, and the state agencies represented on the Task Force.

Senator Van Pelt offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 59

WHEREAS, During the 100th General Assembly, Senate Resolution 1797 directed the Illinois Criminal Justice Information Authority (ICJIA) to conduct a review of the shared gang database operating in Illinois; and

WHEREAS, The ICJIA was to report its findings to the General Assembly by January 9, 2019; and

WHEREAS, The ICJIA needs additional time to complete its review; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the ICJIA shall report its findings as required by Senate Resolution 1797 of the 100th General Assembly no later than June 30, 2021; and be it further

RESOLVED, That with this extension, the ICJIA shall continue to perform its review as provided under Senate Resolution 1797 of the 100th General Assembly.

Senator Aquino offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 60

WHEREAS, In 1992, the State of Illinois established the sister-state relationship with Taiwan Province, the Republic of China (Taiwan), and Illinois and Taiwan have enjoyed strong bilateral trade, educational and cultural exchanges, and tourism; and

WHEREAS, Taiwan shares the same values of freedom, democracy, human rights, the rule of law, peace, and prosperity with the United States and the State of Illinois; and

WHEREAS, The United States ranks as Taiwan's second-largest trading partner; Taiwan is the tenth-largest trading partner of the United States, and bilateral trade reached US\$ 85.5 billion in 2019; and

WHEREAS, Taiwan and the State of Illinois have enjoyed a long and mutually beneficial relationship with the prospect of future growth; Taiwan was Illinois's seventh-largest export market in Asia in 2019, with US\$ 667 million worth of Illinois goods exported to Taiwan; and

WHEREAS, Negotiations for a Bilateral Trade Agreement (BTA) between Taiwan and the United States are an important step toward further strengthening bilateral trade between our countries, thereby increasing exports from Illinois to Taiwan and creating bilateral investment and technical collaboration through tariff reduction and other trade facilitation measures; and

WHEREAS, Taiwan has undertaken a policy of "steadfast diplomacy" in its international relations; it is capable of, and willing to, fulfill its responsibilities and to collaborate with the world to deal with the challenges of humanitarian aid, disease control, and so forth; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we reaffirm our commitment to the strengthening and deepening of the sister ties between the State of Illinois and Taiwan; and be it further

RESOLVED, That we endorse Taiwan's efforts to secure the signing of a Bilateral Trade Agreement (BTA) with the United States and reiterate our support for a closer economic and trade partnership between the State of Illinois and Taiwan; and be it further

RESOLVED, That we continue to support Taiwan's meaningful participation in international organizations which impact the health, safety, and well-being of the people of Taiwan and support Taiwan's aspiration to make more contributions in international societies.

Senator Tracy offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 9

WHEREAS, It is appropriate to remember the many sacrifices and contributions to the cause of freedom made by the outstanding men and women who served in the U.S. Armed Forces; and

WHEREAS, Lt. Col. John Stein was born in Des Moines, Iowa to Jay and Hazel (Fick) Stein on July 8, 1963; he married Barbara Nelson in Macomb on July 9, 1983; he grew up in the Macomb area and moved away in 1983; he graduated from the Rochester Institute of Technology in 1985; he received his master's degree from the University of Maryland; and

WHEREAS, Lt. Col. Stein was commissioned into the U.S. Army and transferred to the U.S. Air Force; during his military career, he flew 3,901 hours; he volunteered for the rescue mission he was flying when he was killed in Afghanistan on March 23, 2003; and

WHEREAS, During his military career, Lt. Col. Stein received a Meritorious Service Medal, an Air Medal, an Aerial Achievement Medal, an Air Force Commendation Medal, an Army Commendation Medal, and an Army Achievement Medal; and

WHEREAS, Lt. Col. Stein was preceded in death by his grandparents; and

WHEREAS, Lt. Col. Stein's passing has been deeply felt by many, especially his wife, Barbara Nelson Stein; his father, Jay W. Stein; his mother, Hazel Henry; his two sons, Doug and Tim Stein; his daughter, Erin Stein Jones; his sisters, Holly Stein, Navida (James McLaughlin) Stein, and April Stein; his six nieces; and his two nephews; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate the portion of Old Highway 136 from E. 950th St. to E. 750th St. between Macomb and Colchester as the "Lt. Col. John Stein Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of "Lt. Col. John Stein Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Secretary of Transportation and the family of Lt. Col. Stein.

Senator Tracy offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 10

WHEREAS, It is highly fitting that the General Assembly pays honor and respect to those individuals who have contributed to the success of their community, the State, and to the efforts to cure childhood cancers and other pediatric diseases; and

WHEREAS, Beginning in 2001, Roger and Regina Landon of Chandlerville have organized numerous horse trail rides at the Jim Edgar Panther Creek State Fish and Wildlife Area each June to raise money for the St. Jude's Children's Research Hospital; and

WHEREAS, Since 2001, horse enthusiasts from all over Central Illinois have been attending the Saddle-Up for St. Jude event to raise money for children diagnosed with cancer and other pediatric diseases that are being treated at St. Jude's; since 2001, a total of \$730,000 has been raised at these events benefiting the children at St. Jude's Hospital; and

WHEREAS, St. Jude's Children's Research Hospital, located in Memphis, Tennessee, treats children with cancer and other pediatric diseases at no cost to the patients; research efforts are directed at understanding the molecular, genetic, and chemical basis of catastrophic diseases in children, identifying cures for such diseases, and promoting their prevention; research is focused specifically on cancers, acquired and inherited immunodeficiency disorders, sickle cell disease, infectious diseases, and genetic disorders; and

WHEREAS, Roger and Regina established these trail rides at the Jim Edgar Panther Creek State Fish and Wildlife area to highlight the beautiful facets of nature found at this wildlife area, to raise funds for the worthy cause of St. Jude's Children's Research Hospital, to bring horse and fish enthusiasts together to enjoy the trails of this wildlife area, and to encourage camping at the area; and

WHEREAS, St. Jude's Children's Research Hospital is associated with Children's Hospital of Illinois, located in Peoria; and

WHEREAS, It is estimated to cost nearly \$1 billion to operate St. Jude's this year, with the majority of those funds coming from generous donors; and

WHEREAS, Roger and Regina Landon started Saddle Up for St. Jude's in 2001; their initial goal was to be more successful than other Saddle Up fundraisers in Illinois, which then averaged \$3,500; for the first benefit, they acquired donations for the meat to be served, the side dishes, paper products, and the evening entertainment bands; the event had Sponsorship Tickets, where each ticket cost \$100 and produced a winner for every 20 sold; 1st place won a Browning Silver shotgun, and the next winner won \$400; raffle tickets for half a beef and cash prizes were also sold; during the weekend of the event, there was a silent auction, which usually generated a great deal of the proceeds, with all the items donated by generous friends and acquaintances; St. Jude's received \$10,000 after the first benefit, and \$14,000 after the second year, with the amount increasing each year to over \$55,000 last year; St. Jude's has received a total of \$730,000 and, due to the COVID-19 pandemic in 2020, a virtual fundraiser was held that raised an additional \$35,000 for St. Jude's; this benefit is well-attended, not only by horse enthusiasts but also by individuals interested in supporting St. Jude's; and

WHEREAS, In 2012, Roger Landon received the Special Event Coordinator of the Year from St. Jude's, which coincided with the 50th anniversary for St. Jude's Children's Research Hospital (1962-2012); Roger and Regina attended the awards recognition program in Memphis, Tennessee; and

WHEREAS, Roger and Regina Landon are personally interested in the Jim Edgar Panther Creek Equestrian Park, not only because of it being the location for the St. Jude's benefit but also for their desire to keep the park beautiful and enticing for everyone to visit and camp; they have initiated taking care of the flower gardens, each year pruning and replanting shrubs and flowers as needed and purchasing mulch to beautify the gardens; and

WHEREAS, Roger and Regina Landon enjoy meeting new camp hosts and assisting them as they settle in their positions; they have a knack for making them feel comfortable with their new environment and duties; often, a different camp host is accepted for the position each year; therefore, be it

SENATE JOINT RESOLUTION NO. 11

WHEREAS, 529 college savings plans are important tools for Illinois families who want to save for their children's college education; they offer a diverse range of investment options, tax-deferred growth, and withdrawals free of state and federal taxes when those withdrawals are used for qualified higher education expenses such as tuition, fees, books, certain room and board costs, computer equipment, and required supplies; and

WHEREAS, While the first college savings plans were developed by states in 1988 as innovative programs designed to help families and students save for higher education expenses, it was not until the enactment of Section 529 of the Internal Revenue Code by Congress in 1996 that college savings plans began to rapidly gain popularity across the country; and

WHEREAS, Today, all 50 states and the District of Columbia offer 529 college savings plans; 12.5 million 529 accounts have been opened, more than \$253 billion dollars have been saved for future higher education expenses, and more than one million students nationwide have withdrawn funds from 529 accounts to help pay higher education expenses; and

WHEREAS, The Illinois Treasurer currently offers and administers two 529 college savings plans, the Bright Start College Savings Plan and the Bright Directions College Savings Plan; and

WHEREAS, In 2018, Morningstar, which independently evaluates and rates college savings plans, selected the Bright Start 529 College Savings Plan as a Gold-Rated 529 and granted the Bright Directions

Advisor-Guided 529 College Savings Plan a silver rating, which was the highest rating for all advisor-sold plans; and

WHEREAS, 529 college savings plans allow families to save for tuition at two-year and four-year institutions, including vocational, trade, community, state, or technical schools; and

WHEREAS, Illinois residents can claim a state tax deduction on contributions of up to \$10,000 a year (\$20,000 for married couples filing jointly) to any state plan; and

WHEREAS, In 2000, the average tuition rate at an Illinois public university was \$4,160, while the average rate at a private four-year institution was \$15,625; in 2018, those rates have skyrocketed to \$15,182 for public universities and \$36,747 for private universities; and

WHEREAS, Federal financial aid awards have shifted away from student grants and moved to providing access to guaranteed student loans so that, today, nearly 63 percent of all federal financial aid is in the form of loans, substantially increasing the number of college graduates who will face the burden of repaying significant student loan debt upon entering the workforce; and

WHEREAS, As of 2018, student loan debt had reached \$1.5 trillion nationally, which rose from \$548 billion in 2007, and more than 1.6 million Illinois residents had student loans totaling more than \$52 billion; and

WHEREAS, When Illinoisans are burdened with student loan debt, they are not able to buy homes, cars, and other products that boost our economy; and

WHEREAS, College savings plans, such as Bright Start and Bright Directions, help families limit or eliminate future student loan debt by helping them save for future higher education expenses; and

WHEREAS, The contributions families make today pay off in the form of an increased earning potential for their children in the future, with a college graduate earning an average of \$1 million more than a high school graduate during his or her career, according to the United States Census Bureau; and

WHEREAS, May 29th is recognized nationally as 529 College Savings Day to help raise awareness across the country of the importance of saving for college with the help of 529 college savings plans; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we declare May 29, 2021 as 529 College Savings Day in the State of Illinois; and be it further

RESOLVED, That we urge all Illinoisans to explore the benefits that 529 college savings plans offer families; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor of Illinois, the Director of the Illinois Student Assistance Commission, the Treasurer of Illinois, the Director of the Community College Board, and the Director of the Board of Higher Education.

A person may not be elected to the office of State Senator for more than three terms or the office of State Representative for more than five terms. Service before the second Wednesday in January of 2023 shall not be considered in the calculation of a person's service.

ARTICLE V THE EXECUTIVE

(ILCON Art. V, Sec. 2)

SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. They shall be elected at the general election in 1978 and every four years thereafter. A person may not be elected to any Executive Branch office, or any combination of Executive Branch offices, for more than two terms. Service before the second Monday in January of 2023 shall not be considered in the calculation of a person's service.
