Senator Fowler offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 130

WHEREAS, Power generation companies have invested billions of dollars in Illinois to make the state the fifth largest generation state in the country; and

WHEREAS, Unlike California and other States in the Union, Illinois is a net exporter of electricity in the Midwest region; and

WHEREAS, The power industry supports more than 285,000 jobs in Illinois; 103,000 of those jobs are direct high paying jobs that run the power plants 24 hours a day; many if not most of the jobs are union jobs that pay twice the national median salary; and

WHEREAS, The electric power industry accounts for five percent of the Illinois economy, with the industry and its workers accounting for at least \$3.7 billion in taxes in every community in the State; these taxes keep property taxes low in the counties that contain power generation assets; and

WHEREAS, The electric power industry runs plants that keep Illinois electric power reliable and effective; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we strongly support the electric industry in Illinois and stand behind the men and women who operate the electric plants every day and keep the lights on for Illinois citizens; and be it further

RESOLVED, We support keeping Illinois an exporter of power in the Midwest, therefore not relying on other state legislatures for our power; and be it further

RESOLVED, That we support public policy for reliable and moderately priced electric power that will keep large electric power plants operating well into the foreseeable future; and be it further

RESOLVED, That suitable copies of this resolution be sent to the Governor and to the Speaker of the House.

Senator Connor offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 139

WHEREAS, Passed in 2014, PA 98-0632, also known as Lauren's Law, requires all Illinois high schools and secondary schools to teach CPR and AED instruction and training as part of their health curriculum; and

WHEREAS, The CPR and AED training must be incorporated into the health curriculum of a school, but it is not required to be within that specific course time; the law does not specify content, but both the American Red Cross and the American Heart Association require that content must cover lecture, demonstration, and practice; and

WHEREAS, Lauren's Law does not require mouth-to-mouth, mouth-to-facemask, or rescue breathing training but must include hands-on skill delivery; the instruction may be delivered in person, by video, online, by webinar, or by the reading of manuals; and

WHEREAS, Many schools do not have CPR or AED training as part of their curriculum, or they have the training on their syllabus but do not comply; currently, there are no consequences for non-compliance; and

WHEREAS, Untrained bystanders who witness cardiac arrest do not know how to respond to a cardiac emergency, which loses valuable response time; according to the American Heart Association, over 350,000 people die from out of hospital cardiac arrest each year; a person has a 10% chance of surviving an out of hospital cardiac arrest; early recognition of a cardiac arrest and immediate quality CPR is the link to survival; bystander CPR can increase survival by 2-3 times; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we strongly urge the Illinois State Board of Education to enforce compliance of Lauren's Law at all Illinois high schools and secondary schools and to encourage school districts to include the program as early as the 6th grade; and be it further

RESOLVED, That we strongly urge all public schools to become Heart Safe Schools by completing a Cardiac Emergency Response Plan (CERP); and be it further

RESOLVED, As part of the CERP, we urge schools to clearly identify school staff that have CPR and AED certification and offer non-certification CPR and AED training to other staff members; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois State Board of Education.

Senator Plummer offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 22

WHEREAS, On February 27, 1861, in an attempt to avert the secession of Southern states, United States Representative Thomas Corwin of Ohio proposed an amendment to the United States Constitution that would prohibit the United States Constitution from being amended in a manner that authorizes Congress to abolish or interfere with the states' domestic institutions, including slavery; and

WHEREAS, On March 2, 1861, the Corwin Amendment was approved by a joint resolution of the Thirty-Sixth United States Congress (12 Stat. 251) and was submitted to the states under Article V of the United States Constitution for ratification with no deadline given for completion of its ratification; and

WHEREAS, The Twenty-Third General Assembly of the State of Illinois ratified the Corwin Amendment in "An Act ratifying a certain amendment to the Constitution of the United States", in force June 2, 1863 (Public Laws 1863, p. 41); and

WHEREAS, The Corwin Amendment has not yet been ratified by three-fourths of the states and, therefore, is not part of the United States Constitution at this time; and

WHEREAS, It is still possible that a sufficient number of states could belatedly ratify the Corwin Amendment thereby adding it to the United States Constitution, as occurred with the 27th Amendment to the United States Constitution, which was first proposed in 1789 and was not ratified by a sufficient number of states until 1992; and

WHEREAS, With the end of the Civil War and the ratification of the actual 13th Amendment to the United States Constitution in 1865, the purposes of the Corwin Amendment have become moot; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the State of Illinois rescinds its 1863 ratification of the following proposition, known as the Corwin Amendment to the United States Constitution:

"ARTICLE XIII.

No amendment shall be made to the Constitution which will authorize or give to Congress the power to abolish or interfere, within any State, with the domestic institutions thereof, including that of persons held to labor or service by the laws of said State."; and be it further

RESOLVED, That certified copies of this resolution be forwarded to the Archivist of the United States, the President of the United States, the President and Secretary of the United States Senate, the Speaker and Clerk of the United States House of Representatives, and each member of the Illinois congressional delegation with the request that it be printed verbatim in the Congressional Record.
