**SENATE RESOLUTION NO. 706**

WHEREAS, Composting is an effective form of waste reduction, reuse, and recycling, and since organic materials make up approximately 30 percent of the material going to landfills, composting is becoming one of the primary methods communities use to reach waste diversion goals and create sustainable communities; and

WHEREAS, Organic residual materials, including yard trimmings, vegetable cuttings, biosolids, food scraps, manures, and hay shavings, have been composted and converted into a beneficial product known as compost; and

WHEREAS, Returning organic resources, remanufactured in compost, to the soil reduces water consumption by over 30 percent for all soil types, conserves water during extreme drought or flooding conditions, decreases dependence on chemical fertilizers and pesticides, and decreases erosion and nonpoint source pollution; and

WHEREAS, Communities, through their local governments, highway departments, soil conservation services, and public works professionals, can have positive impacts on clean water, soil, climate change, and landfill diversion by using compost for public works projects; and

WHEREAS, Composting creates green jobs and infrastructure for cities and states that implement composting programs; and

WHEREAS, International Compost Awareness Week, scheduled for May 1–7, 2022, is a multimedia publicity and educational initiative designed to showcase compost production and demonstrate compost use and is supported by compost industry organizations from around the world; and

WHEREAS, The theme for 2022 is "Recipe for Regeneration: Compost", which recognizes and promotes the importance of composting and the use of compost in growing healthier food, supporting healthier soils and, ultimately, creating a more just and sustainable world; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of May 1 through May 7, 2022 as "Compost Awareness Week" in the State of Illinois.

**SENATE RESOLUTION NO. 709**

WHEREAS, The Underground Railroad was a network of people offering shelter and aid to escaped enslaved people from the South; and

WHEREAS, Most of the enslaved people helped by the Underground Railroad escaped border states such as Kentucky, Virginia, and Maryland; and

WHEREAS, Hiding places included private homes, churches, and schoolhouses; and

WHEREAS, A former station on the Underground Railroad, the Lovejoy Homestead, is located at the eastern edge of Princeton and was the home of the Denham and Lovejoy families for nearly 100 years; and

WHEREAS, Reverend Lovejoy was its most famous resident and occupied the house from 1838 until his death in 1864; he was prominent in the abolition movement and the Underground Railroad, a founder of the Illinois and national Republican Party, and a congressional leader; and

WHEREAS, Reverend Lovejoy is perhaps best known for his role in the Underground Railroad; as an outspoken abolitionist, he openly proclaimed his willingness to assist fugitive slaves; his involvement made his house one of the most important stations on the Underground Railroad in Illinois; and

WHEREAS, The Owen Lovejoy Home now belongs to the City of Princeton and was opened as a museum in 1972; the United States Secretary of the Interior declared the property a National Historic Landmark in 1997; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Department of Transportation to place road signs in the vicinity of the Owen LoveJoy Homestead directing people to this National Historic Landmark; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois Department of Transportation.

WHEREAS, Many prominent women have been or are members of Alpha Kappa Alpha Sorority, Inc., including the late First Lady Eleanor Roosevelt, the late civil rights leaders Coretta Scott King and Rosa Parks, actress Phylicia Rashad, the late poet Maya Angelou, the late writer Toni Morrison, singer Alicia Keys, attorney Star Jones, financial expert Melody Hobson, comedian/actress Wanda Sykes, actress Jada Pinkett-Smith, Cook County Recorder of Deeds Karen Yarbrough, Cook County Board of Commissioners President Toni Preckwinkle, Vice President Kamala Harris, and the former President of Liberia, Ellen Johnson Sirleaf; and

WHEREAS, Lt. Governor Julianna Stratton and Representative LaToya Greenwood are the newest members of Alpha Kappa Alpha Sorority, Inc.; seasoned members of the sorority include Majority Caucus Chair Mattie Hunter; and

WHEREAS, Alpha Kappa Alpha's storied history of proven leadership and extensive involvement in the world community through strategic partnerships evidence the sorority's potential to significantly contribute to the world community; and

WHEREAS, Alpha Kappa Alpha Sorority, Incorporated made history and expanded its international presence when it chartered its first chapter, Omega Theta Omega, in the Middle East; the chapter's 37 women, located in Abu Dhabi, Dubai and throughout the United Arab Emirates, are business executives, attorneys, educators, and physicians, among other accomplished professionals; and

WHEREAS, Leadership development is essential to the vitality of the organization, and the sorority's continuing requirements of academic excellence, shared values, and dedication to the mission of Alpha Kappa Alpha ensure a continuous wellspring of quality leaders; therefore, be it

#### **SENATE RESOLUTION NO. 723**

WHEREAS, An estimated 54 million Americans have osteoporosis or low bone mass; studies suggest that approximately one in two women and up to one in four men age 50 and older will break a bone due to osteoporosis; and

WHEREAS, Osteoporosis-related bone fractures are responsible for more hospitalizations than heart attacks, strokes, or breast cancer; in a recent yearly total, approximately 1.8 million Medicare beneficiaries suffered approximately 2.1 million osteoporotic fractures; and

WHEREAS, In Illinois, 67,000 Medicare beneficiaries suffered over 79,500 osteoporotic fractures in 2016; and

WHEREAS, The cost for Illinois citizens who suffered an initial and subsequent fracture was estimated at over \$261.9 million; and

WHEREAS, Osteoporosis is often called a silent disease because one cannot feel bones weakening; a broken bone is often the first sign of osteoporosis; timely bone health screening, diagnosis, and treatment can help prevent fractures that can lead to hospitalizations and nursing home stays; and

WHEREAS, Cost-effective post fracture care, which improves care coordination, has been demonstrated to reduce the number of subsequent or repeat fractures yet is not widely available or properly incentivized by Medicare; and

WHEREAS, Osteoporosis and the broken bones it can cause are not a part of normal aging; building strong bones begins in childhood and is essential to the prevention of osteoporosis; care for our bones is vital throughout our lives, but we reach our peak bones mass by early adulthood; and

WHEREAS, Optimum bone health and prevention of osteoporosis can be maximized by a balanced diet rich in calcium and vitamin D, weight-bearing and muscle-strengthening exercise, and a healthy lifestyle with no smoking or no excessive alcohol intake; and

WHEREAS, We must raise awareness about bone health among the public, health professionals, and policymakers; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 2022 as Bone Health and Osteoporosis Month in the State of Illinois; and be it further

RESOLVED, That we appreciate the ideals, goals, and activities of the National Bone Health and Osteoporosis Month in May and encourage appropriate good health programs and activities that promote good bone health throughout the lifetime and prevent osteoporosis.
