WHEREAS, The Gamma Eta Chapter was organized through the efforts of Bessie B. Garvin, an educator and the first president of a group of ten dynamic women, holding the distinction as the first Greek letter organization established in East St. Louis; and

WHEREAS, The Gamma Eta Chapter was renamed the East St. Louis Alumnae Chapter (ESLAC) in 1958: and

WHEREAS, The East St. Louis Alumnae Chapter chartered an undergraduate chapter, Epsilon Xi, on the campuses of Southern Illinois University in Edwardsville and Carbondale in 1964; and

WHEREAS, The East St. Louis Alumnae Chapter crowned Jacqueline Storman Turnage as its first Ms. Delta; and

WHEREAS, The East St. Louis Alumnae Chapter's program, the Mini Teen Lift, provides educational opportunities and cultural awareness for teenagers in the East St. Louis community; and

WHEREAS, One of the East St. Louis Alumnae Chapter's signature programs, Breakfast with Santa, was envisioned in 1971, and it continues to grow and bring joy to hundreds of children in the community each year; and

WHEREAS, The East St. Louis Alumnae Chapter, in partnership with other prominent local organizations, launched the national initiative School America; and

WHEREAS, Through years of commitment, location transitions, and dedication, the East St. Louis Alumnae Chapter broke ground on the Delta Child Development Center at 1012 South 15th in East St. Louis in 1988; and

WHEREAS, The East St. Louis Alumnae Chapter and the Delta Economic Development Corporation broke ground on a new childcare playground in 1993, which serves both the State Community Drop-in Center and the Delta Child Development Center; and

WHEREAS, Members of the East St. Louis Alumnae Chapter partnered with Habitat for Humanity on July 17, 1994, building five homes in the 500 block of 49th Street in East St. Louis; and

WHEREAS, The East St. Louis Alumnae Chapter has more than 250 members today and is currently led by President Pamela M. Weston; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare June 6, 2022 as Delta Sigma Theta Gamma Eta Chapter Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the East St. Louis Alumnae Chapter as an expression of our esteem and respect.

Senator Rezin offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 1239

WHEREAS, Agents of the Iranian regime arrested and beat Mahsa (Zhina) Amini, a 22-year-old Iranian woman, on September 13, 2022, for not fully covering her hair; and

- WHEREAS, The brutal beating reportedly knocked Mahsa Amini unconscious, and she remained in a coma for three days; and
- WHEREAS, On September 16, 2022, Mahsa Amini died from the injuries she received from governmental thugs; and
- WHEREAS, The murder of Mahsa Amini ignited a spark, inspiring the people of Iran to rise up against their oppressors, calling for freedom and human dignity; her death, coming after years of oppression, arrests, and executions, set off a firestorm, first on social media and then on the streets of Iran; and
- WHEREAS, Protests started in Mahsa Amini's home province and spread across Iran, uniting disparate ethnic groups, such as the Kurds, Persians, Baloch, and Azerbaijanis, against the regime; and
- WHEREAS, Shervin Hajipour composed a song, threading together Twitter posts hashtagged MahsaAmini, to explain the multitude of reasons behind the protests; and
- WHEREAS, Shervin Hajipour was arrested by the government, and the song taken down shortly after he posted it online; and
- WHEREAS, Shervin Hajipour's song, particularly one phrase, women, life, freedom, has been taken up by Iranian protestors in defiance of the regime and its totalitarian henchmen; and
- WHEREAS, Social media is replete with videos and images of women and schoolgirls baring their heads, burning their mandatory head coverings, destroying regime photos of Iran's dictator, Supreme Leader Ali Khamenei, and reclaiming their schools and public spaces, even if only momentarily, from the dictates of the regime's centralized bureaucracy; and
- WHEREAS, Videos show these same women and schoolgirls chanting the slogan, women, life, freedom, in defiance of the government; and
- WHEREAS, Despite the government's repression, protests have continued to spread, often led by women, including Hadis Najafi, who, while boldly protesting, was shot six times and was tragically killed by the regime, and the teenager Nika Shakarami, whose mutilated and abused body was finally released by the government to her family days after she disappeared during a protest; and
- WHEREAS, In Zahedan, Iran, governmental forces attacked protestors, killing an unknown number of the local Baloch minority who were protesting the death of Mahsa Amina and the purported rape of a local 15-year-old girl by a commander in the regime's Revolutionary Guard; and
- WHEREAS, The Iranian government has sought to undermine the protest movement by cutting access to the internet, censuring its opponents, and blaming the unrest on foreign agitation and disinformation; and
- WHEREAS, An unknown number of Iranians have been killed in the governmental crackdown against the protests, and many more protestors have been arrested; and
- WHEREAS, Shortly after the protests began, an Iranian missile attack on Iraqi Kurdistan killed an American woman and 12 Kurds while injuring countless others; and
- WHEREAS, Per reports on social media trickling out of the country, Iranian citizens in Tehran continued to chant anti-governmental slogans and to call for the fall of the regime from their windows and balconies at night despite the regime's brutal suppression techniques; and
- WHEREAS, The Iranian people have risen time and time again against their authoritarian government, only to be repressed and terrorized over and over again; and

WHEREAS, The Iranian regime has ruthlessly snuffed out protests in the past, arresting and killing its own citizens, such as Navid Afkari, a young Iranian wrestler who was hanged on September 12, 2020, on dubious charges and without due process; and

WHEREAS, Iran has the highest number of executions per capita of any country in the world; and

WHEREAS, Iran, under the leadership of Supreme Leader Khamenei, a modern-day Yazid, has been the leading state sponsor of terrorism, according to the U.S. State Department; and

WHEREAS, Iran has repeatedly taken U.S. and other allied citizens hostage, holding them in deplorable conditions, in demand for huge ransoms and other concessions; and

WHEREAS, Iran played a direct role in the deaths of at least 603 U.S. service members in Iraq and an unknown number in Afghanistan; and

WHEREAS, Iran, using the billions of dollars released by the Joint Comprehensive Plan of Action (JPCOA), joined with Russia's President Vladimir Putin to brutally repress the Syrian revolution, contributing to hundreds of thousands dead, millions displaced, and a global refugee crisis; and

WHEREAS, Iran forced Afghan refugees in Iran to take up arms in Syria against the Syrian people; and

WHEREAS, Iran seized ten U.S. sailors in the Arabian Gulf in early 2016, broadcasting photos of their capture and captivity prior to releasing them; and

WHEREAS, Iran has provided and continues to provide arms and support to groups hostile to the U.S. and its allies; it has supplied warfighting materials to Russian President Putin for use in Ukraine; and

WHEREAS, Iranian governmental revenues and instances of international provocation, including attacks on U.S. flagged shipping and on U.S. allies, have soared since the beginning of 2021; and

WHEREAS, Iranian-aligned groups have repeatedly sought to interfere in U.S. elections, disrupting the democratic process; and

WHEREAS, Iran unleashed a massive cyberattack on Albania, a NATO ally, in July 2022, causing the country to consider invoking Article 5 of the treaty organization; and

WHEREAS, Iran has recently plotted to assassinate former American officials and to kidnap Masih Alinejad, a prominent Iranian activist living in New York; and

WHEREAS, On August 12, 2022, a would-be assassin attacked Salman Rushdie in New York; he had been targeted for assassination by the Iranian government, and the attacker sympathized with the Iranian regime; and

WHEREAS, Since the beginning of 2021, the Iranian regime has made rapid, irreversible strides in developing its nuclear program; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we stand with the Iranian martyrs to liberty who are currently dying on the streets and in the prisons of Iran; and be it further

RESOLVED, That we join with the Iranian protestors who are fearlessly confronting a despotic regime, demanding freedom, dignity, and a better future, and urge President Biden and the members of the Illinois Congressional Delegation to eschew any further negotiations with or cash releases to the Iranian regime while it is murdering its own citizens; and be it further

RESOLVED, That the U.S. use this opportunity to once more unfurl America's standard as a bulwark of freedom and liberty against the forces of oppression and tyranny in a troubled world; and be it further

RESOLVED, That we urge President Biden and the members of the Illinois Congressional Delegation to use America's influence on the world stage to work with the United States' international partners to isolate the Iranian regime; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Biden and all members of the Illinois Congressional Delegation.

WHEREAS, After graduating from Elkville High School, Officer Pierce became the trainer and treasurer of the Elkville Fire Department as well as a correctional officer with the Menard Correctional Facility; and

WHEREAS, In 2017, Officer Pierce moved to Makanda, where he joined the Makanda Township Fire Department; while there, he spent every Monday night training younger firefighters; and

WHEREAS, In 2019, Officer Pierce assisted the mayor of Spillertown in constructing a police department that had not existed for ten years, which included assisting in applying for funding and grants and helping with day to day operations; and

WHEREAS, Officer Pierce became a police officer in Brooklyn and was killed in the line of duty on August 4, 2021 while deploying stop sticks to halt a vehicle fleeing police; and

WHEREAS, At the time of his death, Officer Pierce was survived by his parents, a sister, and a niece and nephew; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate the section of Illinois Route 37 from Longstreet Road to Prosperity Road as it passes Spillertown as the "Officer Brian Pierce Jr. Memorial Highway"; and be it further

WHEREAS, Deputy Weist served as union president, a taser instructor, and a leader in a number of different organizations within the Knox County Sheriff's Office; he organized the Explorer's Program for kids interested in law enforcement at Aledo High School, headed up college recruiting for the department, and raised funds and participated in Shop with a Cop throughout his career; he also served as a volunteer for the Viola Fire Department; and

WHEREAS, Deputy Weist loved anything outdoors; he especially enjoyed mountain biking and fishing with his kids; he also enjoyed deer hunting, cooking, and playing video games; he was passionate about everything he did; and

WHEREAS, Deputy Weist's first priority was his family; he was a devoted husband and father to Jessica and their children, Ava, age 12, and Emery, age 9; and

Senator Fine offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### SENATE JOINT RESOLUTION NO. 60

WHEREAS, In 1972, the Ninety-second Congress of the United States of America, at its Second Session, in both houses, by a constitutional majority of two-thirds, adopted the following proposition to amend the Constitution of the United States of America:

"JOINT RESOLUTION RESOLVED BY THE HOUSE OF REPRESENTATIVES AND SENATE OF THE UNITED STATES OF AMERICA IN CONGRESS ASSEMBLED (TWO-THIRDS OF EACH HOUSE CONCURRING THEREIN), That the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents

and purposes as a part of the Constitution when ratified by the legislatures of three-fourths of the several States within seven years from the date of its submission by the Congress:

"ARTICLE

Section 1. Equality of rights under the law shall not be denied or abridged by the United States or by any State on account of sex.

Section 2. The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

Section 3. This amendment shall take effect two years after the date of ratification.""; and

WHEREAS, Article V of the Constitution of the United States sets forth a two-step amending procedure; and

WHEREAS, The first step of the Article V amending procedure is proposal of an amendment either by two-thirds vote of both houses of Congress or by a convention called by application of two-thirds of the States: and

WHEREAS, The second and final step of the Article V amending procedure is ratification of an amendment by three-fourths of the States; and

WHEREAS, The Constitution of the United States does not limit the time for States to ratify an amendment; and

WHEREAS, The Constitution of the United States does not grant Congress the authority to limit the time for States to ratify amendments; and

WHEREAS, A time limit on State ratifications of amendments is a substantive change to the Constitution of the United States; and

WHEREAS, To have full force and effect, any substantive change to the Constitution of the United States must be within the text of an amendment, where it can be approved as part of each of the two steps of the Article V amending procedure; and

WHEREAS, The time limit on State ratifications of the Equal Rights Amendment is within only the internal resolution used by Congress in the proposal step and not within the text of the amendment; and

WHEREAS, In the ratification step, the States ratified only the text of the Equal Rights Amendment; and

WHEREAS, The time limit within the internal resolution used by Congress in 1972 to propose the Equal Rights Amendment is, thus, without force or effect; and

WHEREAS, The most recent constitutional amendment to be proposed by two-thirds vote of both houses of Congress was the District of Columbia Voting Rights Amendment in 1978; and

WHEREAS, Congress included a time limit within the text of the District of Columbia Voting Rights Amendment, in order for that time limit to have full force and effect; and

WHEREAS, The time limit for the District of Columbia Voting Rights Amendment ended before completion of the second and final step of ratification of the amendment by three-fourths of the States; and

WHEREAS, Because the time limit was within the text of the District of Columbia Voting Rights Amendment, that time limit had full force and effect and that amendment did expire in 1985; and

WHEREAS, The so-called Madison Amendment, relating to Compensation of Members of Congress, is the Twenty-Seventh Amendment to the Constitution of the United States; and

WHEREAS, In 1789, by two-thirds vote of each house of the First Congress, the Madison Amendment completed the proposal step of Article V; and

WHEREAS, Approximately 203 years later, the Madison Amendment completed the ratification step of Article V through ratification by three-fourths of the States; and

WHEREAS, In 1992, having met the strict two-step requirements of Article V, the Madison Amendment was published by the Administration of President George H.W. Bush as the Twenty-Seventh Amendment to the Constitution of the United States; and

WHEREAS, Following publication of the Madison Amendment, Congress affirmed the Madison Amendment as the Twenty-Seventh Amendment to the Constitution of the United States; and

WHEREAS, As of January 27, 2020, three-fourths of the States have ratified the Equal Rights Amendment; and

WHEREAS, Unlike the District of Columbia Voting Rights Amendment, the Equal Rights Amendment does not have a time limit in its text where it would be of full force and effect; and

WHEREAS, In contrast to the Madison Amendment which took 203 years to ratify, the Equal Rights Amendment took a mere 48 years to ratify; and

WHEREAS, The text of Article V of the Constitution references only ratification, not rescission; and

WHEREAS, Samuel Johnson's dictionary of 1755 defines "ratify" as "to confirm; to settle"; and

WHEREAS, Bouvier's Law Dictionary of 1856, considered to be the first American legal dictionary, states that a ratification once done, "cannot be revoked or recalled"; and

WHEREAS, James Madison wrote in a July 20, 1788 letter to Alexander Hamilton that ratification is "in toto and for ever"; and

WHEREAS, The various attempts throughout history to rescind the ratifications of the Constitution of the United States or its amendments, including the Fourteenth, Fifteenth, and Nineteenth Amendments, have never been honored; and

WHEREAS, The Equal Rights Amendment now meets the strict requirements of Article V of the Constitution of the United States to be added as the Twenty-Eighth Amendment; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the General Assembly urges the Administration of President Joseph R. Biden, Jr. to publish without delay the Equal Rights Amendment as the Twenty-Eighth Amendment to the Constitution of the United States; and be it further

RESOLVED, That the General Assembly urges the Congress of the United States to pass a joint resolution, affirming the Equal Rights Amendment as the Twenty-Eighth Amendment to the Constitution of the United States; and be it further

RESOLVED, That the General Assembly calls on other States to join in this action by passing the same or similar resolutions; and be it further

RESOLVED, That suitable copies of this resolution be transmitted to the President and Vice President of the United States, to Members of the United States Congress, and to the Archivist of the United States.

#### SENATE JOINT RESOLUTION NO. 61

WHEREAS, The Congress of the United States of America has enacted both the Government Pension Offset, which reduces the spouse and survivor Social Security benefit, and the Windfall Elimination Provision, which reduces the earned Social Security benefit payable to any person who also receives a public pension benefit; and

WHEREAS, The Government Pension Offset negatively affects a spouse or survivor receiving a federal, state, or local government retirement or pension benefit who would also be entitled to a Social Security benefit earned by a spouse; and

WHEREAS, The Government Pension Offset formula unfairly reduces the spouse or survivor Social Security benefit by two-thirds of the amount of the federal, state, or local government retirement or pension benefit received by the spouse or survivor, in many cases completely eliminating the Social Security benefit even though the survivor's spouse paid Social Security taxes for many years; and

WHEREAS, The Government Pension Offset has a harsh effect on hundreds of thousands of citizens and undermines the original purpose of the Social Security dependent and survivor benefit; and

WHEREAS, According to the Congressional Research Service, more than 700,000 people nationally are affected by the Government Pension Offset and approximately 2,000,000 people nationally are affected by the Windfall Elimination Provision; and

WHEREAS, In certain circumstances, both the Windfall Elimination Provision and Government Pension Offset can be applied to a qualifying survivor's benefit, each independently reducing the available benefit and, in combination, eliminating a large portion of the total Social Security benefit available to the survivor; and

WHEREAS, The calculation characteristics of the Government Pension Offset and the Windfall Elimination Provision have a disproportionately negative effect on employees working in lower-wage government jobs, such as police officers, firefighters, teachers, and state employees; and

WHEREAS, Illinois is making every effort to improve the quality of life of its citizens and to encourage them to live in the State, yet the Government Pension Offset and Windfall Elimination Provision compromise their quality of life; and

WHEREAS, The number of people affected by the Government Pension Offset and Windfall Elimination Provision is growing every day as more and more people reach retirement age; and

WHEREAS, Individuals affected by the Government Pension Offset or Windfall Elimination Provision may have no choice but to return to work after retirement in order to earn enough income to provide for their basic needs, but the earnings accumulated during this return to work can further reduce the Social Security benefits to which the individual is entitled; and

WHEREAS, The Government Pension Offset and Windfall Elimination Provision are established in federal law, and the repeal of the Government Pension Offset and the Windfall Elimination Provision can only be enacted by Congress; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we urge the Congress of the United States to enact legislation to repeal the Government Pension Offset and the

Windfall Elimination Provision from the Social Security Act and for President Joe Biden to sign that legislation into law; and be it further

RESOLVED, That a suitable copy of this resolution be sent to the President of the United States, the Vice President of the United States, and the entire Illinois congressional delegation.
