SENATE RESOLUTION NO. 30

Offered by Senator Rose and all Senators:
Mourns the death of John Virgil "Jack" Fishel Jr. of Arcola.

SENATE RESOLUTION NO. 32

PRESENTATION OF RESOLUTIONS

Senator Feigenholtz offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 28

WHEREAS, The Illinois Department of Public Health's May 2022 report recorded 3,013 fatalities that occurred in 2021 due to opioid overdoses; and

WHEREAS, The 3,013 Illinois opioid overdose deaths represent a 2.3% increase from 2020 and a 35.8% spike from 2019; and

WHEREAS, In 2021, toxicology testing found that 2,672 (89%) of the opioid fatalities involved a synthetic opioid, such as fentanyl; and

WHEREAS, A 4 milligram naloxone hydrochloride nasal spray has been the principal tool used by bystanders and emergency medical services (EMS) to revive an individual from an overdose episode; and

WHEREAS, A study, published in the Harm Reduction Journal in May 2022, surveyed 125 adult U.S. residents who had been administered a 4 milligram naloxone nasal spray during an opioid overdose and found that 78% used 2 or more doses and 30% used 3 or more doses of naloxone; and

WHEREAS, A 2021 Johns Hopkins Bloomberg School of Public Health study published in the Harm Reduction Journal reported on a survey of 171 people who use opioids in suburban Maryland; sixty-one (35.7%) of these people who use opioids had received take-home naloxone over a six month period; 57% of naloxone recipients used it to reverse an overdose; 79% of overdose reversals reported needing more than 2 doses; and

WHEREAS, Published by the National Library of Medicine, a study of the National Emergency Medical Services Information System Database of more than 10,000 EMS agencies across 47 states with

946,000 calls giving naloxone shows that use of naloxone multi-dosing by EMS increased 54% over five-years, from 18.4% to 28.4% in 2020; and

WHEREAS, On April 30, 2021, the U.S. Food and Drug Administration approved a higher 8 milligram dose of naloxone hydrochloride nasal spray product to treat opioid overdose; and

WHEREAS, On October 19, 2021, the U.S. Food and Drug Administration also approved a single-dose, pre-filled syringe that delivers 5 milligrams of naloxone hydrochloride solution through intramuscular (in the muscle) or subcutaneous (under the skin) injection; and

WHEREAS, Thirty-four U.S. states have open access to the 8 milligram naloxone nasal spray on their Naloxone Standing Orders, including Ohio, Kentucky, Iowa, Pennsylvania, Massachusetts, New Jersey, Virginia, Alabama, Florida, Tennessee, Colorado, Alaska, New Hampshire, Illinois, Arizona, Kansas, California, Texas, Georgia, South Carolina, North Carolina, West Virginia, Michigan, Connecticut, Oklahoma, Minnesota, Maine, Louisiana, Nevada, Idaho, Oregon, Nebraska, and Vermont; and

WHEREAS, Thirteen state government agencies have purchased the 8 milligram naloxone nasal spray, including Alabama, Alaska, Colorado, Florida, Idaho, Iowa, Kentucky, New Hampshire, Ohio, Pennsylvania, Tennessee, Wisconsin, and West Virginia; and

WHEREAS, The U.S. Veterans Administration added the 8 milligram naloxone nasal spray to the National Formulary in November 2021; and

WHEREAS, Seventy percent of the number of lives covered by commercial insurance in the U.S. can access the 8 milligram naloxone nasal spray; and

WHEREAS, Ninety percent of the number of lives covered by Medicaid insurance in the U.S. (40 states) can access the 8 milligram naloxone nasal spray, including Illinois; and

WHEREAS, The current cost of the 4 milligram naloxone nasal spray is \$5.93 per milligram and the 8 milligram version is \$3.75 per milligram, or 36.7 percent less; and

WHEREAS, Being good stewards of taxpayer money is a priority for the Illinois General Assembly; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we strongly urge the Illinois Department of Human Services to review the value of expanding its naloxone tool kit to include all U.S. Food and Drug Administration-approved versions of naloxone or other FDA-approved products to fight the Illinois opioid epidemic; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor of Illinois, the Governor's Chief Behavioral Health Officer, the Secretary of the Department of Human Services, and the Director of the Division of Substance Use, Prevention and Recovery.

Senator Johnson offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 29

WHEREAS, From a very young age, Richard "Rick" Drazner was primed for a lifelong commitment to service above self; he harnessed those skills into a 25-plus year commitment to serving the residents and businesses of the Village of Buffalo Grove; he was a dedicated public servant, a business leader, a religious leader, and a great friend to many in his community; and

WHEREAS, Rick Drazner was a true servant to his community, an unsung hero who was instrumental to the enhancement, betterment, and improvement of the Village of Buffalo Grove; he was a member of the

Rotary Club of Buffalo Grove for 25 years, serving as president from 2004 to 2005; as a member, he was instrumental in providing vocational scholarships for years; he also attended numerous fundraising events, district conferences, and the Rotary International Conference in Chicago in 2005; and

WHEREAS, During his public service as a commissioner of the Buffalo Grove Park District for 20 years, Rick Drazner was instrumental in the growth and development of many great parks, including Willow Stream Park, the Mike Rylko Park, and Kendrigan Field at Twin Creeks Park, which is a Buddy Baseball field; he was involved in the growth of many of the facilities, such as the fitness center, the golf dome, and the community arts center, where one of his favorite programs, Broadway Buddies, was developed; his involvement in these improvements has led the Village of Buffalo Grove to be given the perennial ranking in the top 50 best towns in the nation to live and the best Chicago suburb to raise a family; in addition to his innovative and active leadership on the park board, he attained the designation of Master Board Member by the Illinois Association of Park Districts for his outstanding service, leadership, and dedication to advancing parks, recreation, conservation, and special recreation agencies throughout Illinois; and

WHEREAS, Rick Drazner was an engaged leader in the business community for more than 25 years; he served as a member of the Buffalo Grove Lincolnshire Chamber of Commerce for 25-plus years, during which he served as president, vice president, treasurer, and director; during his tenure as president, he enhanced the speaker education program, initiated innovative programs to add value to members' investment, and created an awareness initiative to highlight and promote businesses in Buffalo Grove; and

WHEREAS, Rick Drazner embraced the Buffalo Grove community as a religious leader as well; he served as president and vice president of his temple, Congregation Beth Judea, where he taught religious study courses during service; he is remembered by numerous young adults in his community for additionally serving as their camp counselor and positively impacting their lives; and

WHEREAS, Rick Drazner truly exemplified the spirit of a selfless public servant; he wanted to make the world a little better each day, and he served at the highest level so that Buffalo Grove and the world community was ameliorated through the great service that he consistently provided over the course of his life; he did all of this with an incredibly positive attitude and always with his special humor to keep people smiling; and

WHEREAS, Rick Drazner passed away on April 5, 2019, three days after being reelected to the park board of commissioners; his life of service was commemorated in Twin Creeks Park, which was later renamed the Rick Drazner Park; and

WHEREAS, Rick Drazner was a loving husband and father; most of all, he was a giver of himself and a friend to all around him, and he supported and deeply believed in service above self; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we mourn the passing of Rick Drazner and declare July 10, 2023 as Rick Drazner Day in the State of Illinois; and be it further

SENATE RESOLUTION NO. 31

WHEREAS, Hinduism is the third largest religion in the world with more than one billion followers worldwide and six million in the United States; and

WHEREAS, During the month of October, the culture, history, traditions, achievements, and contributions of Hindus are recognized and celebrated throughout the United States; and

WHEREAS, American Hindus have made numerous positive contributions in all aspects of society, from science to business to politics to spirituality; and

WHEREAS, Illinois' vibrant American Hindu community has contributed tremendously to the vitality of the State and enriched the lives of its citizens; and

WHEREAS, Hindus strive to achieve dharma, which is a code of living that emphasizes good conduct and morality; and

WHEREAS, The American Hindu community will collectively celebrate its heritage during the month of October by focusing on its culture and the diverse spiritual traditions rooted in India; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of October 2023 as Hindu Heritage Month in the State of Illinois.

Senator Lewis offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 33

WHEREAS, For half a century, the Illinois Court Reporters Association (ILCRA) has been the preeminent association in Illinois to provide continual training to Certified Shorthand Reporters (CSRs), also known as court reporters, on professionalism, neutrality, confidentiality, and ethics for the benefit of all litigants, defendants, and the people of this State; and

WHEREAS, Illinois court reporters are licensed CSRs who diligently serve as Guardians of the Record, safeguarding litigants' personal, private, confidential, and proprietary information so that such information is not improperly released to the public; and

WHEREAS, Using advanced technology, court reporters write in shorthand, a simultaneous verbatim report of the spoken word, in pretrial depositions and hearings, trials, arbitrations, and sworn statements which are the critical foundation to the pursuit of justice in every legal proceeding; and

WHEREAS, Illinois shorthand reporters and real-time captioners provide Communication Access Realtime Translation (CART) by captioning for attorneys, litigants, and jurors in legal proceedings, at business meetings, at educational classes and lectures, at sporting events, and at arts performances for many Illinoisans who are deaf or hard-of-hearing, have auditory processing disabilities, or for whom English is not their first language; and

WHEREAS, Court reporters and captioners preserve history for all Americans by translating spoken word into readable, searchable, storable, and usable text and electronic media; and

WHEREAS, Illinois CSRs are licensed by the State as the services provided by shorthand reporters and court reporters have long been declared to affect the public health, safety, and welfare of the people of Illinois; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 4 through February 11, 2023 as Court Reporting and Captioning Week in the State of Illinois.

Senator D. Turner offered the following Senate Resolution, which was referred to the Committee on Assignments:

[January 31, 2023]

SENATE RESOLUTION NO. 36

WHEREAS, The opioid crisis has exacted a terrible toll on our State and nation over the past three decades, including the loss of over 3,000 Illinoisans to overdose in 2021 alone, which is a nearly 36% increase in just two years of an epidemic that has hit some areas, including many rural regions and some communities of color, particularly harshly; and

WHEREAS, The countless victims of the opioid epidemic include young children, the most vulnerable and helpless; every 25 minutes in the United States, a baby is born suffering from opioid withdrawal, also known as Neonatal Abstinence Syndrome (NAS); Illinois' own NAS rate grew 64% between 2011 and 2017 alone; and

WHEREAS, Babies born with NAS face a higher likelihood of experiencing health complications at birth, as well as long-term health challenges and developmental delays; and

WHEREAS, Overdose is now the leading cause of maternal death in Illinois, adding to the many challenges experienced by young children, their families, and communities; and

WHEREAS, Parental substance use disorder is considered an Adverse Childhood Experience (ACE), and research consistently shows that children experiencing ACEs are more likely than their peers to grow up to use drugs themselves and face physical and mental health challenges, as well as educational difficulties that can impact their ability to succeed later in life; and

WHEREAS, Recognizing the need to address these issues, the Children and Families Committee of the Illinois Opioid Crisis Response Advisory Council has called for increased focus on how this drug epidemic has impacted children and their households; and

WHEREAS, During development of the most recent iteration of the State Opioid Action Plan (SOAP), that committee made a number of relevant recommendations for increasing supports for affected children and families, in addition to strengthening the systems that help them; and

WHEREAS, Several key birth-to-3 programs have been shown to play an important role in remediating the detrimental effects of opioid use disorder as well as preventing future such problems, among many other positive health outcomes; and

WHEREAS, Voluntary home-visiting programs are one key example of these initiatives, services provided through such evidence-informed models as Healthy Families America, Nurse Family Partnership, BabyTALK, and Parents As Teachers, in which trained professionals visit the homes of new or expecting parents and their young children to help support a wide variety of health, education, and developmental needs; and

WHEREAS, Quality home-visiting services have been shown to help build resilience among young children and reduce the likelihood that they experience ACEs and become involved in later-in-life drug use and crime, thus playing an important prevention role, and can also help connect parents with any substance-use recovery services they might need; and

WHEREAS, The Maternal Morbidity and Mortality Report published in 2021 by the Illinois Department of Public Health recommends expanding home-visiting programs as a key strategy for addressing these significant maternal health challenges; and

WHEREAS, Early Intervention services are another vital birth-to-3 priority, providing physical, developmental, speech, and other therapies desperately needed by infants and toddlers with developmental delays or disabilities, or risks of such challenges, which are experienced more often by children born with NAS; and

WHEREAS, Our State's existing home-visiting and Early Intervention programs, which are administered through the Illinois Department of Human Services and work with local-level service providers statewide, are limited by existing resources, preventing them from reaching all the children and families who could benefit from high-quality birth-to-3 services; and

WHEREAS, These longstanding shortcomings include inadequate compensation for hardworking and often-overextended community-level service providers and support staff, fueling high caseloads and staff turnover; and

WHEREAS, It is an urgent priority to identify and pursue promising new sources of support for these early childhood initiatives that have a demonstrated history of beneficial outcomes for children, their families, their communities, and our entire State; and

WHEREAS, One potential and appropriate source of funding is represented in the settlement of several lawsuits against the manufacturers and distributors of opioids, lawsuits that were initially filed by a number of Illinois state's attorneys and ultimately combined with others across the country; and

WHEREAS, The Illinois Attorney General has joined in negotiating the settlement of these national lawsuits that are leading to hundreds of millions of dollars in new resources for Illinois over the course of two decades, intended to strengthen efforts at drug treatment and remediation, as well as prevention of future opioid problems; and

WHEREAS, Determination of the use of these forthcoming resources is split between local-level and state-level decision makers, with the latter being aided by an Illinois Opioid Remediation Advisory Board; and

WHEREAS, One approved use of these settlement funds, as delineated in the Illinois Opioid Allocation Agreement, is to address the needs of pregnant or parenting women and their families, including babies with NAS; and

WHEREAS, Members of the nonprofit, bipartisan Fight Crime: Invest in Kids organization, representing 340 Illinois police chiefs, sheriffs, and prosecutors, including those from several of the state's attorney's offices that initiated a number of these very same lawsuits, strongly support the use of these settlement dollars for home-visiting and Early Intervention services as an important way to aid our State's response to the opioid epidemic; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support home-visiting and Early Intervention programs as an essential component of our State's multifaceted approach to the opioid crisis, helping remediate many of its corrosive impacts on young children, their parents, and families, while also assisting efforts at preventing children from future struggles with substance use disorders of their own; and be it further

RESOLVED, That we affirm these vital birth-to-3 services are a top priority for increased public resources, to strengthen their quality and extend their reach to more of the children, parents, and families who could benefit from them, particularly in communities of greatest need and those hit hardest by the opioid epidemic; and be it further

RESOLVED, That we affirm home-visiting and Early Intervention services are an appropriate and necessary use for some of the hundreds of millions of funding coming to Illinois from the settlement of lawsuits against opioid makers and distributors, initiatives that can help meet the settlements' stated aims of boosting opioid remediation, treatment, and prevention; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the offices of the Governor, the Lieutenant Governor, the Attorney General, the Illinois Department of Human Services, the Illinois Department of Public Health, the Governor's Opioid Prevention and Recovery Steering Committee, the

Illinois Opioid Crisis Response Advisory Council, and the Illinois Opioid Remediation Advisory Board.

Senator Joyce offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 7

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the Recruiting & Retaining Public Employee Firefighters and Paramedics Task Force is created to identify solutions to the shortage of eligible applicants for the position of firefighter and/or paramedic and is charged with examining the following:

- (1) The barriers to the recruitment and retention of public employee firefighters and paramedics;
- (2) The steps that the State of Illinois can take to assist local governments to recruit and retain public employee firefighters and paramedics;
- (3) What community colleges, the Illinois Fire Service Institute, the Illinois Department of Public Health, and the Office of the State Fire Marshal can do to assist local governments to recruit and retain public employee firefighters and paramedics;
- (4) How Monetary Award Program (MAP) grants can be utilized to recruit and retain public employee firefighters and paramedics;
- (5) How paramedic licensure and testing/certification requirements affect the recruitment and retention of public employee firefighters and paramedics;
- (6) The statewide hiring provisions currently in statute as an alternative method of selecting and hiring firefighters;
- (7) How apprenticeship Programs (local, regional, statewide) can be utilized to recruit and retain public employee firefighters and paramedics;
- (8) How the minimum requirements to apply to an Illinois local government fire department affect the recruitment and retention of public employee firefighters and paramedics;
- (9) The requirement for fire department sponsorship in order to attend an Illinois fire academy;
- (10) How well the State of Illinois provides a pathway for qualified individuals to obtain the necessary skills to seek employment as a firefighter and paramedic as a public employee in the State of Illinois; and
- (11) All other areas that the Task Force deems necessary to examine to assist in the recruitment and retention of public employee firefighters and paramedics; and be it further

RESOLVED, That the Task Force will be comprised of the following 19 members, who shall serve without compensation:

- (1) 4 members of the Illinois General Assembly, one each appointed by the Senate President, the Speaker of the House, the Senate Minority Leader, and the House Minority Leader; the General Assembly members appointed by the Senate President and Speaker of the House shall serve as Co-Chairs;
- (2) 3 members representing the Associated Fire Fighters of Illinois and 3 members representing the Illinois Fire Chiefs Association, all appointed by the Senate President;
- (3) 3 members representing a statewide organization of municipalities as authorized by Section 1-8-1 of the Illinois Municipal Code, all appointed by the Speaker of the House;
- (4) 1 member representing the Northern Illinois Alliance of Fire Protection Districts and 1 member representing the Illinois Fire Service Institute, both appointed by the Minority Leader of the Senate;
- (5) 1 member representing the Illinois Association of Fire Protection Districts and 1 member representing the Illinois Community College Systems, both appointed by the Minority Leader of the House; and
- (6) 1 member representing the Office of the State Fire Marshal and 1 member representing the Illinois Department of Public Health, both appointed by the Governor; and be it further

RESOLVED, That the Task Force shall convene at the call of the Co-Chairs and shall hold at least five meetings; and be it further

RESOLVED, That the Office of the State Fire Marshal shall provide administrative support for the Task Force; and be it further

RESOLVED, That the Task Force shall submit its final report to the General Assembly and the Governor no later than January 1, 2024, and upon the filing of its final report, the Task Force is dissolved.

Senator Rezin offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 8

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to individuals who have given their lives in the line of duty; and

WHEREAS, Marshal Enoch T. Hopkins was born in Jefferson, Maine on March 22, 1824; he began his long career as a law enforcer shortly after coming to Morris, Illinois in the summer of 1854; and

WHEREAS, Marshal Hopkins' honorable service was tragically cut short when he was killed in the line of duty on September 14, 1878; and

WHEREAS, On the night of September 14, notorious roughs Frank Foster and Charles Miller came to town, where the pair shortly became intoxicated; and

WHEREAS, Marshal Hopkins advised the men several times over the course of the evening to go home as they became disorderly; the pair ignored the multiple warnings they received and persisted with their drinking until late into the evening; and

WHEREAS, Around midnight, Marshal Hopkins found it necessary to arrest the two intoxicated men and caught them in a downtown alleyway; as he was leading them out of the alley, the men fled on foot; and

WHEREAS, Marshal Hopkins pursued the men when Charles Miller suddenly drew his revolver and fired twice at the officer, who was hit by one of the shots and died almost instantly; and

WHEREAS, The funeral for Marshal Hopkins was the largest seen in Morris at the time; he was an honored member of the Masonic Order, a great, noble man, and a respected citizen of the community; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate the portion of Illinois Route 47 over Interstate 80 from Romines Drive to Illinois Route 6 East as the "Marshal Enoch T. Hopkins Memorial Road"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of the "Marshal Enoch T. Hopkins Memorial Road"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Marshal Hopkins, the Secretary of the Illinois Department of Transportation, the Morris Police Department, and the Mayor of the City of Morris.

Senator Bennett offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 9

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to the truly great individuals who have served our country and, in doing so, have made the ultimate sacrifice for our nation; and

WHEREAS, SP4 William Eugene Campbell was born to Ida Marie and Kenneth Campbell on October 24, 1948; he was one of eight children along with his brother, Bob Campbell, and his six sisters, Sandy Painter, Betty Evans, Judy Buchanan, Joyce Borchers, Janet Barker, and Jeanne Taylor; and

WHEREAS, SP4 Campbell graduated in June of 1968 from Gibson City High School at a trying time for many young men due to the heavy involvement of the United States in the Vietnam War; and

WHEREAS, Like many others facing the draft, SP4 Campbell was called to serve in the U.S. Army on August 12, 1968; and

WHEREAS, Just under a year into his service on August 2, 1969, SP4 Campbell was killed in action, the first and only casualty from Gibson City; and

WHEREAS, SP4 Campbell received several recognitions for his actions in Vietnam, including the Silver Star, which was presented to his mother Ida, for the time he "distinguished himself as a leader in Company B, First Airborne Battalion, 501st Infantry, 101st Airborne Division, USARV, during a search and clear operation near the city of Tam Ky, Republic of Vietnam"; and

SENATE JOINT RESOLUTION NO. 10

WHEREAS, It is appropriate to remember the many sacrifices and contributions to the cause of freedom made by the outstanding men and women who have served in the United States Armed Forces; and

WHEREAS, From 1946 to 1962, the United States conducted approximately 200 atmospheric nuclear tests, more than all other nuclear states combined at that time; and

WHEREAS, Approximately 400,000 servicemen in the U.S. Army, Navy, and Marines were present during these atmospheric tests, whether as witnesses to the tests themselves or as post-test cleanup crews; and

WHEREAS, The Manhattan Project was the code name for the American-led effort to develop a functional atomic weapon during World War II; and

WHEREAS, Two types of atomic bombs were developed concurrently during the war, a relatively simple gun-type fission weapon and a more complex implosion-type nuclear weapon; the Thin Man gun-type design proved impractical to use with plutonium, and therefore, a simpler gun-type called Little Boy was developed that used uranium-235, an isotope that makes up only 0.7 percent of natural uranium; since it was chemically identical to the most common isotope, uranium-238, and had almost the same mass, separating the two proved difficult; three methods were employed for uranium enrichment, electromagnetic, gaseous, and thermal; most of this work was performed at the Clinton Engineer Works at Oak Ridge, Tennessee; and

WHEREAS, In parallel with the work on uranium was an effort to produce plutonium, which was discovered by researchers at the University of California, Berkeley, in 1940; after the feasibility of the world's first artificial nuclear reactor, the Chicago Pile-1, was demonstrated in 1942 at the Metallurgical Laboratory in the University of Chicago, the project designed the X-10 Graphite Reactor at Oak Ridge and the production reactors at the Hanford Site in Washington state, in which uranium was irradiated and transmuted into plutonium and the plutonium was then chemically separated from the uranium, using the bismuth phosphate process; the Fat Man plutonium implosion-type weapon was developed in a concerted design and development effort by the Los Alamos Laboratory; and

WHEREAS, Illinois played an important part in the Manhattan Project; and

WHEREAS, Argonne National Laboratory is a science and engineering research national laboratory operated by the University of Chicago for the United States Department of Energy; the facility is located in Lemont, outside of Chicago, and is the largest national laboratory by size and scope in the Midwest; and

WHEREAS, On July 1, 1946, the laboratory was formally chartered as Argonne National Laboratory to conduct cooperative research in nucleonics; at the request of the U.S. Atomic Energy Commission, it began developing nuclear reactors for the nation's peaceful nuclear energy program; in the late 1940s and early 1950s, the laboratory moved to a larger location in Lemont and established a remote location in Idaho called "Argonne-West" to conduct further nuclear research; and

WHEREAS, Code-named the "Metallurgical Lab", the team constructed Chicago Pile-1, which achieved criticality on December 2, 1942 underneath the stands at the University of Chicago's Stagg Field; because the experiments were deemed too dangerous to conduct in a major city, the operations were moved to a spot in nearby Palos Hills and renamed "Argonne" after the surrounding forest; and

WHEREAS, Red Gate Woods is a forest preserve within the Palos Division of the Forest Preserve District of Cook County and is located near where the Cal-Sag Channel meets the Chicago Sanitary and Ship Canal; the original site of Argonne National Laboratory and the Site A/Plot M Disposal Site is in the woods, which contains the buried remains of Chicago Pile-1, the world's first artificial nuclear reactor; and

WHEREAS, It is important to remember and honor the sacrifices and achievements of all those who served; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we

WHEREAS, While on a medevac run on the evening of February 16, 1968, PFC Kick's vehicle was ambushed by the enemy, and he was mortally wounded; and

WHEREAS, PFC Kick was awarded the Purple Heart, the Bronze Star, the National Defense Service Medal, the Vietnam Campaign Medal, and the Vietnam Service Medal; he was also awarded the Vietnamese Military Merit Medal and the Vietnamese Gallantry Cross with Palm from the South Vietnam Government; his name can be found on Panel 40E Line 7 of the Vietnam Veterans Memorial in Washington, D.C.; therefore, be it
