Senator Tracy offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### **SENATE JOINT RESOLUTION NO. 19**

WHEREAS, It is highly fitting that the General Assembly pays honor and respect to those individuals who have contributed to the success of their community and the State and to the efforts to cure childhood cancers and other pediatric diseases; and

WHEREAS, Roger and Regina Landon of Chandlerville established trail rides at the Jim Edgar Panther Creek State Fish and Wildlife Area, one of the State's largest public access areas, to highlight the beautiful facets of nature found at this location, to bring horse and fish enthusiasts together to enjoy the trails of this wildlife area, and to encourage camping at the location; and

WHEREAS, In 2001, Roger and Regina Landon began organizing numerous horse trail rides at the Jim Edgar Panther Creek State Fish and Wildlife Area to raise money for the St. Jude Children's Research Hospital (St. Jude), gathering horse enthusiasts from all over central Illinois to attend their Saddle-Up for St. Jude event to raise money for children diagnosed with cancer and other pediatric diseases that are being treated at St. Jude, an event the Landon family continues to host and organize each June to this day; and

WHEREAS, St. Jude, located in Memphis, Tennessee, treats children with cancer and other pediatric diseases; the hospital's research efforts are directed at understanding the molecular, genetic, and chemical basis of catastrophic diseases in children, identifying cures for such diseases, and promoting their prevention, with research being focused specifically on cancers, acquired and inherited immunodeficiency disorders, sickle cell disease, infectious diseases, and genetic disorders; in Illinois, the hospital is associated with the Children's Hospital of Illinois, located in Peoria; and

WHEREAS, St. Jude treats children at no cost to the patients; in order to operate, it is estimated to cost the hospital more than \$2 billion each year, with the majority of those funds coming from generous donors and fundraising events; and

WHEREAS, Roger and Regina Landon started Saddle-Up for St. Jude in 2001 with the initial goal of becoming more successful than similar fundraisers held in Illinois, which then averaged \$3,500; their annual benefit includes food, music, raffles, prizes, and a silent auction, with items donated by generous friends and

acquaintances; their benefit is well-attended each year, not only by horse enthusiasts but also by individuals interested in supporting St. Jude; and

WHEREAS, Roger and Regina Landon's Saddle-Up for St. Jude raised \$10,000 after its first benefit, with the event routinely securing more donations each year; when the COVID-19 pandemic looked to derail their efforts in 2020, they pivoted their outdoor event to a virtual fundraiser, collecting an additional \$35,000 for St. Jude; most recently, their benefit raised over \$63,000 in 2022; since the benefit's inception, they have given over \$800,000 to benefit the children at St. Jude; and

WHEREAS, For his work and dedication, Roger Landon was recognized as Event Coordinator of the Year by St. Jude in 2012, coinciding with the 50th anniversary of the hospital, which was established in 1962; and

WHEREAS, Sadly, Roger Landon passed in the fall of 2021; Michael Landon, one of Roger and Regina's sons, assumed the leadership role for the Saddle-Up for St. Jude event, continuing his parents' efforts to bring people together in order to support the work of St. Jude; and

WHEREAS, The Landon family remains personally interested in the Jim Edgar Panther Creek Equestrian Park, not only because of it being the location for Saddle-Up for St. Jude but also for their desire to keep the park beautiful and enticing for everyone to visit and camp; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate the equestrian campground within the Jim Edgar Panther Creek State Fish and Wildlife Area in Chandlerville as the "Landon Equestrian Campground"; and be it further

RESOLVED, That the Department of Natural Resources is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name "Landon Equestrian Campground"; and be it further

RESOLVED, That we recognize Regina Landon and the late Roger Landon on their distinguished volunteerism and their lifelong dedication to the people of Illinois and to preserving the natural fish and wildlife areas of Illinois; and be it further

RESOLVED, That we recognize Michael Landon for continuing his parents' legacy and leading Saddle-Up for St. Jude; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Director of Natural Resources and the Landon family.

Senator Villivalam offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### **SENATE JOINT RESOLUTION NO. 20**

WHEREAS, Assyrians, an ethnic minority group, are the indigenous people of Mesopotamia and have lived in the Middle East since ancient times, including in what is today Turkey, Iraq, Iran, and Syria; and

WHEREAS, Today, Assyrians, also known as Chaldeans and Syrians, live around the world, including over 600,000 who live in the United States and over 80,000 who live in Illinois; and

WHEREAS, Between 1914 and 1923, the Assyrian Genocide occurred; during this time, the Ottoman Empire murdered over 300,000 Assyrian men, women, and children by methods that included mass executions, death marches, torture, and starvation; and

WHEREAS, During the Assyrian Genocide, also known as the Seyfo Genocide, the Ottoman Turks and their Kurdish allies also systematically raped and enslaved Assyrian women and girls, forced the Assyrians from their ancestral lands, and pillaged and destroyed their communities; and

WHEREAS, The killings of over two million Armenians, Assyrians, Greeks, Christians, and other religious minority populations represented the culmination of a series of violent persecutions dating back to the late 1800s; and

WHEREAS, The year 2023 marks the 108th anniversary of the Armenian, Assyrian, and Greek genocides of 1915; these genocides were part of the planned eradication of those indigenous communities by the Ottoman Turkish Empire; yet, to this day, Turkey has still not recognized these genocides; and

WHEREAS, August 7, 1933 is recognized by the International Association of Genocide Scholars as the date on which as many as 6,000 Assyrians were killed at the orders of the Iraqi government in an event known as the Simele Massacre; this massacre continued the legacy of persecution exemplified by the 1915 Assyrian Genocide; and

WHEREAS, August 7th, globally observed by the Assyrian community as Assyrian Remembrance Day, is in remembrance of the Simele Massacre and of all persecution the Assyrian people have faced as a result of their distinct and ancient ethnic and religious identity; and

WHEREAS, The persecution against Assyrians continues until this day in their ancestral homeland, where they are continually targeted for persecution by state and non-state actors such as the Republic of Turkey, the Republic of Iraq, the Kurdistan Regional Government, and the so called Islamic State of Iraq and the Levant or ISIL; and

WHEREAS, ISIL has persistently destroyed culturally and historically significant locations and items, including UNESCO world heritage sites such as the ancient Assyrian city of Nimrud; and

WHEREAS, The United States House of Representatives and United States Senate concurrently resolved that "the atrocities perpetrated by ISIL against Christians, Yezidis, and other religious and ethnic minorities in Iraq and Syria constitute war crimes, crimes against humanity, and genocide"; and

WHEREAS, The denial of genocide is widely recognized as the final stage of genocide; this denial maintains impunity for the perpetrators of these atrocities and demonstrably paves the way for future genocides; and

WHEREAS, The resilience and endurance of the Assyrian people, despite being victims of a genocide that the Islamic State continues to perpetuate to this day, is commendable and praiseworthy; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that RESOLVED, That we recognize the Assyrian Genocide of 1915 as a genocide and as a reprehensible crime against humanity, and we honor the memory of the hundreds of thousands of Assyrians who were murdered; and be it further

RESOLVED, That the State of Illinois recognizes the Simele Massacre of 1933 as a genocide and reprehensible crime against humanity and honors the memory of the thousands of Assyrians who were murdered during the Simele Massacre of 1933; and be it further

RESOLVED, That the State of Illinois deplores the persistent, ongoing efforts by any person, in this country or abroad, to deny the historical fact of the Assyrian Genocide or any other genocide; and be it further

RESOLVED, That the State of Illinois respectfully calls upon the President of the United States to formally and consistently reaffirm the historical truth that the atrocities committed against the Assyrian,

Armenian, and Greek populations of the Ottoman Empire between 1914 and 1923 constituted genocide; and be it further

RESOLVED, That the State of Illinois encourages education and public understanding of the facts of the Assyrian Genocide, including the United States' role in humanitarian relief effort and the relevance of the Assyrian Genocide to modern day crimes against humanity; and be it further

RESOLVED, That we declare August 7, 2023 as Assyrian Remembrance Day in the State of Illinois.

Senator Morrison offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

**SENATE JOINT RESOLUTION NO. 21**

WHEREAS, On Monday, July 4, 2022, the City of Highland Park and thousands of its residents and neighbors gathered for its annual Fourth of July parade; and

WHEREAS, For generations, Highland Park has hosted this parade, one of the largest Fourth of July gatherings in the northern suburbs of Chicago; and

WHEREAS, At 10:14 a.m., tragedy struck as an alleged lone gunman opened fire with a semi-automatic rifle at the intersection of 2nd Street and Central Avenue in downtown Highland Park; and

WHEREAS, In less than one minute, the assailant shot 83 bullets into the crowd, killing 7 and injuring dozens; and

WHEREAS, As residents ran from the gunfire, placed their bodies over their loved ones, and sought safety, first responders who had come to watch the parade put themselves in harm's way; and

WHEREAS, Community Emergency Response Team (CERT) members and community volunteers rushed to the scene and bravely worked side by side with fire and police personnel and medical professionals, helping to save lives through their quick action; and

WHEREAS, Law enforcement officers from Highland Park and hundreds of others throughout the State of Illinois and at all levels of government worked together to quickly secure downtown Highland Park and later apprehend the suspect; and

WHEREAS, Mayor Nancy Rotering admirably and strongly led the grieving Highland Park community in the minutes immediately after the shooting and in the weeks and months following the shooting, as the international community looked to her leadership; and

WHEREAS, City Manager Ghida Neukirch selflessly ran to the scene of the shooting to provide first aid to gunshot victims, going far above and beyond her duties and providing extraordinary care to the Highland Park community in the moments following the shooting; and

WHEREAS, Physicians, nurses, and other staff raced to Highland Park Hospital to assist the injured, some coming straight from the parade, doing incredible work under intense and difficult circumstances; and

WHEREAS, Hundreds of therapists, counselors, and social workers have supported those experiencing trauma from what they witnessed during and after the shooting; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we mourn the lives lost at the hands of gunfire in the City of Highland Park on July 4, 2022 and all those around the State of Illinois who have been lost to gun violence and recognize the surviving families that live with the trauma of their losses; and be it further

RESOLVED, That we especially remember the lives of Katherine Goldstein, Irina McCarthy, Kevin McCarthy, Stephen Straus, Jacquelyn Sundheim, Nicholas Toledo-Zaragoza, and Eduardo Uvaldo; and be it further

RESOLVED, That we honor the City of Highland Park and its law enforcement, first responders, and community leaders for their service to the people of Illinois; and be it further

RESOLVED, That we urge leaders to continue to do everything in their power to ensure no other community experiences the trauma of gun violence, so that this horrific tragedy shall not be in vain; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the City of Highland Park.
