**PRESENTATION OF RESOLUTIONS**

Senator Fowler offered the following Senate Resolution, which was referred to the Committee on Assignments:

**SENATE RESOLUTION NO. 63**

WHEREAS, In 1992, the State of Illinois established a sister-state relationship with Taiwan, the Republic of China (R.O.C.); since that time, Illinois and Taiwan have enjoyed strong bilateral trade, educational and cultural exchanges, and tourism; and

WHEREAS, Taiwan shares the same values of freedom, democracy, human rights, the rule of law, peace, and prosperity with the State of Illinois and the United States; and

WHEREAS, The United States ranks as Taiwan's second-largest trading partner; Taiwan is the eighth-largest trading partner of the United States, with bilateral trade reaching more than US\$ 856 billion in 2021; and

WHEREAS, Taiwan and the State of Illinois have enjoyed a long and mutually beneficial relationship with the prospect of future growth; Taiwan was Illinois' seventh-largest export market in Asia in 2021, with US\$ 747 million worth of Illinois goods exported to Taiwan; and

WHEREAS, To strengthen the Taiwan-Illinois bilateral economic relationship, it is essential to support Illinois businesses to enhance their economic engagement with Taiwan based on the 1979 Taiwan Relations Act (TRA, Public Law 96-8, 22 U.S.C. 3301); Article 4, Section b of the TRA stipulates that "wherever the laws of the United States refer or relate to foreign countries, nations, states, governments, or similar entities, such terms shall include and such laws shall apply with respect to Taiwan"; it is legitimate for Illinois businesses to refer to Taiwan, R.O.C. as Taiwan in conducting their business ties with Taiwan; and

WHEREAS, Negotiations for a Bilateral Trade Agreement (BTA), the Avoidance of Double Taxation Agreement (ADTA), and the Indo-Pacific Economic Framework for Prosperity (IPEF) between Taiwan and the United States are an important step toward further strengthening bilateral trade between our countries and will thereby increase Illinois' exports to Taiwan and create bilateral investment and technical collaboration through tariff reduction and other trade facilitation measures; and

WHEREAS, Taiwan has undertaken a policy of "steadfast diplomacy" in its international relations; Taiwan is capable of, and willing to, fulfill its responsibilities and to collaborate with the world to deal with the challenges of humanitarian aid, disease control, and so forth; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we reaffirm our commitment to the strengthening and deepening of the sister-state ties between the State of Illinois and Taiwan, R.O.C.; and be it further

RESOLVED, That we reaffirm our support for the Taiwan Relations Act (TRA) and support Illinois businesses to refer to Taiwan, R.O.C. as Taiwan; and be it further

RESOLVED, That we endorse Taiwan's efforts to secure the signing of a Bilateral Trade Agreement (BTA), the Avoidance of Double Taxation Agreement (ADTA), and the Indo-Pacific Economic Framework for Prosperity (IPEF) with the United States, and we reiterate our support for a closer economic and trade partnership between the State of Illinois and Taiwan; and be it further

RESOLVED, That we continue to support Taiwan's meaningful participation in international organizations that impact the health, safety, and well-being of the people of Taiwan, and we support Taiwan's aspiration to make more contributions in international societies.

Senator Ellman offered the following Senate Resolution, which was referred to the Committee on Assignments:

**SENATE RESOLUTION NO. 64**

WHEREAS, The International Dark-Sky Association (IDA) defines light pollution as any adverse impact or effect attributable to the use of artificial light at night, including but not limited to sky glow, glare, spill light, and impaired nighttime visibility; and

WHEREAS, Light pollution is known to negatively impact human health, public safety, astronomical observations, energy security, global climate, and natural ecosystems; and

WHEREAS, IDA provides guidance on mitigating light pollution with principles that can be broadly applied, empowering diverse jurisdictions, communities, and interests to select responsible outdoor lighting; and

WHEREAS, Responsible outdoor lighting may be designed to minimize the impact on the environment to achieve the IDA's short-term conservation goal of no net increase in light pollution and long-term conservation goal of the restoration of intrinsic darkness; and

WHEREAS, The IDA develops a range of scenarios and guidance for common lighting solutions and provides flexibility in identifying how the IDA's principles are best applied within local areas to meet valid needs while observing all regulatory frameworks; and

WHEREAS, Local Illinois governments should be encouraged to utilize light fixtures that reduce unnecessary light and save energy when they replace light fixtures or build new light fixtures; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare that local governments in Illinois should abide by IDA's guidelines and lighting principles to help mitigate the effects of light pollution produced by outdoor lighting.

WHEREAS, Corporal Donald Claude Taylor was born on August 30, 1949; and

WHEREAS, Cpl. Taylor served with the U.S. Army, 11th Light Infantry Brigade, 4th Battalion, 3rd Infantry, C Company; and

WHEREAS, Cpl. Taylor began his tour of duty in Vietnam on December 11, 1969; and

WHEREAS, Cpl. Taylor gave his life in service to our country on March 5, 1970; and

WHEREAS, Cpl. Taylor was awarded the Purple Heart, the Combat Infantryman Badge, the Marksmanship Badge, the National Defense Service Medal, the Vietnam Campaign Medal, the Vietnam Service Medal, the Army Presidential Unit Citation, the Vietnam Gallantry Cross, and the Army Good Conduct Medal; and

WHEREAS, Cpl. Taylor's sacrifice is honored on the Vietnam Veteran's Memorial in Washington, DC; his name can be found inscribed at VVM Wall, Panel 13w, Line 86; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate Interstate 55 as it travels around the city of Chenoa as the "Cpl. Donald C. Taylor Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name "Cpl. Donald C. Taylor Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Cpl. Taylor and the Secretary of the Illinois Department of Transportation.

WHEREAS, The Children's Mental Health Act initiated the development of the Screening, Assessment and Support Services (SASS) program for children and adolescents experiencing a mental health crisis; and

WHEREAS, One in six children and adolescents have mental health conditions, but only half of those receive mental health services; and

WHEREAS, Undiagnosed, untreated, or inadequately treated mental illness can significantly interfere with a child's ability to learn and develop; and

WHEREAS, These delays in treatment also lead to worsened conditions that are harder and costlier to treat; and

WHEREAS, Delays in treatment further result in higher rates of school dropout, unemployment, substance use, arrest, incarceration, and early death; and

WHEREAS, The number of children and adolescents experiencing a mental health crisis continues to increase, taxing school and community mental health services; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the SASS Program Task Force; and be it further

RESOLVED, That the Task Force shall be charged with the following duties:

- (1) Evaluate the SASS program by county, including but not limited to Crisis and Referral Entry Services (CARES) hotline volume, hotline staffing, local agency staffing, local agency staff turnover, local agency staff response time, local agency staff training, number of referrals for inpatient and outpatient services, and availability of inpatient and outpatient services; and
- (2) Analyze whether the current funding is sufficient to meet the needs of the program; and be it further

RESOLVED, That the Task Force shall consist of the following members:

- (1) One legislative member appointed by the President of the Senate, who shall serve as co-chair;
- (2) One legislative member appointed by the Speaker of the House, who shall serve as co-chair;
- (3) One legislative member appointed by the Senate Minority Leader;
- (4) One legislative member appointed by the House Minority Leader;
- (5) The Director of the Department of Children and Family Services or his or her designee;
- (6) The Director of the Department of Healthcare and Family Services or his or her designee;

(7) The Secretary of the Department of Human Services or his or her designee;

(8) One member representing a statewide professional school social worker association, appointed by the President of the Senate;

(9) One member representing a statewide professional school psychologist association, appointed by the Speaker of the House;

(10) One school social worker or school psychologist representing a statewide professional teacher organization, appointed by the Senate Minority Leader;

(11) One school social worker or school psychologist representing a different statewide professional teacher organization, appointed by the House Minority Leader;

(12) One school social worker or school psychologist representing a professional teachers' organization in a city having a population exceeding 500,000, appointed by the President of the Senate;

(13) One school district administrator representing a statewide professional school administrator organization, appointed by the Speaker of the House;

(14) One school principal representing a statewide professional school principal organization, appointed by the Senate Minority Leader; and

(15) One school board member representing a statewide professional school board organization, appointed by the House Minority Leader; and be it further

RESOLVED, That members of the Task Force shall serve without compensation; and be it further

RESOLVED, That the Department of Children and Family services, the Department of Healthcare and Family Services, and the Department of Human Services shall provide administrative support; and be it further

RESOLVED, That the Task Force shall use the collected information to write a report, including the findings of the evaluation and policy recommendations that would address identified program and financial challenges, and deliver this report to the Governor and the General Assembly on or before June 30, 2024, and, upon the filing of its report, the Task Force shall be dissolved; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the Senate, the Speaker of the House, the Minority Leader of the Senate, the Minority Leader of the House, the Director of the Department of Children and Family Services, the Director of the Department of Healthcare and Family Services, and the Secretary of the Department of Human Services.
