Ninety-Third General Assembly

Pursuant to Article IV, Section 9(b) of the Illinois Constitution of 1970, I hereby veto SB 2424 entitled "AN ACT concerning State finance."

[March 11, 2003]

Amends the Illinois State Collection Act of 1986. Provides that after accounts have been certified by the Debt Collection Board or the Attorney General as uncollectible, the State Comptroller may sell the debts to outside private vendors or enter into one or more contracts with outside private vendors for the purpose of pursuing a last-call collection effort to collect these debts for a contingent fee. All moneys in the Fund shall be appropriated to the Department of Corrections to be used to keep open or re-open, as the case may be, the Sheridan Correctional Center for its continued operation and for no other purpose. Amends the State Finance Act to create the special fund.

I hereby veto and return Senate Bill 2424
