### PRESENTATION OF RESOLUTIONS

Senator Halvorson offered the following Senate Resolution and, having asked and obtained unanimous consent to suspend the rules for its immediate consideration, moved its adoption:

#### SENATE RESOLUTION NO. 1

**RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, AT THE NINTH SPECIAL SESSION THEREOF**, that the Secretary inform the House of Representatives that a majority of the members of the Senate has assembled, pursuant to the proclamation of the Governor, convening a Ninth Special Session of the General Assembly, and are now ready for the transaction of business.

The motion prevailed.  
 And the resolution was adopted.

Senator Halvorson offered the following Senate Resolution and, having asked and obtained unanimous consent to suspend the rules for its immediate consideration, moved its adoption:

#### SENATE RESOLUTION NO. 2

**RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, AT THE NINTH SPECIAL SESSION THEREOF**, that the President appoint a committee of five to wait upon his Excellency, the Governor, and inform him that the Ninth Special Session of the Ninety-Fifth General Assembly is now duly in session in pursuance of his proclamation, and is ready to receive any message he may desire to submit.

The motion prevailed.  
 And the resolution was adopted.

Senator Halvorson offered the following Senate Resolution and, having asked and obtained unanimous consent to suspend the rules for its immediate consideration, moved its adoption:

#### SENATE RESOLUTION NO. 3

**RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, AT THE NINTH SPECIAL SESSION THEREOF**, that a Committee of three (3) members of the Senate be appointed, two (2) members to be appointed by the President and one (1) member to be appointed by the Minority Leader, to approve any and all Journals of the Senate for all days of the Ninth Special Session of the Ninety-fifth General Assembly where such Journals, prior to adjournment SINE DIE, have not been approved by the body as a whole.

The motion prevailed.  
 And the resolution was adopted.

The Journal of Monday, July 27, 2007, was being read when on motion of Senator Hunter, further reading of same was dispensed with, and unless some Senator had corrections to offer, the Journal would stand approved. No corrections being offered, the Journal was ordered to stand approved.
